GENERAL INVESTIGATIVE DIVISION

The Civil Rights Division of the Department has requested interviews of 6 complainants who are members of the United Farm Workers Union (UFWU) in Kern County, California. It is alleged they have been harassed and intimidated in connection with various boycotts and that local officers have not provided equal protection. This could involve violation of the Civil Rights Statutes.

The attached furnishes details of efforts to locate and interview the alleged victims and apparent lack of cooperation by the legal office of the UFWU to make them readily available. On 7/26/73, over 100 UFWU pickets appeared at the Bakersfield, California, Resident Agency, to make civil rights complaints in connection with this matter. Only one of the original 6 alleged victims was in the group. The pickets were accompanied by a member of the UFWU legal office and 2 employees of the Justice Department's Community Relations Service. Pickets were orderly and no known press coverage; interviews continuing.

Matter being discussed with the Department and instructions will be issued to Sacramento.

This report contains the results of a limited investigation.

JERRY COHEN, Attorney for the United Farm Workers Union (UFWU), Keene, California, was contacted July 17, 1973, to make arrangements for interviews of the six captioned victims. He advised arrangements would be made to have all six available on July 19, or 20, 1973.

On July 20, 1973, efforts to recontact COHEN were unsuccessful at UFWU headquarters, and it was determined no messages were left by COHEN.

On July 20, 1973, [REDACTED] Legal Office of UFWU, Lamont, California, was contacted regarding an interview of the victims. [REDACTED] advised she was the individual who provided the Community Relations Service with the names of the victims and the details of the incident at the John Kovacovich Ranch on June 28, 1973. She advised most victims were scattered or in Kern County Jail and being arraigned the same date. She suggested interviews for July 23, or 24, 1973. (b)(7)(c)

On July 23, 1973, [REDACTED] was recontacted and advised she would have the six victims available at 2:00 P.M., July 24, 1973, but insisted on at least 15 to 20 other interviews. She also advised all had been instructed not to submit to interviews by anyone except the UFWU legal office. (b)(7)(c)

On July 24, 1973, [REDACTED] stated she had been (b)(7)(c) unable to gather victims because they were still scattered. [REDACTED] suggested interviews for 2:00 P.M., (b)(7)(c) July 25, 1973, but consented to 12:00 noon.

On July 25, 1973, [REDACTED] stated she had received (b)(7)(c) orders to make the victims available for interview on July 26, 1973, at 2:00 P.M. She stated they could not come in earlier because they did not get off the picket lines until 12:00 noon. She stated 15 to 20 persons would be in for interview.

On July 26, 1973, at 2:15 P.M. [REDACTED] accompanied (b)(7)(c) by GONZALO CANO and BILL TALBERT of the Community Relations Service of the Justice Department appeared at the Bakersfield Resident Agency with over 100 UFWU pickets for the purposes of making statements regarding civil rights complaints in the captioned matter.

Approximately half were nonEnglish speaking.

Of the total number appearing, only HELEN CHAVEZ of the requested victims appeared for an interview.

At 4:40 P.M., [REDACTED] announced the UFWU (b)(7)(c) had decided they would not remain for more interviews but would return at about 8:00 A.M., July 27, 1973, to continue interviews of those not interviewed on July 26, 1973.

On July 27, 1973, six additional members of UFWU appeared in Bakersfield Resident Agency and provided signed statements. None of those who appeared were among the six requested victims.

On July 30, 1973, BILL SKINNER, Investigator, Kern County District Attorney's Office, Bakersfield, provided five negatives of photographs. SKINNER advised that a representative of UFWU had briefly loaned his office these five photographs for the purpose of copying with instructions to provide a copy to the FBI. SKINNER advised a copy had been made for the FBI but did not turn out thus he is providing the negatives made when the photographs were copied.

SKINNER advised his office will use these photographs to assist in identifying responsible parties at the assault on UFWU pickets on June 28, 1973.

On August 2, 1973, instant matter was discussed with Assistant U. S. Attorney (AUSA) THOMAS T. COURIS, Eastern District of California (EDC), Fresno, California. He advised he does not desire further investigation at this point. He also advised he does not feel this case has any prosecutive merit with respect to the Kern County Sheriff's Office.

COURIS advised he is desirous of receiving instant report and reviewing with regard to conspiracy by the Teamsters Union after which he will furnish his views directly to the Department of Justice.

COURIS further advised he does not feel that further efforts to locate and interview the three victims who have not appeared are warranted in view of the statements taken and the unsuccessful efforts to locate them to date.

SC 44-542

On June 28, 1973, 28 individuals associated with the Teamsters Union were arrested by the Kern County Sheriff's Office and booked into the Kern County Jail, Bakersfield, California.

JOSEPH JOHNSON, Chief Investigator, Kern County District Attorney's Office, Bakersfield, advised on August 6, 1973, that due to the lack of cooperation in general by the UFWU, 17 of these individuals arrested had to be released without charge. At the present time, 11 Teamster members are still under charge, and cases involving six have been presented to a county grand jury; however, results of the grand jury's decision, if any, have not been made public. It is expected that five of the 11 will not be presented to a grand jury in the future and that five of the six cases presented will probably be dismissed resulting in only one indictment.

# THE "COACHELLA EXPERIENCE"

Six people from Michigan made up the CCMA Task Force that traveled to the Coachella Valley to understand the full implications of the Teamster-United Farm Worker dispute. The members of the Task Force were the following: Rev. Peter Dougherty, Catholic Campus Ministry, Eastern Michigan University; Pamela Lemerand, student, Wayne State University; Sr. Joan Tirak, Catholic Campus Ministry, Eastern Michigan University; Stephanie Dabrowski, student, Wayne State University; Marie Parker, student, Eastern Michigan University; Rev. Reynard Kinkel, Catholic Campus Ministry, Wayne State University.

On April 15, 1973, the Teamsters Union announced that it signed contracts with a majority of the table grape growers in the Coachella Valley (California). These growers produce 85% of the valley's table grapes. For the past three years these growers had been under contract with Cesar Chavez' United Farm Workers' Union. One of the first goals of our Task Force was to find out why the UFW was dumped and why the Teamsters were able to move in and take over as the field workers' representative.

## Beginning of the Story

Last December at a convention of the American Farm Bureau, Teamster Pres. Frank Fitzsimmons proposed an alliance between organized labor and agribusiness to fight Chavez and "his revolutionaries" (NEWSWEEK, May 21, 1973). Incidentally, the Chavez-led UFW is 30,000 members strong.

Within months the Teamsters turned their attention to the table grape growers of California. Since this is a \$200 million dollar a year industry, one can understand why the Teamsters would head in this direction.

For an overview as to where the table grape vineyards are in California, this three part division seems helpful:

- A) Coachella Valley 10% of grape indus.
- B) Arvin-Lamont 30% of grape indus.
- C) Delano 60% of grape indus.

The UFW has called strikes in the Coachella Valley and the Arvin-Lamont area since most of the growers in these places have signed with the Teamsters. Right now almost 40% of the table grape industry has signed up with the Teamsters; contracts in the Delano area do not expire until the end of July, 1973.

At first the Teamsters concentrated on southern California's Coachella Valley. With the UFW contract due to expire on April 14, 1973, Teamster organizers went into the fields and by March 1, 1973, they proclaimed to the growers that they had more than 4,100 signatures of field workers who claimed they wanted to be represented by the Teamsters. They were saying, in effect, that they "decertified" the UFW union and established themselves (Teamsters) as the farm workers' representative in the table grape industry.

## Some Problems with the Teamster Claims

Because of the above there are some serious problems with the latest Teamster move against the UFW.

A. There are serious questions about the legitimacy and authenticity of the signatures gathered by the Teamsters. NEWSWEEK's Peter Greenberg (May 21, 1973) discovered upon examining the signatures that many were remarkably similar. The UFW legal department is taking declarations under oath from many workers whose names appear on the Teamster petition.

This is the kind of evidence the UFW has in its legal case against the Teamsters.

A farmworker: "First off, I do not wish to be represented by the Teamsters and secondly, I never signed that petition. My name is there, but it is not my signature. I would never sign a petition like that. I am angered that someone else would put my name on a petition like that. I am and always have been a loyal "Chavista" and do not want the Teamsters at all." -- a worker from H & M Tenneco.

The UFW will bring a legal case against the Teamsters, claiming that they forged many farm worker names to their so-called list of 4,100! Second, the UFW will show that the Teamsters used force to get people to sign a petition saying they wanted to be represented by the Teamsters Union.

It should be pointed out here that the growers are not completely free from blame. All the growers in the Coachella Valley, except Steinberg and Larson, signed with the Teamsters. Whether the growers who signed with the Teamsters cooperated in the above mentioned improper activity, we probably will never know. In the end we will see that all parties--growers, Teamsters and UFW--made mistakes.

As far as the UFW is concerned, no matter what the courts do, (justice grinds exceedingly slowly at times) the future of their union is at stake. They cannot wait for court decisions. Right now the Teamsters have 85% of the Coachella Valley table grape contracts. As tough Ralph Cotner of the Teamsters puts it: "We've got no reasons to leave. We got the workers...and we're gonna keep 'em." So, the UFW has called an all out strike-boycott of Coachella Valley Teamster grapes. We will report later on about the present status of the strike and how effective it has been.

B. One last thing about Teamster statistics and techniques. NEWSWEEK (May 21, 1973) reported that by March 1, 1973, the Teamsters asserted they had more than 4,100 signatures of farm workers who maintained they wanted the Teamsters as their union. At that time, however, there were not that many field workers in the grape vineyards! To be certain of this, on June 20, 1973, we contacted Floyd Marlowe, Farm Worker Representative, Calif. Dept. of Human Resources Development. He

said that on March 30, 1973, his records show that there were 500 farm workers in the grapes. Pre-harvest work of thinning was being done and hence not that many workers were in the Coachella Valley at that time.

How did the Teamsters get the 4,100 names they have on their list? No one seems to know and they are not telling. At this writing (June 22) Mr. Marlowe says there are 3900 field workers in the grapes. There are 1,000 strikers. Hence there are approximately 4,900 farm workers in the Valley at this time. 1,000 of the 4,900 are UFW strikers; another 800 are UFW farm workers employed by Larson and Steinberg, the two growers in the

Coachella Valley that signed with Cesar Chavez. That leaves 3,100 farm workers in the fields of growers with Teamster contracts. Are all these workers committed to the Teamsters? Increasingly we are finding by talking to "Teamster" farm workers that they need money. They are poor people and the grape harvest is one of the ways they can make some money to keep them going. Many support Cesar Chavez and the UFW. We cannot begin to speculate as to how the Teamsters got their figure of 4,100. But we do have some leads. The following declaration was given under oath:

I have been working for the ----- Company for the last 6 years. Until Monday, the 16th of April, I worked under UFW contract. Two times the Teamsters came to our fields before the UFW contract expired. They asked me to sign a piece of paper whereby I would support the new Teamster contract. I told them I didn't want to sign because I was already represented by the union of Cesar Chavez. I saw that the majority of the other people who were working with me didn't want to sign.

On Monday, April 16, the UFW contract expired. The next day -----, our foreman, instead of sending us to work, told us to stay in the camp. He said that we would be paid that day even though we didn't work. A little bit later, the Teamsters arrived. Jerry -----, the boss of the camp, was there when they arrived. One of the Teamsters ----- that I had to sign if I wanted to keep working. I didn't want to sign, but I

have a family. I had worked there for six years and I was afraid if I lost my job there I wouldn't be able to find work anywhere else. So I had to sign. I think that a lot of people signed because they were also afraid of losing their jobs.

Because of this kind of confusion and deception, a poll of about 1,000 field workers in 31 fields in the Coachella Valley was taken on April 10, 1973. Floyd Marlowe estimates that there were between 1,200 and 1,600 field workers in the grapes at that time. Hence this poll of approximately 1,000 would seemingly be rather valid. A committee of 25 civic, religious and labor leaders helped to take this poll. Msgr. George Higgins, U.S. Catholic Conference, was a member

of the committee. The results of the poll were as follows:

- 795 votes for UFW
- 80 votes for Teamsters
- 78 votes for no union

C. Some conclusions. From the foregoing the following conclusions seem warranted:

- 1) The UFW is the choice of the field workers.
- 2) The Teamsters through various means tried to make the public think that they are the choice of the field workers.
- 3) The Teamsters are the choice of the growers. Some theories as to why the Teamsters want to organize field workers and why the growers prefer the Teamsters will be dealt with later.
- 4) Bluntly, the growers want one union (Teamsters) and the field workers want another (UFW). The growers signed with the Teamsters without respect to the wishes of the workers. This is o.k. if we subscribe to the philosophy that the employer determines what union will represent the workers. However, if in this situation we use the model of organized labor the following would occur:

a) A rival or raiding union (the Teamsters in this case) on claiming to represent the workers previously under contract with another union (UFW)

b) must have workers file for a "decertification" election in which through secret ballot, the workers determine the union of their choice.

The most sensible thing to do now in the Coachella Valley is not to side with

the Teamsters (we have 4,100 votes!); nor should we say categorically that we are on the side of the UFW (we have the support of the workers). Rather, to solve this whole problem there should be secret elections supervised by a third party. We feel from the facts we have seen the UFW would win, since they do have the support of the field workers. But this is not to say there is no dissatisfaction or opposition to Cesar Chavez by some field workers. However, we feel the majority of the workers are on his side.

5) A final conclusion about the pact the Teamsters have with the growers in the Coachella Valley. The contract was signed with little or no discussion with

farm workers. Farm workers did not determine the content. Subsequently, they did not ratify the contract which was signed by the Teamsters and the growers. This is a clear indication that the issue in the table grape dispute of 1973 is essentially the same as the dispute in the late 60's. That is, whether or not farm workers can have a union of their own which is governed by the rank and file and not by a few outsiders and "big brothers" who feel they know what is best for the workers.

#### The Present Situation of the Strike in the Coachella Valley

Because of the circumstances surrounding the grower-Teamster pact, the UFW has called a strike-boycott of all Coachella Valley grapes picked by the Teamsters. There are about 1,000 UFW strikers, as was reported by the local press when our task force visited the valley. Floyd Marlowe, a State of California official, confirmed this figure and said there are 3,900 farm workers in the grapes; 800 of these are working under UFW contracts. That means that approximately 3,000 farmworkers belong to the Teamster work force, a figure that is disputed by UFW officials. They claim that about 2,200 people are actually working under the Teamster contract. Numerous sources in Coachella have told us that 4,500 farm workers are needed at the peak of the grape season to bring in the harvest. At present, the growers are at the peak of their harvest and according to these equations the growers should have sufficient workers to do the job. However, the growers claim they are get-

ting the crop harvested. We will have to wait and see who is right.

The following points must be kept in mind if one is to understand fully why the strike exists.

A. At the heart of the grower-Teamster/UFW dispute is the issue of the hiring hall. The UFW maintains that the hiring hall is essential in order to check grower exploitation of the farm worker.

The background on this issue has to do with the growers' practice of using a "labor contractor" to get the field workers to bring in the harvest. The UFW has always fought against the presence of the labor contractor (or its equivalent); thus the labor contractor vs. the

hiring hall was the major bone of contention between the growers and the UFW.

How does the labor contractor operate in theory? Suppose a grower needs 200 field workers. Most likely he will have 4 labor contractors whose job it will be to get 50 workers to do the work in the fields. In this system many abuses can develop and have developed over the years.

In the past labor contractors would be paid a lump sum by the grower; the labor contractor would then pay the farm worker out of his pocket. Hence he could maintain the "power of the purse." He could ask for a payoff for giving someone a job as well as a percentage of the farm worker's wages. If a woman is asking for a job, she may have to do the labor contractor a "favor" or two. Labor contractors have been known to hire only young men (20 to 40 years of age) whom they could force to work fast and thus get the most out of the wages they pay. Thus women and older men would be discriminated against. Certainly there would always be the problem of the labor contractor hiring only his favorites.

To make sure that these abuses would cease the UFW has demanded in its contracts that there be a hiring hall; the workers receive jobs through a seniority system. A person's seniority in the UFW is determined according to how long one has been a member of the union.

Suppose a grower needs 200 workers to pick grapes. He would send this request to the UFW hiring hall in Coachella. The workers are then dispatched to the grower according to seniority. The grower will usually have a foreman for every 50 men

whose task is to assign work and coordinate the efforts of the crew. He has no authority to hire. Growers complain that the hiring hall cannot work, and this they maintain, was the major reason why they refused to sign again with Cesar Chavez. The Teamsters did not push the idea of the hiring hall in their contract and so the growers signed with them. The deal the Teamsters made with the growers has been called in the media a "sweetheart contract." We can see exactly what this means in relation to the labor contractor. The Teamster-grower contract is a sweetheart deal in the sense that the union (Teamsters) has sold out the workers by negotiating a contract for the good

of the employers and not the workers, e.g., labor contractor issue.

The UFW maintains that the Teamster "foreman" is the equivalent of the labor contractor, and hence there are the same old abuses creeping in. The growers on the other hand say there is no substance to this charge and that the role of the foreman is to provide field workers and coordinate work efforts.

#### \$1.6 Million from Meany

B. To fight the growers and the Teamsters the UFW has been given \$1.6 million for strike benefits by George Meany, AFL-CIO chief. Each person on strike is given \$90 per week (the strike breakers in the fields are making about \$120 per week). Those on strike do more than just sit home and collect pay checks. All strikers meet at the local Coachella park at 4:30 a.m. daily. Picket captains group the strikers who then begin to set out in caravans of cars and buses to the fields of the growers. Their aim is to arrive at the entrances of the fields before the scabs, where the UFW strikers talk to them and encourage them to join the "huelga" (strike). Each picket line is equipped with a loud speaker and so throughout the morning UFW leaders talk to the workers in the fields, asking them to come out and join their brothers and sisters on the picket line. Work in the field ends around 11:00 a.m. or 12:00 noon. (The sugar content in the grapes is reduced with the 115° temperatures, and therefore picking must end until the following day). After the scabs leave the fields they are followed to the work camp by UFW representatives, and further

discussions about the strike take up the early part of the afternoon. Around 5:00 p.m. there usually is a strategy meeting in the park and then it is home for supper and early to bed--morning comes fast. When we left the Coachella Valley June 23 the spirits of the strikers were high and they did not appear discouraged despite the obstacles that they were facing.

E. Why do many remain in the fields and work, even though they know there is a Cesar Chavez-led strike?

It has been said that no strike among field workers could be successful and at times, perhaps the UFW wonders if this is true. Mexico is only an hour's drive from Coachella and so legal and illegal aliens can come up and make some quick money during the harvest time. These are poor people and are interested in making a buck; the fact that they are in the fields working does not necessarily mean they do not support Cesar Chavez. Also, it is no revelation to know that some of the best people who find out about exploitation are the exploited themselves. So, the liberation cause that some farmworkers support is not always understood by their fellow workers. As one person told us, "the poor want bread not ideology." Hence it is relatively easy for the growers and Teamsters to break the strike with people from Mexico. But as we left the Coachella Valley, two factors seem to indicate that the strike is taking its toll on the growers.

First, the UFW organizers claim that increasingly they hear that the people in the fields are ready to come out and join the strike. There have been a lot of complaints about how they have been treated by the Teamsters. Second, the growers are not getting a good price for their grapes and hence may just be breaking even; that indeed is not their goal! Here are some facts on this point. Growers consistently stated to us that it costs them about \$7.00 to produce one lug of grapes (22 lb. box). A #1 box of perlettes (type of grape) was selling for \$8.00 a lug when we left the Coachella Valley, according to Mr. Steinberg, a grower who signed with the UFW. However, a great deal of the grapes sent to market by the Teamsters are seconds; they are not getting the #1 rating and hence they are not getting the #1 prices. UFW leaders told us that #2 perlettes are getting \$7.00 and \$7.50 per lug and if this is

true the growers are not making any money --just breaking even. Four growers, Steinberg, Morano, Karahadian, and Keyan stated in the Riverside County Daily Enterprise June 13, that if prices go below \$7.50 per lug they will lose money. All this is interpreted by the UFW forces as good news. They say grower problems are due to the fact that inexperienced pickers are working in the fields (the good ones are on the picket line): the grapes are being packed poorly; the vines were not thinned properly in the spring and so the growers are paying for it now in terms of quality grapes.

#### Recent Violence in Coachella

Cesar Chavez has long told his followers that they will win, but only if they stick to their principles of non-violence. In recent days this philosophy of the UFW has really been put to the test. During our last week in Coachella there were numerous minor scuffles and fights. Both sides were guilty of "disturbing the peace" to some degree. But on the whole Lt. Jack Reid, spokesman for the Riverside County Sheriff's office, said that the recent incidents had been generated by "unprovoked attacks" by Teamster security guards (N.Y. Times, June 27, 1973). We can attest to this last statement. The Teamster "goons" as the UFW strikers call them, were arrested for beating up a priest in a local cafe; fighting with local people at a neighborhood ice cream stand; kidnap and attempted murder; stoning the car Cesar Chavez was riding in. Surely, they have added to this list since we left Coachella, fortunately, with no bruises.

What is so ironical is that recently the Teamsters have hired a public relations firm, Hoover-Gorin & Associates, for \$1.3 million to help them improve their image! Incidentally, one of the Teamster strong men beat up a representative from this firm while we were in Coachella. Apparently, money cannot buy everything.

Public relations firm notwithstanding, the Teamsters have an image all their own and it hangs out wherever they go. The L.A. Times (June 12, 1973) reported on the army of "goats" organized by Bill Grawi, organizer for the Western Conference of Teamsters. One



hundred twenty hefty, bearded men from L.A. are paid \$67.50 per day to protect the interests of the Teamsters and the growers. In a press conference on

June 19 Grami insisted all the "guards" were Teamsters on leave from their usual jobs to assist him with the problems in Coachella. Wherever they come from it is clear that they are the biggest joke that has hit Coachella for a long time. They would be funny except for the tragic results that keep happening from their continued presence. Some of their more brilliant statements include: "If you don't like it, ya want to make some-thing of it?" As we returned to Michigan we could only feel sorry for the poor people in this small desert town. They must live in this atmosphere of fear and intimidation for the next month until the harvest is over.

### Conclusion

As we left the Coachella Valley we could not help but recall the words of an article about Einar Mohn, director of the Western Conference of Teamsters. Jane Kiely, of Graduate Theological Union (Berkeley) interviewed him for her dissertation on farm labor. Mohn said farm workers will not be able to take part in meetings for about two years (L.A. Times, April 28). In two years he expects more whites in the fields and this, he says, will make organizing farmworkers more feasible. Because of the present membership of the union he said it is difficult to have an effective union.

In conclusion, we can only say that the Teamsters have no business calling themselves a union of farmworkers. They could not possibly come to understand the needs of farmworkers, nor do they plan on representing them fairly when it comes to a showdown with the growers. Grapes produced under their contracts should make the ordinary person of conscience sick, when he knows the full extent of the oppression under which these grapes are harvested.

Because of this, we urge the members of CCMA to: 1) work with existing groups in your area to support the UFW boycott of grapes and lettuce; 2) see what can be done in your area to raise money for the UFW people on strike; send contributions to: United Farm Workers, La Paz, P.O. Box 62, Keene, California 93531; 3) con-

sider going to California and join the farm workers on the picket line for a few days. For information about this as well as on-going information about the UFW struggle write or call:

Stanley Pottinger of the Civil Rights Division has recently requested the Bureau to investigate criminal Civil Rights matters in Kern County, California, arising out of the dispute between the United Farm Workers of America and the International Brotherhood of Teamsters. Since certain of these matters may involve violations of criminal statutes over which the Criminal Division has jurisdiction, the Bureau is requested to forward to the Criminal Division copies of all investigative reports pertaining to the following matters:

1. Violence at the Cavokovich Ranch in Kern County, California. The Civil Rights Division requested an investigation into this matter on August 13, 1973 under the caption: UNSUBS, Kern County Deputies, Teamsters: Frank Quintana et al, victims;
2. Violence at the Guimarra Ranch, Kern County, California. The Civil Rights Division requested an investigation into this matter on August 22, 1973 under the caption: F.N.U. Cooper, Kern County Sheriff's Deputies: Lidia B. Manriques, victim; and
3. Violence at the Nalbandian Ranch in Kern County, California. The Civil Rights Division requested an investigation into this matter on August 30, 1973 under the caption: UNSUBS, Kern County Sheriff's Deputies: Erlene Cuerto, victim.

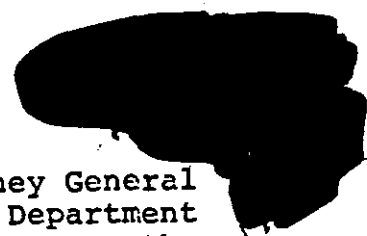

J. Stanley Pottinger, Assistant Attorney General (AAG) of the Civil Rights Division (CRD) of the Department met with the Director in the Director's Office late on the afternoon of 11/14/73. In attendance were Assistant Director Robert E. Gebhardt of the General Investigative Division and Acting Section Chief Joseph G. Kelly of the General Investigative Division's Civil Rights Section.

Pottinger stated he had primarily requested to see the Director as a matter of courtesy but in addition desired to furnish the Director with pertinent background information relating to certain requests he had made for investigation since he anticipated the Director might well receive inquiries from the White House and other sources concerning them.

He added that he had recently found it necessary to request Bureau investigations into a number of highly sensitive and delicate matters and he personally wanted to thank the Director for the outstanding cooperation which the FBI had extended to him and for the exceptional manner in which the Bureau had handled the investigations involved.

Pottinger then proceeded to discuss the delicate and sensitive investigations referred to above as follows:

Late on 8/23/73, Jerome Zeifman, Chief Counsel of the House Committee on Judiciary, called to advise me of a telephone conversation he had just had with Congressman Edwards. He said Edwards is currently in California and has spent considerable time in the Kern County area where there is a great deal of unrest in connection with labor activities involving grape pickers. Several individuals have been killed or injured during this labor unrest.

Zeifman said that Edwards is very concerned that the investigations of this situation are not being handled properly. He said Edwards specifically expressed his concern that the publicly stated policy of former Acting Director Gray to the effect that outside Agents would be sent in to handle civil rights cases is not being followed in this instance. He said Edwards feels a number of Agents should be sent into the area from other FBI offices and that they specifically should be Agents with Spanish speaking ability. He said Edwards had commented that he recently had some contact with the Phoenix FBI Office and had been highly impressed with the competency of the number of Spanish speaking Agents available there.

Zeifman advised Edwards has visited the FBI Resident Agency office in the area where this labor problem is centered expressing his concern over these cases and also has communicated directly with the Department of Justice about this matter. He said Edwards feels his expressions of concern have not generated the proper response and Edwards is now suggesting that he be allowed to convene his Subcommittee on Civil Rights and Constitutional Rights of the House Committee on Judiciary to conduct hearings in California concerning the handling of these cases. Zeifman said at Edwards' request he has discussed this matter with Pat McSweeney, Deputy Assistant Attorney General for Legislative Affairs in the absence of Assistant Attorney General Mike McKeivitt, and that he expects a response from McSweeney. Zeifman said he was merely advising me so that the FBI would be aware of this situation.

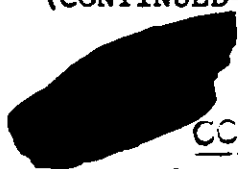

I told Zeifman that I was aware that Edwards had visited the resident agency. I also told him that the adequacy of personnel in the area has been considered by officials both in the field and here in Washington. He was thanked for advising us of Edwards' comments.

This matter was discussed with McSweeney who stated Edwards has been constantly agitating regarding the Kern County situation. He advised that Senator Hubert Humphrey (D.-Minn.) also has gotten into the act and sent a telegram to the Attorney General urging that a large force of personnel be sent into the area to handle the unrest that has resulted from the labor dispute. McSweeney was advised that a week ago we had inquired of the Sacramento FBI Field Office regarding the adequacy of personnel to handle civil rights complaints growing out of this situation in Kern County and were assured that there are sufficient personnel in the area to take care of the matter, including Spanish speaking Agents. He was advised that we have experienced some delays in handling the necessary investigation because of an uncooperative attitude on the part of attorneys representing the United Farm Workers.

The Civil Rights Section of the General Investigative Division advises we have had 23 civil rights cases referred to us as a result of the situation in Kern County, about half of which are preliminary types.

It is not new or unusual for Congressman Edwards to be critical of the FBI with respect to the handling of civil rights matters. He has done so consistently and with this situation being in his home area, it is natural that he will make every effort to take advantage of the publicity potential. Congressman Edwards does not represent Kern County, however. Kern County is divided between two congressional districts. One is represented by Congressman Robert B. Mathias and the other by Congressman William M. Ketchum, both Republicans.

On August 23, 1973, J. Stanley Pottinger, Assistant Attorney General in charge of the Civil Rights Division, phoned me. He said they have received a number of calls in his Division about violations of civil rights in the Chavez Case. In response to these, he wondered whether or not the following requests could be honored:

1. That we have Bureau Agents assigned who could, in effect, form somewhat of a police type of mission. This would be Agents who would be called into the area to do substantially the same that is being done by state officers and United States Marshals.
2. It was requested that there be a more vigorous job done in the investigation of civil rights matters. Pursuant to this, it was felt that there should be more people from outside the state assigned to the investigation. It was also felt that there would be a need for more Spanish speaking Agents on the site.

Mr. Pottinger then said he was of the opinion the first request should be denied. I told him I agreed with this and would not want to assign men for policing duties.

I pointed out I, for example, had opposed a Bureau rule of many years ago that police officers who have become Agents should not be assigned to civil rights matters. This in effect spotlighted the background of an Agent and placed him in a separate and, therefore on occasion, undesirable category. In my mind the fact a man had served as a police officer should not mitigate against him and there was no reason to believe that just because of this, he would be softer or more sympathetic to the officers being investigated as possible violators.

I therefore said I would not want to give any consideration to the assignment of Agents at the site merely because they represented an "out-of-state" status.

I then pointed out, however, that I thought the addition of Spanish speaking Agents might be helpful for the obvious reason. In assigning people with this capability, we might at the same time be handling the matter of assignment of people from out of state and the two could be accomplished, in other words, by this one measure.

Mr. Pottinger said he had been informed that there were some Spanish speaking Agents available and it would not present too much of a problem. I informed him, therefore, he could speak with the Civil Rights Section and could inform them that I approved of a reasonable number of such assignments. He indicated he felt this was a very agreeable position and that he would proceed in this direction.

As noted above, I set out my feelings about the assignment of Agents to civil rights investigations. I do not know the present rules in this regard. In view of this, I would like to have a memorandum outlining such policy in order that I might possibly consider revision in accordance with my personal observations.

Reference is made to Director Clarence M. Kelley's memorandum dated 8/27/73, which among other things, discussed the necessity of assigning some Spanish-speaking Agents to work Civil Rights cases which have arisen within the Sacramento Division as a result of the confrontations between pickets of the United Farm Workers (UFW) and the Teamsters Union.

As background in this matter, on 8/17/73, a discussion was held with Mr. William L. Gardner, Deputy Chief, Criminal Section, Civil Rights Division (CRD), U. S. Department of Justice (USDJ), wherein Mr. Gardner mentioned that Mr. Robert Murphy, Chief, Criminal Section, CRD, USDJ, had received a phone call earlier that day from Democratic U. S. Congressman Donald Edwards, 10th Congressional California District, who had spent some time in the Kern County, California, area observing the strike situation involving the UFW and Teamsters Union. Mr. Gardner stated he had been informed by Mr. Murphy that Congressman Edwards stated he felt the Federal Bureau of Investigation was being hindered in its investigation of Civil Rights complaints by a lack of manpower and by a lack of Spanish-speaking Agents.

On 8/17/73, a discussion was held with Assistant Special Agent in Charge (ASAC) Theodore P. Rosack, Sacramento Division, wherein ASAC Rosack stated at that time he felt he had sufficient personnel assigned to handle the investigations and that the two Spanish-speaking Agents then assigned in the area were sufficient to handle the work. He indicated that if a drastic increase in the number of cases occurred, he would reassess the manpower needs at that time.

On 8/24/73, ASAC Rosack advised he had been advised by Mr. William Briggs, Special Investigator, U. S. Senate Labor and Public Welfare Committee, who indicated he was in the Kern County area to investigate the acts of violence which had

occurred in connection with the UFW strike. Mr. Briggs requested ASAC Rosack meet with him on that day to discuss the FBI's posture with regard to the handling of the Civil Rights complaints. Mr. Briggs was referred to the CRD, USDJ.

On 8/24/73, Mr. William L. Gardner advised he was being sent by Assistant Attorney General J. Stanley Pottinger to the Kern County, California, area to confer with various individuals on the scene regarding the conditions and to inquire firsthand into the situation arising out of the UFW and Teamsters Union confrontations. On 8/28/73, a discussion was had with Mr. Gardner concerning his trip to the Kern County area and during this discussion, he indicated he had met with Caesar Chavez, UFW leader. During this meeting Chavez stated he felt more Spanish-speaking FBI Agents should be sent into the area to investigate the Civil Rights allegations as many involve itinerant Mexican-American farm workers who spoke only Spanish. Mr. Gardner was asked specifically if he intended to recommend in his report to Mr. Pottinger that additional FBI Agents be sent into the area to handle Civil Rights investigations. Mr. Gardner indicated that he would make no such recommendation, that he felt this assessment could only be made from within the concerned agency, and that it would be somewhat presumptuous for him to make such a recommendation. He did state, however, he personally believed that as a result of his discussion with Chavez and attorneys for the UFW, the number of Civil Rights allegations needing investigation would increase.

In referenced memorandum, Director Kelly expressed the opinion that if a determination were made additional Spanish-speaking Agents were needed to handle the Civil Rights cases, he would be agreeable to approving a reasonable number of such assignments.

ACTION: To assist in the investigation of the increasing number of Civil Rights cases occurring in the Kern County area, and to forestall any adverse public criticism, it is recommended that two Spanish-speaking Agents be temporarily assigned to the Sacramento Division from either the Los Angeles and/or San Francisco Divisions.

A separate memorandum regarding the Civil Rights policy of the Bureau is being prepared.

SACs, Los Angeles and San Francisco were telephonically instructed to send one Spanish-speaking Agent to Sacramento with the period of assignment indefinite at this time, and that the Agents should report on Tuesday morning, September 4, 1973. They were advised to confirm Bureau telephone call by nitel to Sacramento and the Bureau, and that any additional details should be obtained from the Sacramento Office.

There is attached a draft prepared by the Civil Rights Division of the Department. This draft is to be used in connection with Congressional inquiries to the Department and is to be furnished to the Public Information Office of the Department of Justice.

The draft was reviewed by the General Investigative Division. It is noted that on page 1 the draft stated, "To date, we have initiated more than a dozen investigations." In this connection, we have more than two dozen investigations going on at the present time; however, not all of these were initiated by the Department of Justice.

On page 2, lines 8, 9, and 10 read, "The Bureau has also agreed that, where appropriate, Special Agents who speak Spanish will be used in such investigations." It is to be noted that we already have two Spanish-speaking Agents assisting in these investigations and the General Investigative Division has recommended that two more be sent to assist.

It was suggested that lines 8, 9, and 10 be revised to read, "The Bureau, where appropriate, is utilizing Special Agents who speak Spanish in such investigations."

These suggested changes were discussed with Assistant Attorney General Stanley Pottinger of the Civil Rights Division. He agreed to adopt the language suggested for lines 8, 9, and 10 on page 2 and also indicated he would revise page 1 to relate that more than two dozen investigations have been initiated without differentiating as to who initiated them. Mr. Pottinger expressed appreciation for the suggestions and stated this draft of his statement would be utilized for the purposes noted above.

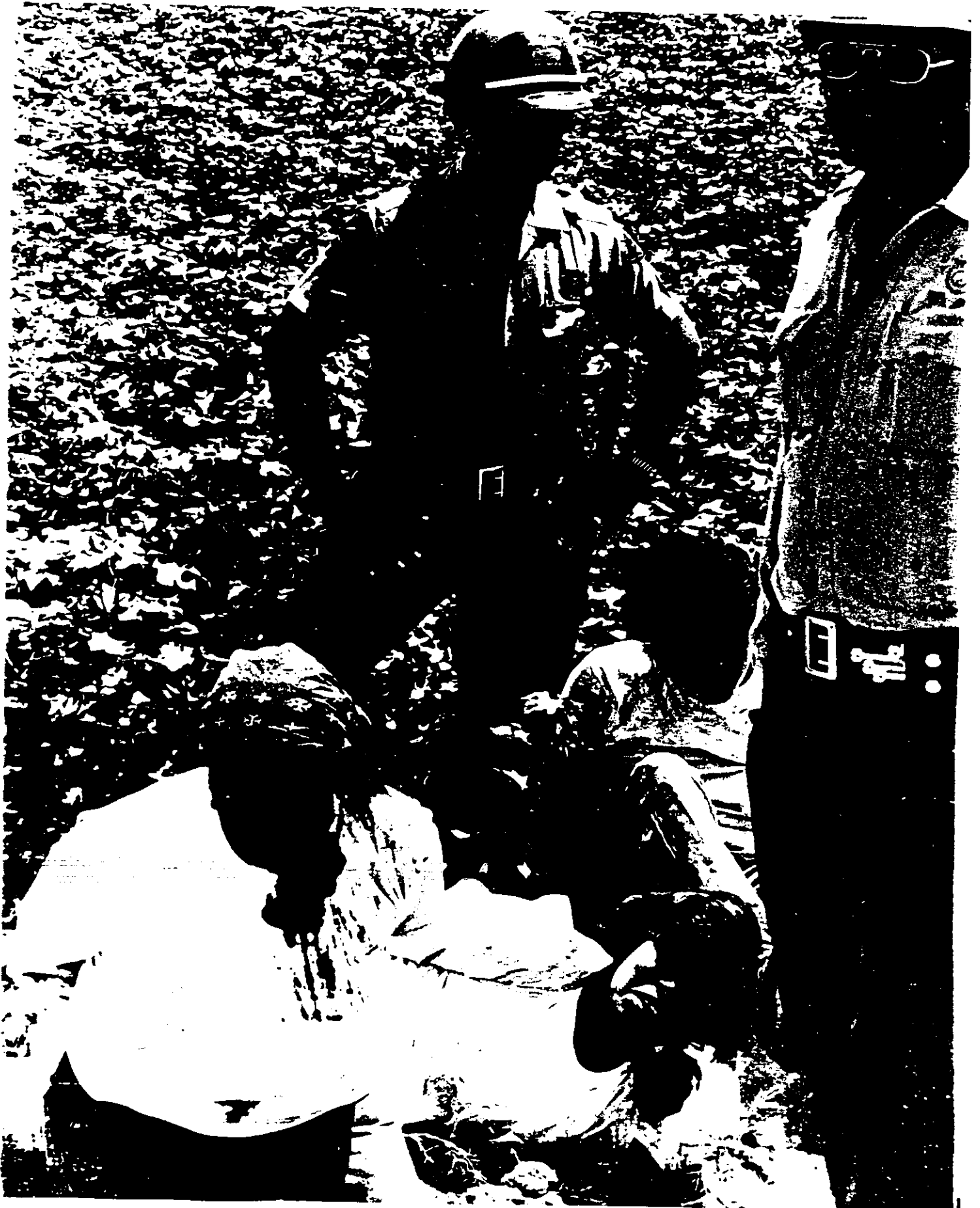

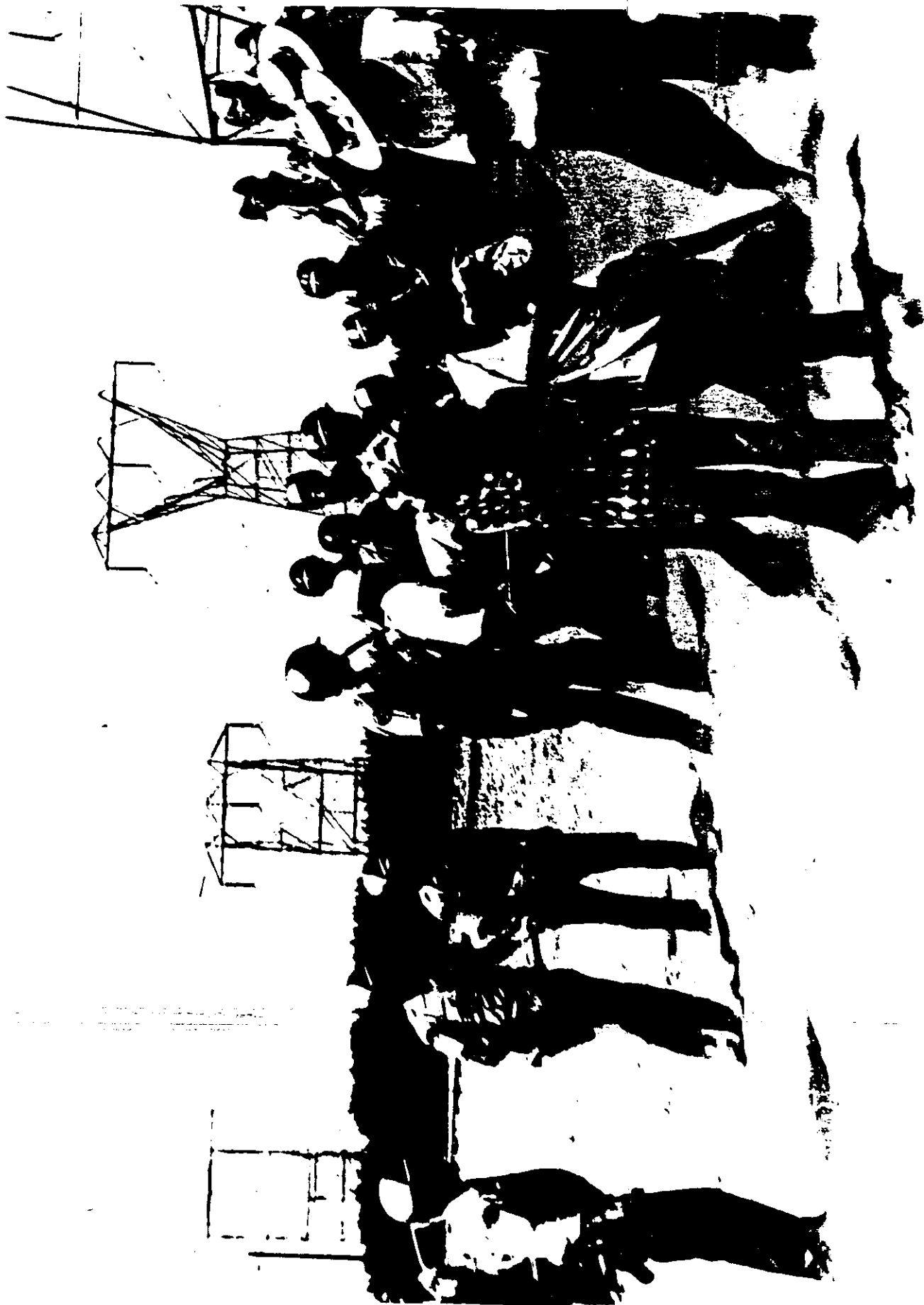

Dear Mr. Pottinger:

Thank you very much for your letter of September 4 describing work being done by the Department of Justice concerning possible violations of federal criminal law in activities involving the United Farm Workers in California. I sincerely appreciate the information you provided me.

I am sure you know that I am concerned with the situation in California, not only what has taken place during the past month but also the serious implications for the future. I spent several days in the Bakersfield-Delano area during the height of the tensions.

I observed the good work being done by the Community Relations Service, observed the United Farm Workers picketing at several vineyards, talked to local police and press, and attended the two funerals.

As explained to Mr. Murphy, I was disappointed not to find Chicano Special Agents in the Bakersfield F.B.I. office. The Daifullah funeral was thought important enough by the Catholic Church for Bishop Flores of San Antonio to travel at church expense to California. The only Agent I saw at the Bakersfield F.B.I. office taking statements in Spanish was not, in the opinion of my Chicano assistant, appropriately fluent in Spanish.

For many years in civil rights cases a major criticism of Justice Department involvement has been the use of locally assigned F.B.I. Agents to investigate allegations of criminal conduct of local police. From my experience in the Bureau I know that a harmonious relationship with the local police is essential to doing a good job for the F.B.I. This has always resulted in unenthusiastic investigations by the locally

assigned Agents and a strong feeling on the part of minority citizens that the F.B.I. is in league with the police. That this problem is well understood by the F.B.I. was made clear a few months ago by the F.B.I. Acting Director who said his policy in these civil rights cases would always be to send in outside Agents. Perhaps this was done and is being done in Fresno-Tulare-Kern Counties, but that is not the appearance of what is being done, and sometimes appearance is as important as action.

My last comment is to again stress the importance of these cases you are investigating. I am personally convinced that widespread violations of Federal criminal law took place and will take place again if the Justice Department does not face up to its responsibilities, unpleasant as they may appear. As I told Mr. Murphy on the telephone from Delano, lives could have been saved in the early sixties if Bull Connor had been arrested for his clear violations of Federal law. The same kind of illegal runaway police activity is taking place in California today, and I sincerely believe the Justice Department has an important and responsible role to fill.

The purpose of this letter is not, however, to give my personal views on the farm situation in California but is to thank you for your courteous communication and to express my appreciation for your keeping the Subcommittee informed.

The attached concerns letter from Congressman Don Edwards (Dem. - Calif.) dated 9/17/73, directed to Mr. J. Stanley Pottinger, Assistant Attorney General, Civil Rights Division, U. S. Department of Justice, which was forwarded by Mr. Pottinger to this Bureau by memorandum dated 11/27/73. In his letter Congressman Edwards expresses disappointment of the lack of Spanish-speaking Agents assigned to work Civil Rights cases in the Kern Co., California, area which arose out of confrontations between members of the United Farm Workers (UFW) and the Teamsters Union.

It is noted Congressman Edwards makes reference to a visit he made to our Bakersfield, California, Resident Agency, during late 8/73, and as a result of this visit he made his observations. At that time the Sacramento Division had two Spanish-speaking Agents assigned to assist in receiving Civil Rights complaints from UFW members. Constant contact was maintained with the Sacramento Division regarding the situation that existed in the Kern Co. area and as the number of Civil Rights allegations received increased, two additional Spanish-speaking Agents from other field divisions were temporarily assigned to the Sacramento Division to further assist the handling of these complaints. Both the Sacramento Division and FBIHQ felt the number of Spanish-speaking Agents assigned to that area was sufficient to handle the number of cases received. In view of this, it is felt no constructive purpose would be served in contacting Congressman Edwards with regard to the personal opinions he expresses in his letter of 9/17/73.

On Wednesday, March 27, 1974, this Division was contacted telephonically by Jerry Cohen, counsel in California for the United Farm Workers Union (tel. 805-822-5571). Cohen related that he had been contacted by a person who provided the fictitious name of "Fred Schwartz". Schwartz purported to have information that three people had at numerous times over the past several years broken into various United Farm Worker Union offices in California, as well as the offices of other organizations assisting the UFWU and their activities, including SNCC and the Saul Alinsky Organization. Cohen received the impression that Schwartz was an attorney and was representing one of the persons responsible for the break-ins. Schwartz wanted \$35,000 for evidence he would provide linking numerous California growers to these break-ins. Cohen met with Schwartz on Monday, March 25, 1974, in Bakersfield to discuss the matter further. Schwartz provided Cohen with brief glimpses of materials in his possession purporting to have been seized from offices broken into. Schwartz also provided a list of such places, including a UFWU office in Delano called Filipino Hall. Cohen related that Filipino Hall was in fact the object of an armed robbery last year and that the crime had never been solved. Among the

materials taken at that time were financial records of the union and records relating to certain of their activities covered by the Norris-LaGuardia Labor Act. Schwartz further related that there were checks in existence which would establish a financial link between the alleged thieves and the growers. Cohen further related that Schwartz was extremely anxious to raise the \$35,000, as his "client" was supposed to be charged this week with fraud by unknown prosecuting authorities. As the above information indicates a possible violation of Title 18, U.S.C. §241 involving interference with the rights of United Farm Worker Union members and workers under the Norris-LaGuardia Labor Act, please conduct the following limited investigation:

Interview Attorney Jerry Cohen for full details of his contacts to date with Fred Schwartz. In the event Schwartz recontacts Cohen, which Cohen feels is inevitable, arrange with Cohen to be informed of the location of the meeting to take place between Cohen and Schwartz. Establish a surveillance of that meeting and attempt to ascertain the identity of Schwartz. Following the meeting please reinterview Cohen for full details of the conversation. Assuming Schwartz can be identified by photographs, fingerprints or in some other manner, please inform this Division of the results of the interview with Cohen and the identification of Schwartz in order for us to determine what further investigation, if any, is warranted. Also, please do not inform local law enforcement authorities of the meeting between Cohen and Schwartz at this time.

This will confirm the telephone conversation of Wednesday, March 27, between William L. Gardner, Deputy Chief of the Criminal Section of this Division, and Supervisor [REDACTED] of your Bureau.

GENERAL INVESTIGATIVE DIVISION

This concerns a new Civil Rights investigation to be conducted by our Sacramento Division involving United Farm Workers (UFW) in California.

On 3/27/74, Mr. William L. Gardner, Civil Rights Division, U. S. Department of Justice, advised he had been contacted by attorney Jerry Cohen, UFW, Bakersfield, California, who advised he, in turn, had been contacted by a Fred Schwartz who allegedly represented one of three persons responsible for a number of burglaries of UFW offices in California during the past year. Schwartz offered to sell to the UFW certain documents and literature obtained during these robberies for a sum of \$35,000 and indicated persons conducting robberies reported to John Harmer, a California State legislator and to the California Council of Growers. Cohen had delayed responding to Schwartz's offer and arranged to have Schwartz recontact him 3/29/74.

Department requested investigation be conducted under possible violation Title 18, U. S. Code, Section 241, involving a conspiracy to deny UFW rights guaranteed by labor law statutes. They requested Cohen be interviewed for full details; attempts be made for Agents to observe future meetings between Cohen and Schwartz; that Cohen be interviewed immediately following meeting with Schwartz; and attempts be made to identify true identity of Schwartz. They requested no dissemination of information be made to local authorities at this time.

Sacramento Division was advised to conduct the requested investigation. The attached advises attempts to contact Cohen 3/27/74 negative; however, he will be available for interview 3/28/74. They have been instructed to sutel summary of Cohen's interview. Matter being followed closely and you will be kept advised of pertinent developments.

NOTE: This concerns a limited Civil Rights investigation being conducted by our Sacramento Division, pursuant to a Departmental request, into alleged break-ins of UFW offices and an attempt by one Fred Schwartz to sell documents taken during these break-ins to the UFW for a sum of \$35,000. By teletype 3/31/74, SC Division advised Schwartz met with victim 3/31/74 and offered to sell documents taken during course of 16 break-ins for a total of \$25,000. These break-ins occurred during 1966 - 1970 and documents allegedly have been in possession of House Un-American Activities Committee in the past. Schwartz named 3 major California growers as having hired individuals to do break-ins and indicated documents taken were periodically reviewed by military intelligence and other unknown agencies. He claimed 2 persons currently being paid "hush money," one in Mexico and one in Spain, and that periodically Agents of Army Intelligence or CIA send money to these two individuals through one of the three California growers. Schwartz refused victim close examination of documents, but stated he was a former policeman and desired to write book about matter. On 4/1/74, Mr. William L. Gardner, CRD, advised investigation should continue to fully identify Schwartz and once identified, information developed during investigation should be furnished to appropriate local and Federal authorities. This instructs SC and SF to expedite investigation to identify Schwartz and to suLHM results. [REDACTED] indicates growers Jack Pandol and Martin J. Zaninovich filed CR complaint with our SCO 8/73, alleging rights of growers had been violated by UFW workers.
