SYNOPSIS OF FACTS:

Anonymous post card addressed to ELVIS PRESLEY at Memphis, Tenn., postmarked 8 PM on 8-30-56, at Niagara Falls, NY, is obscene and contained threat to kill. FBI Lab searched postal card in question through anonymous letter file without identifying it with a prior submission. Facts of case discussed with USA, Buffalo, NY, who declined prosecution on grounds that card appeared to be from "Frank" and states he would reconsider prosecution in the event victim received additional threatening communications.

DETAILS:

By communication dated September 6, 1956, the Postal Inspector in Charge at Chattanooga, Tennessee, furnished an anonymous postal card addressed to ELVIS PRESLEY at Memphis, Tenn., postmarked 8:00 PM on August 30, 1956, at Niagara Falls, New York, to FBI Office at New York City who, in turn, furnished this postal card to the Buffalo Office. This postal card reads as follows:

"If you don't stop this (obscene word) we're going to kill you."

The above message on the postal card was written in pencil and is printed.

By letter dated September 20, 1956, the FBI Laboratory advised that the hand-printing on the postal card in question was searched through the anonymous letter file without identifying it with a prior submission.

On September 27, 1956, the facts of this case were discussed with Assistant United States Attorney RICHARD E. MOOT at Buffalo, New York, who advised that in the event the identity of the unsub was obtained, he would decline prosecution inasmuch as the card appears to be from a "crank." Mr. Moot further advised, however, that in the event additional threatening cards or letters were received by the victim, he should be advised and additional consideration would be given him to the prosecution of the person involved.

It is being pointed out that the complete text of the message on the postal card, including the obscene word, was furnished to Mr. MOOT.

Information concerning the subject was furnished to this office by the Provost Marshal Division, Hqs., U.S. Army, Europe, with the indication that they wished to avoid any publicity in this matter since they did not want to involve ELVIS PRESLEY nor put him in an unfavorable light since PRESLEY had been a first-rate soldier and had caused the Army no trouble during his term of service. The information furnished by the Provost Marshal Division in a self-explanatory memorandum classified For Official Use Only is enclosed. Seven Photostats of letters from GRIESSEL-LANDAU to PRESLEY or to one of PRESLEY'S secretaries are also enclosed.

MEMORANDUM

3 February 1960

1. Elvis Presley was interviewed on 28 December 1959 concerning his complaint that he was the victim of blackmail by a Mr. Laurens Johannes GRIESSEL-LANDAU, of Johannesburg, South Africa. GRIESSEL-LANDAU represents himself to be a doctor specialist in the field of Dermatology. GRIESSEL-LANDAU is not a medical doctor.

2. Copies of letters from GRIESSEL-LANDAU to Presley and Presley's private secretary were obtained on loan basis so that they could be photographed.

3. On or about 27 November 1959, GRIESSEL-LANDAU appeared at the residence of Elvis Presley in Bad Nauheim, Germany and began his treatments. These treatments took place in Presley's quarters in the presence of two female secretaries (both U. S.). The treatment involved Presley's shoulders and face.

4. Presley reports that GRIESSEL-LANDAU made several homosexual advances to some of his enlisted friends. GRIESSEL-LANDAU also is alleged to have admitted to Presley that he is bi-sexual. His first homosexual experiences took place early in his life in the orphanage in which he was brought up.

5. On 24 December 1959 Presley decided to discontinue the skin treatments. At the time that he told GRIESSEL-LANDAU of this decision he also thoroughly censured GRIESSEL-LANDAU for embarrassing him as a result of the improper advances that he (GRIESSEL-LANDAU) made to his (Presley's) enlisted friends. GRIESSEL-LANDAU immediately went into a fit of rage, tore up a photo album of Presley's, and threatened to ruin his singing career and to involve Presley's American girl friend (a 16 year old daughter of an Air Force captain). GRIESSEL-LANDAU further threatened to expose Presley by photographs and tape recordings which are alleged to present Presley in compromising situations. Presley assures us that this is impossible since he never was in any compromising situations. Presley contends that GRIESSEL-LANDAU is mentally disturbed. This is based upon the fits GRIESSEL-LANDAU has had and on his statements concerning the shock treatments he has been taking..

6. By negotiation, Presley agreed to pay GRIESSEL-LANDAU \$200.00 for treatments received and also to furnish him with a \$315.00 plane fare to London, England. GRIESSEL-LANDAU agreed to depart to England on 25 December 1959 at 1930 hours from Frankfurt, Germany. GRIESSEL-LANDAU did not leave as agreed, rather returned and demanded an additional \$250.00, which Presley paid. A day later GRIESSEL-LANDAU made a telephonic demand for 2,000 £ for the loss of his practice which he closed in Johannesburg, South Africa prior to his departure for Bad Nauheim to treat Presley.

7. GRIESSEL-LANDAU finally departed Rhein-Main Air Field, Frankfurt, Germany at 1600 hours, 6 January 1960 on Flight 491, British European Airway for London, England under the name of GRIESSEL. He is alleged to be seeking entry into the United States. No contact between Presley and GRIESSEL-LANDAU has been reported since 5 January.
