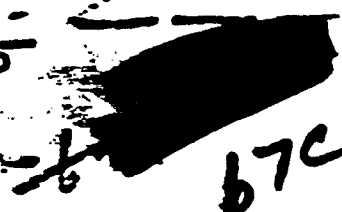

On 9/20/77, a series of search warrants were executed at key locations throughout the United States at the residences and businesses of primary subjects related to OPPOPEN. The two additional cases captioned in the title of this communication are considered OPPOPEN related. One of these searches was conducted at Bannon International, 156 State Street, Boston, Massachusetts. The Boston Division seized a voluminous amount of records stored at this establishment and thereafter began to put the information in a form suitable for entry into the computer system (Major Case Information System).

At the present time, Boston is continuing to review the seized material and is in the process of setting forth leads based on information obtained from the material.

**As brief background:**

Beginning on 12/16/74, and extending through 1975, PHILLIP KARL KITZER, JR. and other individuals operated an "off shore bank" identified as the First National City Bank and Trust Company, Ltd., Granada, West Indies. From approximately 11/75 through 5/76, KITZER was a leading figure in the operation of a second "off shore" bank, the Mercantile Bank and Trust Company, St. Vincent, and Chicago, Illinois. With increasing law enforcement interest in each of the aforementioned "off shore" banks, KITZER and his associates moved to create a new vehicle for fraud. The third "off shore" bank organized was the Seven Oak Finance, Ltd. Bank in Kent, England, which KITZER and his associates had acquired by the Fall of 1976. It is reasonably estimated through comments made by KITZER that the total amount of fraudulent negotiable instruments written through the "off shore" banks operated by KITZER and his associates, approximates 2 1/2 billion dollars. In all three of these ventures, KITZER and others sold and/or were involved in the negotiation of letters of credit, certificates of deposit, loan guarantees and other financial instruments on these "off shore" banks.

KITZER and his associates have termed themselves, "The Fraternity" and are a loosely knit group comprised of approximately 30 to 40 of the world's top con-men. These con-men have maintained contact with each other through the extensive use of telephones, telex machines, the mail and personal visits.

If latents of PRO are developed, Identification Division is further requested to prepare a clear plastic overlay which can be used on top of the examined material to show graphically how the hand was placed in holding the paper. Latents, should they be PRO's, should be so placed on the paper as though PRO were holding the paper in position while writing. Memphis advised in 12/9/77 airtel to Miami, referenced above, that this technique is being used most effectively in ITSP prosecutions at Memphis. b7c

2. FBI Identification Division, Handwriting Section, is also requested to determine if the handwriting appearing on the nine sheets of paper is identical to any of records for that of FREDERICK P. PRO.
