

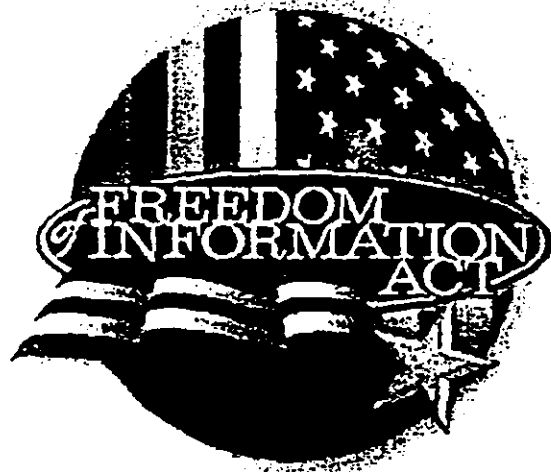

Merv Griffin's Night For the Network's

On the anniversary of its cancellation of the Easter Sunday show of the Snothers Brothers and their series, CBS had another programming dilemma on Friday. A yippy Abby Hoffman, one of the "Chicago 7," appeared on the Merv Griffin late night talk show wearing a shirt resembling the U.S. flag.

This time, CBS canceled was Hoffman's offending image. The show went on the network Friday and was seen here on Channel 9 on a delayed basis Sunday night, with Hoffman blotted out. He was heard, but not seen, and only when he was a Hoffman close-up did the TV screen go entirely black.

Woods, president of the network, appeared prior to the segment to explain the "invisibly man" treatment. Because of legal complications and the desire not to affront many viewers, the network decided to mask Hoffman out. Woods appeared again at the end of the program to point out that Hoffman himself had referred to the legal complications over the use of the flag as a garment.

The ways of the law are often difficult to follow. In this case, the clever solution served to reduce the viewer's indignation of the offense. It apparently never occurred to the lawyers, or CBS, to drop the entire show, which was a predictably noisy exhibition that made very little sense and picked up in volume until it became a contest of who could talk the loudest.

Griffin, the host, looked alternately benign or puzzled and occasionally went back to pursue a line of questioning that Hoffman simply skipped over with aquip for his usual vocal mumble jumble.

Wouldn't it have been reasonable if the host of a talk show had appeared at 11:30 and announced: "Ladies and gentlemen, tonight I goofed. I

booked a program with one of the "Chicago 7," thinking that maybe we might learn something, but once again he used the program as a platform for the cliches we have heard a dozen times, and the program was a disaster. So I asked the network to cancel that program and here I am live, with a few surprise guests, like the president of this network. Maybe its time we had a discussion on what freedom of speech means and what our responsibilities are on this most powerful medium." That'll be the day.

Griffin, or his producer, did not extend themselves in planning the program. His guests included Virginia Graham, a mile-a-minute TV talker who was reasonably restrained until Hoffman observed that all America needed a face lifting; two inarticulate young actors from a current movie bomb called "Zybriskie Point," who live in a commune in the Boston area that sounds like Tahiti Revisited, and Tony Dolan, a young conservative from Yale who has tangled with Hoffman before on other TV talk shows and still tries to use factual arguments. But he made a few points in the melee, enough to anger yuppies in the audience.

Of course, the show could win an Emmy for visual non-effects.

As of yesterday, by the way, Griffin still did not have a local outlet for his program after this week. WTOP-9, the CBS affiliate, announced several weeks ago that it was dropping his program to run movies, effective next Monday, and did not even want to run the show in the daytime. Channel 5 offered a morning hour that will open up in the near future, but the guess here now is that channel 20 (WDCB) will pick it up at its regular time.

With Griffin due in Washington next month, hopefully to do several programs with government officials and other area guests, the lack of a local outlet would present embarrassing problems.

On February 18, 1970, Jerry Rubin and Abbie Hoffman were found guilty in the United States District Court, Northern District of Illinois, Chicago, Illinois, for violating the Federal Anti-Riot Law Statute for traveling in interstate commerce from outside the State of Illinois with intent to incite riots in Chicago, Illinois, during the Democratic National Convention in August, 1968. On February 20, 1970, they were sentenced to five years imprisonment and fined \$5,000 each. On February 26, 1970, the United States Court of Appeals, Seventh Circuit, Chicago, Illinois, ordered them released on \$25,000 bond each pending appeals of their convictions.

Solid Gold in Haywire Left

Abbie Hoffman and Jerry Rubin live in two worlds. There's the world of the streets—of Chicago, the Pentagon, of Uncle Sam hats, American flag shirts, Drillo hair—the media manipulative put-on world of the Yippies.

But less visible, there's another world of literary agents, royalty checks, sales percentages, lecture fees, book and movie contracts.

For Hoffman, 32, and Rubin, 31, are leading examples of a new discovery by book publishers and movie producers: There's big money in revolution.

Hoffman's two books already have sold 191,000 copies, have earned more than \$50,000 in advances, royalties and resale rights. As an added bonus, his book "Revolution for the Hell of It" was bought by Metro-Goldwyn-Mayer to be made into a movie. Hoffman's share in the complicated deal is at least \$25,000, with another payment still pending. The Yippie leader also has a piece of the net profits.

Hoffman and Rubin, flamboyant radicals with more than 30 arrests between them, are a bit reluctant to talk about their business side.

Are you a good businessman, Hoffman was asked? "Maybe," he replied after a long pause. "But I'm a better pool hustler."

"He talks about advances. He talks about percentages of things. He knows what he's doing," says Christopher

Cerf, the Random House editor who worked on Hoffman's second book, "Woodstock Nation."

Rubin's book "Do It" has sold 175,000 copies since it appeared last year. "It's going to sell a million," he predicts. Rubin has earned at least \$25,000 from the paperback so far.

Spurred by the success of the two Yippie leaders and Black Panther Eldridge Cleaver before them (Cleaver's book "Soul on Ice" sold more than 1.2 million copies), some major publishers have assigned editors to keep an eye on the new left, to watch the streets for potentially hot literary properties.

The latest entry, Panther Party Chairman Bobby Seale's book which was sold by fellow Panthers during a rally on his behalf in New Haven, Conn., last month.

"There's a certain competition among publishers for who has the best radical going," says Carl Brandt, Rubin's agent, who also represents more traditional writers such as Marquis Childs and Stephen Birmingham.

In a large sense, it's the latest twist—with today's royalties added—to a phenomenon that started with Tom Paine—revolutionary pamphleteering. Publishers, themselves, may not agree with the sentiments, but they feel the public has the right to know.

The books clearly are aimed at youth. Hoffman and Rubin sell well at college book stores. Hollywood's decision

"It's obvious more films will be made," says Hillard Elkins, who is producing the movie based on Hoffman's book.

The literary success of Hoffman and Rubin mixes both Marxes, Karl and Groucho, with a lot of show biz.

A key person in the beginning was Joyce Johnson, Hoffman's first editor at the Dial Press.

"I lived in the East Village on St. Marks Place. One could not help become aware of Abbie," she said. "Just on the off-chance he might be interested in doing a book, I dropped him a note."

Hoffman collected a \$2000 advance from Dial. But the book really didn't take shape until just after the Demo-

cratic National Convention in 1968.

"He called me up and said 'I've got the book.' It was right after Chicago. It suddenly jelled," she recalled. "He wrote very quickly. He's very facile, very clever. It just pours out of him."

Hoffman did most of the writing on his second book in Christopher Cerf's office. Often he lay on the floor, shirt off, scribbling in longhand. A parade of mini-skirted editorial assistants filtered in and out, staring.

One day Christopher's father, Bennett Cerf, head of Random House, toured the company with a matron. They opened the door and there was Hoffman, barchested, working on the book in his usual position. "He's not my son. He's not my son," Cerf exclaimed.

"Hi, Dad"

"Hi, dad," Hoffman answered with a big grin.

Brandt recalls he first met Rubin in Central Park while he was watching a Yippie "love-in." Those were the days when the Youth International Party, founded by Hoffman and Rubin, was trying to recruit members so protests could be organized in the streets at the Democratic Convention.

Rubin later arrived at Brandt's Park Av. office with the outline for his book. "Do it," was turned down by 15 publishers before Simon and Schuster accepted it.

Hoffman and Rubin are supreme self-publicists.

"Jerry's a marvelous pro-

ducer," says Brandt. "The trial itself was great promotion."

During his Chicago trial on charges of conspiring to cross state lines with intent to incite riot, Rubin gave federal Judge Julius Hoffman pages from the book. Since then, Rubin has appeared on ABC's late night Dick Cavett show. Rubin didn't plug the book, but he tore up and stepped on a judge's robes. Letters to Cavett generally damned Rubin but praised the program for having him on.

"Just being Abbie is publicity in itself," says a spokesman for the Dial Press. "He makes news. In our office he's courteous. He's trying to figure out ways to promote the book... he knows what he's here for. We know what he's here for."

Sometimes, when traveling around the country on revolutionary missions, Hoffman will tuck a list of bookstores to be visited into his suitcase. During a recess at the Chicago trial, he hosted a fingerprint party—instead of the traditional autograph party—at a Chicago bookstore.

"He's better at publicity than anyone else I've met," Cerf says. Hoffman's lawyer and business agent, Jerry Lefcourt, says: He'd probably be worth \$250,000 on Madison Av."

All the hoopla tends to obscure the business side, which includes the business of revolution. The books are

designed to bring down inhibitions and institutions.

A sample from Hoffman:

"One good way to protect the security of your gang is to all turn on together with LSD. A cop would smoke pot but he sure as hell would never drop acid. Also I've never seen an undercover cop with long hair and I've seen a lot of undercover cops."

And one from Rubin:

"When planning a demonstration, always include a role for the cops. Most people don't get excited until the cops come in. Nothing radicalizes like a cop. Cops are perfectly dressed for the role of 'Bad Guy.'"

Where has all the money gone? Certainly some of it has gone for bail. Hoffman and Rubin vehemently deny having sold out to capitalism in the slightest degree. They say, and their agents claim, almost every penny of their earnings flow back into the movement. Lefcourt says that Hoffman's lifestyle has not changed—and that the Yippie leader now has to worry about his income taxes.

"He isn't rich," adds Lefcourt.

More Books

"I was not co-opted," Rubin says. "I didn't do the book for money. I did the book because I wanted to spread the fire. We're using the system to destroy it."

But Rubin praises Simon and Schuster. "Even a good Communist can respect a good capitalist," he says. "They have distributed the book well."

What of the future? Hoffman is writing two more books. One is called "Steal This Book" and is a manual

of how to get things free in America. Hoffman's wife, Anita also is writing a book. Rubin says he is planning another book this summer. There are also plans to revive the Yippies as a political party this fall. Rubin and Hoffman want to start their own publishing house.

The two revolutionaries paused the other day amid all the activities to reflect on themselves as authors.

"A book is like a chocolate bar. You experience it. It's not just debating intellectual ideas," said Rubin.

"I have a disdain for my own writing. I don't view myself as an author," Hoffman said. "I just exert a lot of energy. Sometimes I write it down on paper."

He thought a minute.

"It's embarrassing," he said. "You try to overthrow the government and end up on the best-seller list."

According to its official newspaper, the Black Panther Party (BPP) was started during December, 1966, in Oakland, California, to organize black people so they can take control of the life, politics and the destiny of the black community. It was organized by BOBBY SEALE, BPP Chairman, and HUEY P. NEWTON, BPP Minister of Defense, NEWTON was sentenced in 1968 to serve 2 to 15 years after being convicted of manslaughter in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther", which further describes itself as the "Black Community News Service", states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education, GEORGE MASON MURRAY, which ends with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement, "...we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman MAO Tse-tung of the People's Republic of China and feature MAO's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.

The "Newark Sunday News" of Newark, New Jersey, issue of April 20, 1969, contained an article showing the NECLC, of 25 East 26th Street, New York, New York, operates from its office an anti-war legal help organization for draft-age men, reservists and those on active duty.

According to this leaflet, the USCANLF-SV is an Ad Hoc organization formed in April, 1965. Its mailing address was Room 5, 103 MacDougal Street, New York City. The only officer listed is WALTER D. TEAGUE, Chairman.

The USCANLF-SV supports the aims of the National Liberation Front of South Vietnam (NLF) and the right of the people of Vietnam of self-determination without the presence of United States troops. It calls for the immediate withdrawal of all United States troops from Vietnam. It will counteract the United States Government's propaganda by making available literature of the NLF; disseminating analyses and reprints of the political structure and nature of the NLF; providing speakers for street meetings, teach-ins, etc.; working with all groups for recognition of the legitimacy of the NLF, and by urging all people to send medical aid and money for medical aid to the NLF through its missions.

[REDACTED] a leaflet issued by the U.S. Committee to Aid the National Liberation Front of South Vietnam, Box C, Old Chelsea Station, New York, New York, Zip Code 10012, telephone YU 2-7162. This leaflet was a call for support issued by the Committee and reported a letter received from the Charge d'Affaires, National Liberation Front of South Vietnam, Havana, Republic of Cuba, in which he expressed appreciation for support given to the National Liberation Front of South Vietnam by progressive organizations of North America, calling for the total and unconditional withdrawal of American troops from Vietnam. In this leaflet, the Committee urged all groups and individuals to support the just demands of the Vietnamese and oppose U.S. imperialism. This leaflet was signed by WALTER TEAGUE, Chairman.

A review of the records of the Criminal Court of the City of New York, Part 2B, Room 415, 100 Centre Street, New York City, on July 16, 1970, disclosed that Abbott Hoffman, with his attorney Gerald Lefcourt, appeared before Judge Arthur Braun in the Criminal Court of the City of New York on July 15, 1970, in connection with Hoffman's arrest at Columbia University on April 30, 1968 by the New York City Police Department (NYCPD) on charges of criminal trespassing and resisting arrest. Hoffman pled guilty to criminal trespass and was sentenced to a \$50 fine or five days imprisonment by Judge Braun. Hoffman was continued on \$50 bond and was given until August 17, 1970 to pay the fine or be jailed.

The records of the Criminal Court of the City of New York also disclosed that Abbott Hoffman, with his attorney Gerald Lefcourt, appeared before Judge Arthur Braun on July 15, 1970, in connection with his arrest by the NYCPD on April 11, 1969, on charges of simple assault and disorderly conduct, resisting arrest, harrassment and obstructing governmental administration.

On a motion of the District Attorney the charge of simple assault was dismissed.

Abbott Hoffman pled guilty to resisting arrest and was sentenced to \$1,000 fine or one year imprisonment by Judge Arthur Braun. Hoffman was continued on \$500 bond and was given until August 17, 1970 to pay the fine or be jailed.

It stated the ECLC was established in 1951, and "although representing itself as a non-Communist group, actually operates as a front for the Communist Party."

"The New York Times" issue of April 1, 1968, contained an article reflecting the ECLC was changing its name to the National ECLC (NECLC) "to reflect our determination to develop a vital national civil liberties organization in all 50 states as rapidly as possible."

The "Newark Sunday News" of Newark, New Jersey, issue of April 20, 1969, contained an article showing the NECLC, of 25 East 26th Street, New York, New York, operates from its office an anti-war legal help organization for draft-age men, reservists and those on active duty.

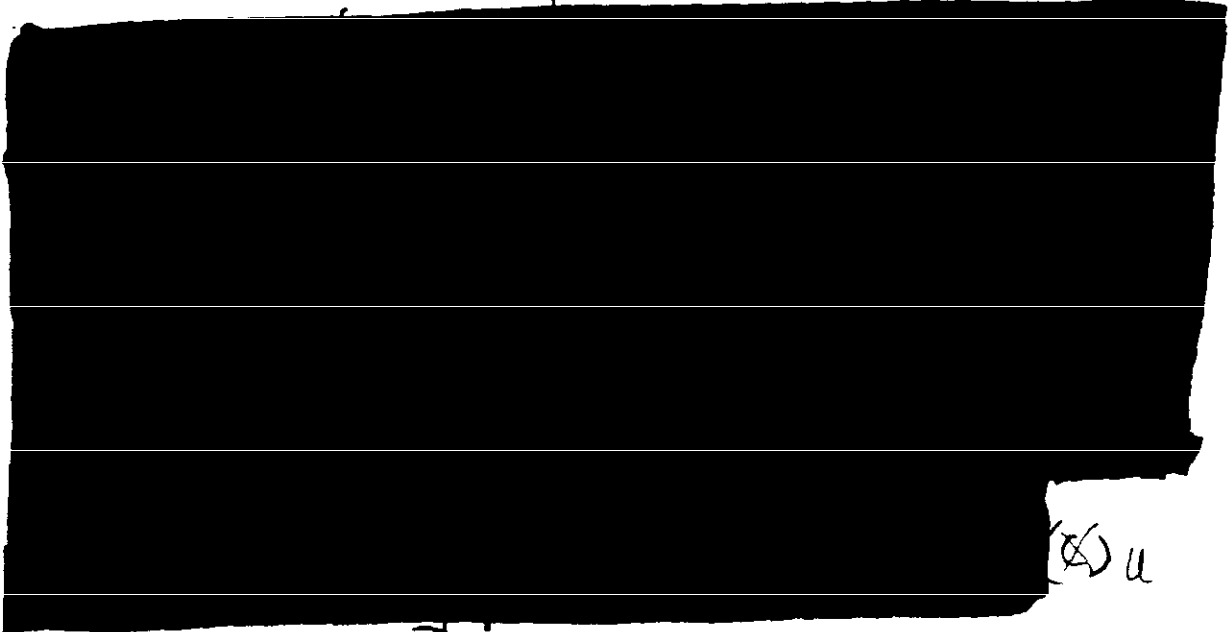
