The "Daily Worker", December 12, 1946, Page 11, Column 1, carried an article by DAVID PLATT entitled, "Brooklyn Has A New Film School". This article stated that "The week's good news in the culture front" was the opening in Brooklyn of the New Institute, an "important training center in film, radio, and dance techniques", and stated that the New Institute occupied two entire floors at 29 Flatbush Avenue. was listed as being among the members of the faculty. The article stated that the Film Department of the school had available a complete studio with camera, lighting, sound projection, cutting and editing department, and that for radio students the New Institute had installed a complete sound system with professional recording apparatus. The article stated that programs produced and directed at the school would be broadcast.

The "Daily Worker" issue of May 3, 1947, Page 11, Column 1, identified DONALD WINCLAIR as Director of the New Institute at 29 Flatbush Avenue, Brooklyn, New York, and stated that all of the courses in the institute were approved for veterans.

It is to be noted that LEVISON attended St. Johns Law School from the period 1935 to 1939.

With respect to the American Law Students Association, the Sunday edition of the "New York Times", dated December 27, 1936 on Page 10, Column 1, under the heading "Society Formed By Law Students" set forth the following:

"The American Law Students Association, designed to deal with legal, ethical, social and economic problems affecting law school students, was formed yesterday by students from the law schools of Columbia University, New York University, St. Johns University, and Brooklyn Law School in this city, and Harvard and Yale.

"During their three hour meeting in the Bar Association Building, the students showed greatest interest in the economic difficulties that are confronting them as law clerks and as young lawyers. Suggestion of a minimum wage for clerks brought a withdrawal for the St. Johns Student Council. Assurance that the organization would take no stand at present on a minimum wage brought the Council back in, and THOMAS W. LA VENIA, President of the St. Johns Council was elected Vice President of the new organization.

"The group finally adopted the proposal by the LINFIELD Committee that the Association 'take adequate steps in conjunction with bar associations, law school faculties, and other legal groups to improve the economic well-being of law students, law clerks, and young attorneys.' Suggestions were made of more Government jobs for lawyers.

"The meeting decided that the organization would be a forum for the discussion of the legal basis of national problems, and encourage cooperation between law reviews and the exchange of professors, and would seek changes in curriculum to prepare for Government positions".

Mentioned in the above article with THOMAS W. ~~LA~~ ~~VENIA~~, were STANLEY LEVISON and JOHN ~~MALONEY~~, student and Vice Dean, respectively of St. Johns University Law School, among others. NY

[REDACTED] advised in 1941 that among other circulars, a copy of the minutes of the Fifth Annual Convention of the American Law Students Association was found in Madison Square Garden, New York City, following the CP meeting held on April 17, 1941. b1

The CP has been designated by the Attorney General pursuant to Executive Order 10450.

The House Committee on Un-American Activities, 79th Congress, Second Session, May 29, 1946, at Washington, D.C., reported the following on Page 8 with respect to the American Law Students Association:

"1. Cited as under Communist control, influence, or in collaboration with the CP by the Committee for Cultural Freedom, Professor JOHN ~~DEWEY~~, Chairman, April, 1940." NY

When interviewed during the early part of 1954 in connection with another matter, Father JOSEPH T. TILLANEY, Dean of St. Johns University Law School in Brooklyn, New York, stated as follows in connection with the American Law Students Association. Father TILLANEY said that it was his understanding that the American Law Students Association was conceived with ethical and loyal intentions in 1936. The St. Johns Council was active in the association for approximately one year and the association became rather dormant thereafter to the best of his knowledge. He added that it was his understanding that the American Law Students Association became connected with persons and organizations of questionable patriotism and then died out entirely. He stated that it had been replaced by another organization of excellent reputation, sponsored by the American Bar Association.

JOSEPH F. LOEWI, according to these records, died a resident of NY County on 6/4/49. On 6/29/49 a decree was made awarding letters of administration to ALICE R. LOEWI on the goods, chattels and credits of her deceased husband. Subsequently there was found a will of JOSEPH F. LOEWI dated 6/24/40 together with a codicil dated 3/31/42, which were admitted to probate by decree of the court 5/15/51.
