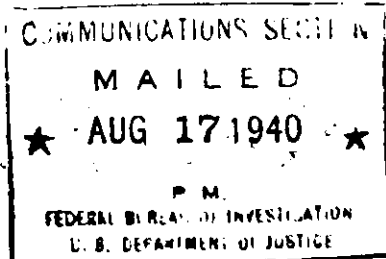

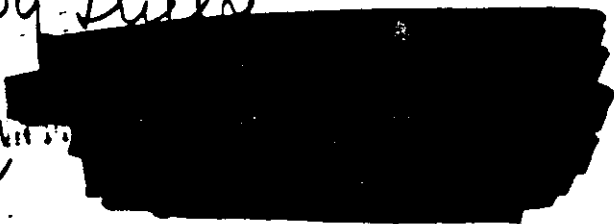

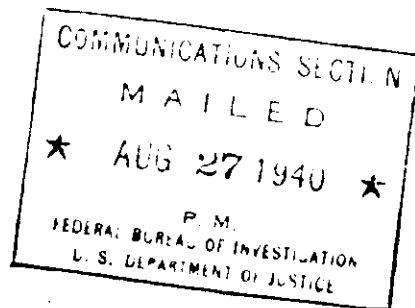

GERMAN GROUP TO BUY STATION

CHICAGO: (AP) The German-American National Alliance, Inc., announced today its intention of raising funds to purchase or lease a radio broadcasting station.

The action followed a decision by radio station WHIP at Hammond, Ind., to terminate broadcasting of the German hour program which has been sponsored by the alliance.

Dr. George F. Courier, president of the broadcasting corporation, explained that any broadcast that "engenders social conflicts or kindles hatred cannot be construed as serving the public interest." Alliance directors adopted a resolution to "supplement otherwise the already available channels of communication between the organization and its members and supporters

MEMORANDUM FOR SPECIAL AGENT IN CHARGE

Detroit, Michigan
August 13, 1940

On August 8, 1940, Mr. L. Jerome Dufahaut, Commercial Manager of Essex Broadcasters, Inc., the firm operating Radio Station CKLW, Windsor, Ontario, Canada and Detroit, Michigan, with offices in the Union Guardian Building, Detroit, called at the Detroit Office and surrendered a postcard postmarked Detroit, Mich., August 6, 1940, addressed to W. T. Grant Dept. Store, 5870 Grand River Ave., Detroit, Michigan and whose message, in substance, was that the sender, [REDACTED] Detroit, was surprised that the Grant Company advertised over a station which would not let "Us Americans" hear Col. Lindbergh's speech of the Sunday just past.

Mr. Dufahaut advised that Col. Lindbergh spoke from Chicago, Ill., Sunday, August 4, 1940, over the network of the Mutual Broadcasting System, of which CKLW is an associated or member station, but that CKLW had elected to strike the speech or not to carry it on the air, due to the fact that part of its operations area is in Canada and that it was anticipated Lindbergh's speech would not be to the liking of Canadians. In addition to this postcard, he stated, his station had been in receipt of about fifty telephone calls from persons in Detroit, complaining about keeping Lindbergh's speech off the air and, since they were all earmarked with a sprinkling of mass-effort, he wished to bring it to the Bureau's attention, particularly since it had been his information that Lindbergh's speech in Chicago was attended largely by persons whose enthusiasm had been aroused by German sponsors. He could not or would not enlarge on how he had obtained this information, or upon the degree of authenticity to attach to it, but suggested that station WHP, of Hammond, Indiana, might have some information on the subject.

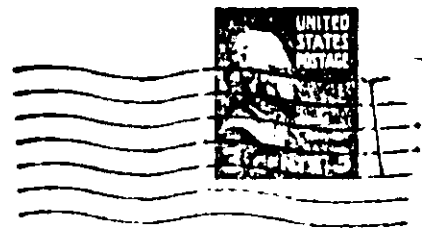
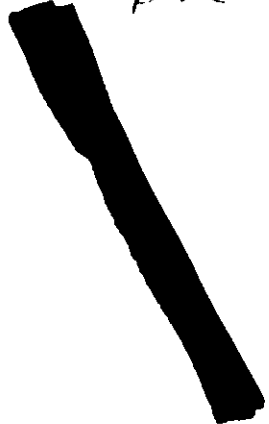

Gentlemen:

We all realize that this year of 1940 opens for us a hitherto unprecedented expanse of OPPORTUNITY for PROGRESSIVE GROUPS to concentrate their efforts and to gain truly beneficent results from their natural power which lies in their will to advance.

The committee that is herein communicating with you wishes to develop in this letter a plan which will have reason to believe you are interested in—namely: A certain few principles and procedures for a new government; and the suggestion of a certain person to be a candidate for president on an independent ticket.

There are probably about ten million voters in this nation who have been preparing, in their minds, for a new economic and political system. This being so, why do we not have a new government? Consider this to be the general reason: That it appears that each person who has something to offer is holding up a bit of something, saying, "Look, I've got the truth!"; and he is enamored with his own bit of truth, really has something that in its fundamentals is a bit of truth (it always is); and he is further convinced that it is he that is holding it up. He is so enamored that he exaggeratively proclaims he has the truth. Consequently, the exaggerated bits of truth, offered by nearly all persons and groups, clash and conflict. All our disagreements and strifes exist because different groups are offering different bits of truth in the place of the whole truth. Fragmentary, disconnected and scattered bits of truth. Truth will not stand for that.

WE MUST COMBINE, IN THE SERVICE OF THE NATURAL, THE WHOLE TRUTH THAT MUST BE, THAT WILL BE, MANIFESTED AND ESTABLISHED IN OUR ECONOMIC AND POLITICAL INSTITUTIONS.

WE MUST CONCENTRATE WITH ALL OUR MINDS, WITH ALL OUR HEARTS, ON THE FUNDAMENTAL STREAM OF LIFE—WITHIN US, AND WITH ALL OUR ACTS, TO OBTAIN AND AFFAIN THAT TRUTH THAT APPLIES TO ALL, THAT BENEFITS ALL, AND THAT IS THE ORDERLY PROCEDURE OF LIFE TO ALL.

What is the key thought to that truth and that solution? It is this: ONLY THAT TRUTH THAT BENEFITS ALL MEN CAN SOLVE OUR PROBLEM. We must draft ourselves into a new, wholesome solution.

IN THE NAME OF THAT FULL AND FULLY APPLICABLE TRUTH, WE STOP TALKING ABOUT, WRITING ABOUT, WORKING FOR, ATTEMPT TO APPLY, AND FIGHT FOR THOSE PRINCIPLES OF ECONOMIC AND POLITICAL LIFE THAT ARE VITAL AND VITALITY. WE REFUSE HENCEFORTH TO BE DISTRACTED AND SENT OFF ON TEMPORARY OR OPPORTUNISTIC ISSUES AND ARGUMENTS.

We submit to you now the next egg of that body of permanent principles, namely: To establish constitutional money for our nation—the right of congress to coin money and regulate its value; and that we must have an honest money system that is honest especially because it really satisfies, the individualist, that is, the person who champions the right to individual enterprise; it really and honestly serves, satisfies, the majority, who are entitled to live without being exploited of the natural means to do so; and furthermore, it must serve, satisfy, that we must have a governmental system that can really enforce and maintain an honest money system.

AS THINGS STAND, CAPITALISM HAS A BIT OF TRUTH; COMMUNISM HAS A BIT OF TRUTH; AND TOTALITARIANISM HAS A BIT OF TRUTH. EACH SYSTEM HAS A BIT OF THE WHOLE TRUTH. SO THEY CLASH. WE PROGRESSIVE SEEKERS MUST FIND A WAY TO BRING THESE TRIPLE PIECES OF TRUTH REALLY FIT TOGETHER. Working on the money system that will lead to the practical way in which they are one. When we find what capitalism really have; and use that find as a co-ordinated whole, then we are beginning to see the way; and we can be satisfied that none shall exploit the others—neither the few the many, nor the many the few.

In the name of that full and applicable solution, we now make a further suggestion: We draft, in this year of 1940, one of our outstanding citizens on an independent ticket for president. We believe we have in mind a person who is singularly qualified for this position on such a ticket as we consider. We believe that this person would with all his heart answer a call to lead into a realization of the solution for every man. We believe he is watching and waiting for the right time, conditions and men are ripe to be revolutionized—WITHOUT FORCE—into a system that springs us out of all our present floundering and futilities. Who is this person?

He is Col. Chas. A. Lindbergh. Let us draft Col. Lindbergh in the service of vital, permanent principles, to unify the right thinking people of this nation on a platform of economic broadness and moral uplift.

Col. Lindbergh has, in recent broadcasts, repeatedly urged us to organize in our communities, to unify ALL ADVANCING GROUPS, let us solidify our efforts into one tremendous demand for a new money, economic freedom, SOLUTION FOR ALL.

Our motto is: SOLUTION FOR ALL!

THIS MOVEMENT TO JOIN MEN TO PERMANENT FUNDAMENTAL PRINCIPLES, regardless of what is done or accomplished now. With regard to the general disapproval of Lindbergh-- I have a very odd relationship to his entire history, dating from the week before he flew the Atlantic.

I tried, during the famous case associated with his name, to bring some facts into public view, but was not successful. However, I worked with ex-Governor Hoffman on the matter some of which cautiously appeared in Liberty afterward- and am in possession of some astounding matters gathered from many during and after the Hauptmann trial.

Much of this I tried to bring to the attention of the FBI during that trial but was not successful, either.

If, in the life which I know to be very full of hard work, you can spare an hour to hear some of this, with the view to passing it on if you choose-- I will gladly await your convenience, suiting my time to yours. The facts of this case, believe me, are quite otherwise than they have ever appeared and I believe if the truth can be pulled out, that ~~that~~ it will ~~not~~ forever discredit Lindbergh and stop his influence in this country and disclose him for what he is-- but will rival the famous Dreyfuss case in France,- a case along with the Lindbergh case which both so far surpass fiction as to make the maddest writer a mere dealer in soda-pop.

I am-- I do believe you know it-- a very conservative person, knowing far more of the seamy sides of life than most women and from long association with police, welfare workers and prison officials, not inclined to be too easily excited.

Gentlemen:

Last month you received a letter from the Lindbergh For President Club No. 1, of the above address. This October letter comes from the same organization, from the same address, and from the identically same committee membership—only the name of the organization has been changed. It is now the SOLUTION FOR ALL CLUB No. 1. During the course of this letter you will learn the reasons for this change of name without change in objectives.

We received a considerable number of replies to our first letter, encouraging and prompting us to proceed with this work. The dominant feeling of the many letters was that, as expressed by one of the writers, "Your plan is a ray of hope in an otherwise dark situation."

A few letters were unfavorable to the movement. We do not blame these writers, for we think we have not yet given ourselves opportunity to make known what we are and stand for. We shall now quote you one of these unfavorable letters. It is the only one of its particular kind that we received. Yet we quote it because we realize that others must have thought likewise. Furthermore, our answer to this letter turns out to be an answer to all the questions, suggestions and such misunderstandings as were contained in all the letters we received. We quote the letter, word for word, and in full, as follows:

Gentlemen:

Your anonymous communication of August 1940 is hardly deserving of serious consideration by any respectable American citizen who has the interest of his country honestly at heart. Furthermore, anyone who sets out to revolutionize with or without force the economic system of the country should have courage enough to stand upon his feet and declare his intentions without using so honorable a person as Colonel Lindbergh as a front. Further, an organization of the magnitude you propose which is inviting the support of American voters should at least indicate who are the responsible persons sponsoring the movement. You have an obligation to the country to make yourself known.

This is our answer:

Dear Sir:

We like your letter. We think it is in large part justified. And where it is not justified, that is due to the fact that we were still moving to get into a position from which we could make known our aims and objectives. Your letter evidently recognizes nobility of purpose and objectives in our first letter; yet it also recognizes something that is greatly incongruous to that nobility. It was that incongruity that justified you in straining even all the practical loftiness there was in our procedure.

A very brief account of the brief history, to date, of this Club will show you how this temporary incongruity came about. The executive committee was from the beginning composed of men who are without question sincerely and selflessly and sympathetically devoted to bring consolation and order into all aspects of human existence. In carrying out their work as a committee they began by doing the usual thing in the usual way, namely to make the usual expressions on the usual earnest kind of issues, and on the newly arriving temporary issue and then to "HAIL SOMEBODY" who they thought could lead the American Nation into the better way. They presented specialized and limited issues and put their hope in personality. They were sure their objectives were right; yet they felt insufficient in the execution of their work. Consequently they made known the existence of the Club to a certain element of persons, and invited their co-operation. Some literature had already been prepared and allowed to trickle out, and its results noted. The new element differed very kindly with the old aims and objectives. Only ESSENCE is practical; and that which is practical is compounded of ESSENCE

We shall not only humbly, yet also proudly and exultingly submit ourselves to that PRACTICAL PRINCIPLE. We shall be able to express this PRINCIPLE in the simple terms of our economic and political life and institutions. We shall be able to permit this PRINCIPLE to work in our economic and political life and institutions. That which is fundamentally sound is the most practical. Any idea that is not practical is worthless. Ideas that are most fundamentally sound have the most practical value.

We hereby denounce and turn our backs to the floundering and futility, hate and envy, we have engaged in formerly. In this Proclamation of PRINCIPLE, the PRIME MOTIVE POWER, as our SPONSOR, we decisively depart from all current aims and methods of the usual attempts to bring about economic and political order. It is because of this departure, and only because of this departure, that we shall be able to do something sympathetic, consoling and constructive to restore our bodies, minds, souls and our society. Should we try to do it otherwise, we would only find ourselves fallen into the weary round of earnest beatings in the air or of insincere presumption and pretense of knowing.

Do you still wish to know who are the sponsors of this organization? Then seek to know this PRINCIPLE, PRACTICAL ESSENCE. Until we understand and use the ESSENCE of the PRACTICAL, we do not know the SPONSOR of this work—even though we be told the names of ourselves who are the servants and sponsors of SPONSOR NUMBER ONE. When we, the members of all the Solution for All Clubs, have become conclusively confident that the so-called sponsors humbly and gladly subordinate themselves to SPONSORING PRINCIPLE; when we, all the members of all the Clubs, have become conclusively confident that we do all subordinate ourselves to that PRINCIPLE, and are conclusively confident that we are ready, willing and able to apply this PRINCIPLE, or to permit this PRINCIPLE to apply ITSELF, then the names of the sponsors will be revealed.

We now apologize to PRINCIPLE, and to Col. Charles A. Lindbergh, and to the American People, if we have appeared to exalt the person of Col. Lindbergh above PRINCIPLE. All men who are, and shall be connected with this movement shall be capable of doing so only in so far as they have identified themselves with MOVING SUBSTANCE and POWER. We believe that Col. In carrying out their work as a committee they began by doing the usual thing in the usual way, namely to make the usual expressions on the usual earnest kind of issues, and on the newly arriving temporary issues and then to "HAIL SOMEBODY" who they thought could lead the American Nation into the better way. They presented specialized and limited issues and put their hope in personality. They were sure their objectives were right; yet they felt insufficient in the execution of their work. Consequently they made known the existence of the Club to a certain element of persons, and invited their co-operation. Some literature had already been prepared and allowed to trickle out, and its results noted. The new element differed very kindly with the old aims and objectives. They knew things would have to be conceived and carried on differently; and they knew things would be done differently. Yet they used no argument nor pressure to bring about this change. They allowed things to develop step by step from the old idea to the new idea. Demonstration and experience logically forced the change; and the first circular letter of the Club went through to bring about the climax in demonstrating the course to be followed.

The result is consistent. All the members of the committee, without one dissenting voice from both the original and the more recent element, are heartily agreed that we are now really beginning to state to you a consistent position, of consistent objective, and our consistent program. Accordingly, worthy friend, we, the Executive Committee of the Solution for All Club conceive that this Club has only one SPONSOR, and that the NAME of this SPONSOR is PRINCIPLE. It is that SUPREME PRACTICAL LAW that governs all action in all life. Out of this Law issue all right principles and all right programs. We of this Club undertake to be guided by, and to guide by, to express and to apply, that which we shall sense to be the SUPREME PRACTICAL FACT of the UNIVERSE, in all things, great and small, and, of course, particularly in human life, and still more particularly, as far as our present expression as the Solution for All Club goes, in our economic and political life. Only ESSENCE is practical; and that which is practical is compounded of ESSENCE.

We shall not only humbly, yet also proudly and exultingly submit ourselves to that **PRACTICAL PRINCIPLE**. We shall be able to express this **PRINCIPLE** in the simple terms of our economic and political life and institutions. We shall be able to permit this **PRINCIPLE** to work in our economic and political life and institutions. That which is fundamentally sound is the most practical. Any idea that is not practical is worthless. Ideas that are most fundamentally sound have the most practical value.

We hereby denounce and turn our backs to the floundering and futility, hate and envy, we have engaged in formerly. In this proclamation of **PRINCIPLE**, the **PRIME MOTIVE POWER**, as our **SPONSOR**, decisively depart from all current aims and methods of the usual attempts to bring about economic and political order. It is because of this departure, and only because of this departure, that we shall be able to say something sympathetic, consoling and constructive to restore our bodies, minds, souls and our society. Should we try to do it otherwise, we would only find ourselves fallen into the weary round of earnest beatings in the air, or of insincere presumption and pretense of knowing.

Do you still wish to know who are the sponsors of this organization? Then seek to know this **PRINCIPLE**, **PRACTICAL ESSENCE**. Until we understand and use the **ESSENCE** of the **PRACTICAL**, we do not know the **SPONSOR** of this work—even though we be told the names of ourselves who are the servant sponsors of **SPONSOR NUMBER ONE**. When we, the members of all the **Solution for All Clubs**, have become conclusively confident that the so-called sponsors humbly and gladly subordinate themselves to **SPONSORING PRINCIPLE**; when we, all the members of all the **Clubs**, have become conclusively confident that we do all subordinate ourselves to that **PRINCIPLE**, and are conclusively confident that we are ready, willing and able to apply this **PRINCIPLE**, or to permit this **PRINCIPLE** to apply **ITSELF**, then the names of the sponsors will be revealed.

We now apologize to **PRINCIPLE**, and to Col. Charles A. Lindbergh, and to the American People, if we have appeared to exalt the person of Col. Lindbergh above **PRINCIPLE**. All men who are, and shall be connected with this movement shall be capable of doing so only in so far as they have identified themselves with **MOVING SUBSTANCE** and **POWER**. We believe that Col. Lindbergh is capable, and will become capable, of throwing himself with others into **ESSENTIAL ACTION** in our social living and being. Col. Lindbergh has placed himself before the public. He remains there. We of these **Clubs** continue to see him there. We recommend to you the article entitled "Lindbergh Today" in Scribner's Commentator for August. This article appeared entirely independently of this **Club**. It is, of course, impossible in 1940 to put anybody into the presidency on any but the usual run of issues. Our concrete objectives will reveal themselves step by step as we approach 1944, and before.

Be patient! We have an economic and political system concretely prepared. We are not presenting that system now. Since it is for a short time from now, it is not for today. Therefore, today we must know what we know or can know now, and do what we must do and can do now. As we do in the successive nows what we must do, we shall find that each thing done is already a part of that which is the culminating plan that has not been presented. More and more we shall see it arising out of the natural, logical, steps we accomplish.

Trusting, dear friend of the **Club**, that we have for this particular now fully carried out our obligations to the country to make ourselves known, and assuring you that we wish to lay bare before you the very **SUBSTANCE**, **ENERGY** and **NAME** of the **ACTION** of **ESSENCE** within us, we remain,

In accordance with our practice of noting the vital truth in all ideas, practices and programs, we recommend, for careful study, the articles, in the Commonwealth magazine for September, on the Finished Products Single Tax, and on the Ad Valorem Property Tax and what it is doing in our system. These articles arose independently of our **Club**. We urge you at least to keep these subjects in mind in order in the future to note their essentially close relation within the inclusive objective order we shall present.

Our November letter will be primarily an organization letter. It will be devoted to give you some simple rules and procedure for establishing yourselves as clubs in the **Solution for All organization**. The letter will also outline the first of our practical steps in the building up of our economic and political structure. The November letter will be very important. Do not miss becoming an active worker in this movement at once. If for any reason you fail to get the November letter, be sure to notify us.

Begin at once to get a number of our letters already issued, and to distribute them; and you will find in the next letter how you have thereby already established a **Club**. If you have not received our August-September letter, do not fail to send for it. It contains many full statements on the fundamental attitude of this organization—on how to see the truth in capitalism, the truth in communism, and the truth in totalitarianism; how to make them the whole truth. If you have not circulated last month's letter, then send it out with this one. Send at least to each letter. Take it upon yourselves to send them to those progressive individuals and groups you wish to organize, or that you think will organize themselves.

The price of these letters is one cent (1c) each for one hundred or more, one and a half cent (1½c) each for ten (10) to ninety nine (99), and three cents (3c) each for any number less than ten (10).

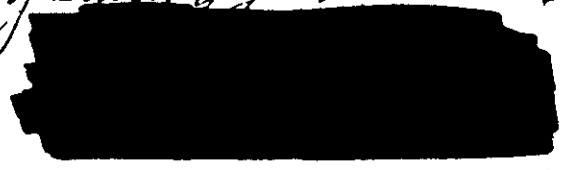

Lindbergh View Of U. S. Mission Wins Acclaim

Landon, Amos Pinchot and 62 Others Indorse Call to 'Build Strength at Home'

Amos R. E. Pinchot, lawyer, of 101 Park Avenue, issued a statement yesterday at his office announcing that Alfred M. Landon, Republican candidate in 1936, and sixty-two other widely known Americans were indorsing a paragraph taken from Col. Charles A. Lindbergh's article in last week's issue of "Collier's" magazine as "a call to the American people and a clear definition of America's highest duty in the present international crisis."

The paragraph, which Mr. Pinchot called "an inspiring statement," follows:

"If we desire unity and strength among our people, we must turn our eyes back from these everlasting wars of Europe—back to our own country, to the clear horizon of a great American future. Let us learn from the errors made by the democracies abroad and not repeat them. Let us give thanks to the generations of Americans before us who won and maintained the independence of our nation against far greater dangers than we face today. Let us dedicate ourselves to guarding that independence that we may pass it on to the future in even greater security than we received from it in the past. It is by building our own strength and character at home—not by crusading abroad—that we can contribute most to civilization throughout the world."

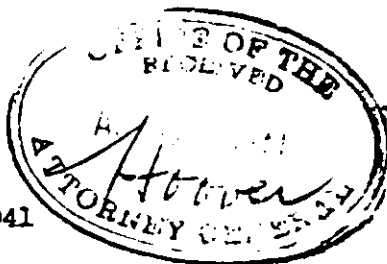

Lindbergh Thinks England and France Were Whipped Before War Started

CHICAGO, April 18 (AP)—Col. Charles A. Lindbergh believes that England and France were vanquished before they began to fight and that Britain cannot win even with all the resources of the United States.

His opinion that a Nazi victory was an accomplished fact was expressed last night in an address delivered at a rally sponsored by the America-First committee.

Making an appeal for unity among those groups which oppose U. S. intervention in the war, Lindbergh asserted that a minority has led the nation toward war "through misinformation and confusion of the issues involved."

"War is not inevitable for this country," he said. "The claim that our participation is inevitable is simply propaganda by those who want to get us in."

"We must face the fact that England is in a desperate position," he continued. "Up to date she has lost every major campaign in which she has participated. Her shipping losses are of the utmost seriousness, and her cities have been devastated by bombs. x x x"

"Personally, I believe it will be a tragedy to the world—a tragedy even to Germany—if the British empire collapses. But I must tell you frankly that I believe this

It was I who referred The Chicago Times to an article in the Saturday Evening Post, about two months ago, in which Lindbergh excused himself about the medal. This article sounded to me as if he had it published. It stated that he was no longer with the government. I thought it terrible that you should be blamed for his resent-resignation. This, I felt, was to turn many people against you.

In this article Lindbergh extolled Ford's DICTATOR-LIKE methods. I believe he is working under Ford.

This article said that he "was on his own" when visiting the various air-fields in this country.

Ford, as you know, publishes a very anti-semitic paper. I have also seen it hinted in an article that he is contributing heavily to organizations spreading this kind of literature.

Sometime ago, I heard Walter Winchell state over the radio that one of the head men in Ford's plant is a Nazi. "This", he said, "is for the interest of anyone concerned."

Who knows but that, if there have been leaks in our designs, that they may be the ones who are guilty. I believe that Lindbergh should not be allowed on the fields and no secret models of any sort should be entrusted to the Ford plants until further check-up by the proper persons. This, of course, is merely a suggestion and a surmise. With all Ford's money, if he were so inclined, he could take advantage of all the strikes and PAY people to strike. I think the secret service should make a check-up.

By the way, where did he hide that ten million dollars in gold at the time the government called it in? Did he ever return it to this country? If, by any chance he might NOT BE a loyal citizen, why is he allowed to have so much money? Why not get together with Canada who threatened long ago to take over his factories unless he produced needed armaments for the government?

As I stated in a previous letter, I am not in a position financially to give all my time but I want to do everything I can to help.

By letter dated April 13, 1941 Mr. Harry L. Hopkins submitted to the Attorney General an anonymous letter which was addressed to him and postmarked Cincinnati, Ohio. This letter was submitted by the Attorney General to the Bureau for appropriate examination in the Technical Laboratory. The evidence was received in the Laboratory on April 19, 1941 for document examination. The original evidence submitted is listed on the attached sheet.

Specimen Q1 is a white bond envelope bearing one cancelled 3 cent Thomas Jefferson postage stamp. The address on Q1 has been written on a typewriter. Q1 measures 9.50 inches in length by 4.28 inches in width by 0.0043 inches in thickness, weighs 5.770 grams and contains no watermark.

Specimen Q2 is a white sheet of onion skin paper bearing a message that has been written on a typewriter. Specimen Q2 measures 10.98 inches in length by 8.50 inches in width by 0.0020 inches in thickness, weighs 1.830 grams and contains no watermark.

Specimens Q3 through Q9 are white sheets of onion skin paper and all bear a message that has been written on a typewriter. The physical characteristics are similar in all respects to those of specimen Q2.

The specimens were also examined for latent fingerprints and nine such impressions, suitable for comparison purposes only, were developed.

appearing in the current specimens were not found in any of the letters in this file. A photographic copy of the typewriting appearing on specimens Q1 through Q9 will be added to this file and in the event of any future identification you will be so advised.

It was concluded that specimens Q1 through Q9 were written on a typewriter that was equipped with Underwood Pica type, spaced ten letters per inch. No conclusion could be reached as to whether specimen Q1 was written on the typewriter which was used to write specimens Q2 through Q9 due to the fact that specimens Q2 through Q9 are carbon copies and therefore any defects in the type have been eliminated in these particular specimens.

The original evidence submitted is being retained in the files of the laboratory.

Remember your post card has to fight against the Time, Life, March of Time Fortune, Collier, Liberty and recently Newsweek. each have a circulation of more than 500,000 readers, but your post card can save America if million of them pile up on the desk of the Warburgs they will be panicky because they are yellow rats, proof not calculated are each step planned toward the abyss. If possible copy at least part of this message and send it to somebody else with request that himself it does some.

Don't be a cattle driven at the slaughter house for England.

Fellow Americans England is telling you that if she is defeated we are next... what a lie... as you know France is beaten and entirely defeated nothing prevented Hitler to take over the whole country in fact at the time of armistice he had whole of France in his hands, but voluntarily he evacuated 2/5 of France territory, within the limit of the evacuated territories are next after Paris the France's two largest cities: Lyons and Marseilles - may I ask you why Hitler do not take first the whole France before attempting to take over New York, Chicago or Denver.

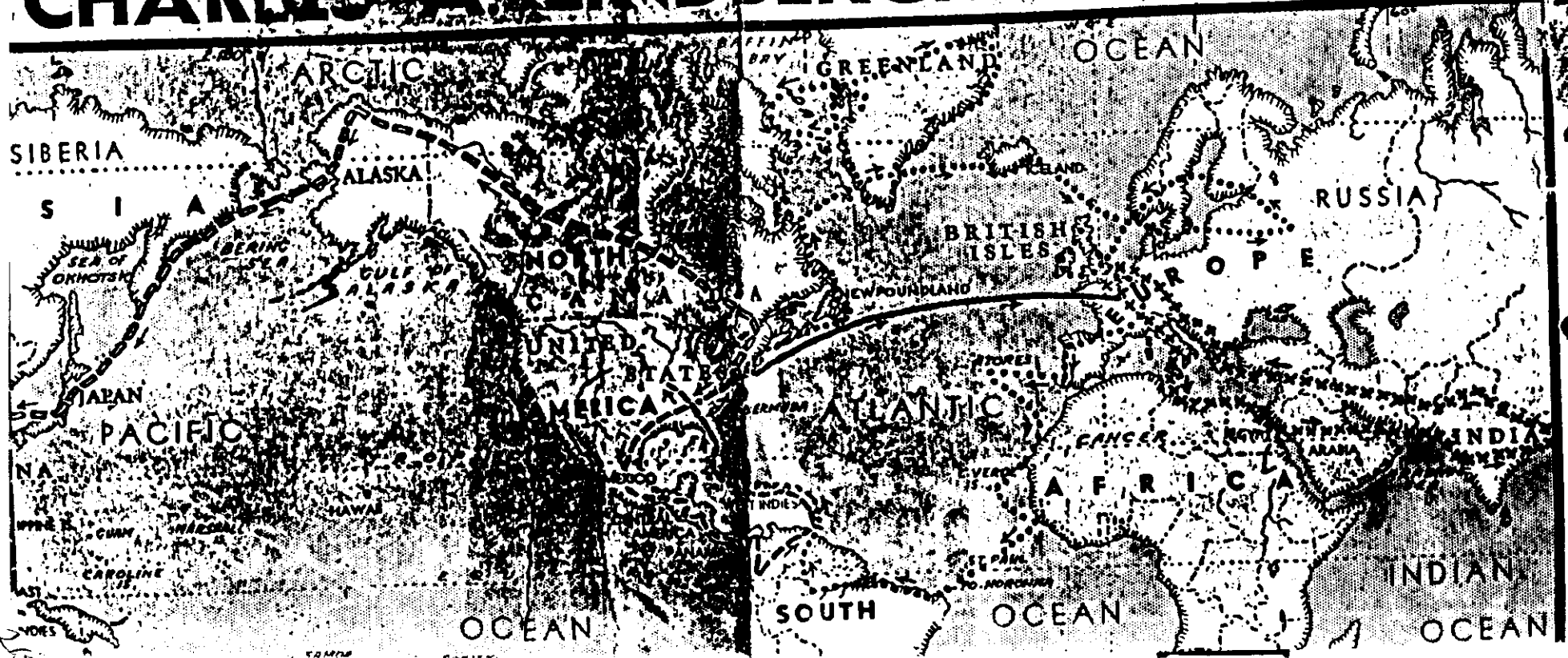

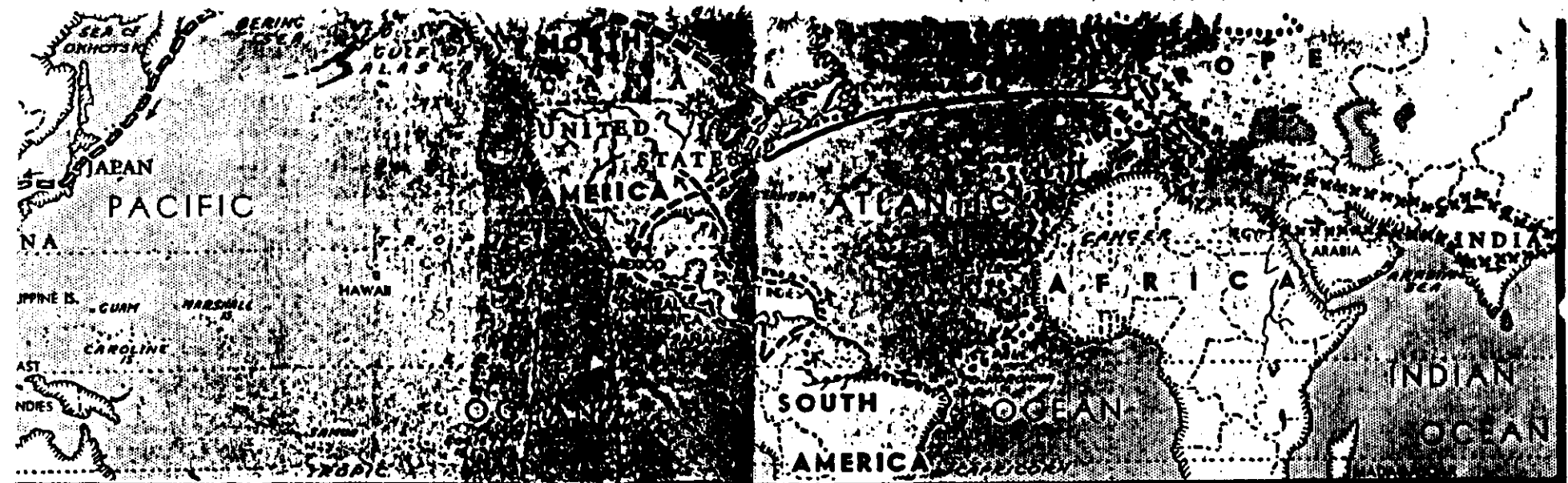

The following information was received at the Bureau from an unknown outside source.

It is reported that Col. Charles A. Lindbergh is a candidate for the Fuehrership of the United States and that Fifth Columnists are rallying under his name. It is said that the Christian Fronters in the East, the Silver Shirts in the West, the Ku Klux Klan down South and other so-called storm-troop bands are indicating that Lindbergh is their man.

The latest issue of the Wichita, Kansas, newspaper, "Publicity", alleged mouthpiece of Dr. Brinkley, Edward James Smythe, Gerald B. Winrod and other so-called United States Fascists sets out:

"Colonel Charles A. Lindbergh, by his courageous stand against 1776 may prove to be 'this nation's man on a white horse.' Just the individual to ride roughshod into the nation's capitol in 1944. He would become another Honest Abe - the long looked for Lincoln of this day and age - an emancipator of the Jewocratic slaves of the 20th century.

"What this nation needs and needs badly, is another Honest Abe Lincoln in the White House - it was President Lincoln who emancipated the negro race from slavery in 1863. Dear Mr. Hoover,

While I have my doubts as to whether this letter will ever reach your hands, I cannot resist the temptation to write. Being as light-headed as the next college student, I have got to put in my two cents, and as long as this is still America, that's exactly what I'm doing.

Lindberg raised a very big furor over whether or not he was in sympathy with the Nazi government. I don't think so, but I do think they have some hold over him, and that hold his son. This is what I'm blabbing about: His son was suddenly kidnapped, out of a clear sky, without even a warning, by a German. What was supposedly the boy's skeleton was found and identified. Hauptmann took the rap.

I claim that the Germans kidnapped the boy, took him to Germany, and substituted the skeleton of another boy in his place. Crazy, isn't it? But you can't stop crackpots like me from theorizing. My reasons? 1. The kidnapping was done by a German, who made a very feeble defense.

On the evening of May 29, 1941, Colonel CHARLES A. LINDBERGH, United States Senator DAVID I. WALSH and novelist KATHLEEN NORRIS were the principal speakers at a meeting of the America First Committee at the Arena in Philadelphia, Pa.

Transmitted herewith is a clipping from the Evening Bulletin, Philadelphia, Pennsylvania, dated May 30, 1941, concerning this meeting and a leaflet which was passed out at the meeting.

The meeting was attended by Special Agents R. J. UNREINER, N. S. HARZENSTEIN, W. B. CALDWELL, and G. P. FOPP of this office. Although the meeting was scheduled to begin at 8:30 p.m., the Arena was filled to capacity at 7:00 p.m., and by 8:30 p.m., there were about five thousand people listening to a loud speaker in an adjoining lot and in the streets.

The speakers made quite a point of the fact that the national radio companies had refused the facilities of their broadcasting systems for a nation-wide broadcast of the meeting and stated that everything possible was being done to prevent the America First Committee from presenting their views to the American people.

The Agents observed no disorders or fights, and the meeting was orderly, though enthusiastic.

The crowd cheered the talks given by LINDBERGH, Senator WALSH and KATHLEEN NORRIS, and each time the President's name was mentioned a loud boo went up from the crowd.

Lindbergh Demands U. S. be told where it is Led

Arena Throng Hears him say President's Suggestion
on Hemisphere Defense would Cause War
that might Last for Generations

Philadelphia foes of intervention jammed the Arena and its adjoining parking lots last night to hear and wildly applaud the militant demands of Charles A. Lindbergh that the United States keep out of Europe's war.

It was a crowd—estimated by police at more than 8,000 inside the sports center and half that many outside—that booted every mention of or reference to President Roosevelt either by Lindbergh or the other featured speakers, U. S. Senator David I. Walsh (D-Mass) and Kathleen Norris, novelist.

The crowd gave unmistakably complete endorsement of the isolationist principles of the America First Committee, under whose auspices the rally was held, and also lustily booed every reference to England.

It was a crowd preponderantly middle aged and with women outnumbering men two to one. For every man wearing a hat and coat, there was one bareheaded and shirt-sleeved; for every modishly dressed woman there were two whose dress bespoke modest circumstances.

Points of Address

Wildest of the demonstrations were those when Lindbergh:

1. Demanded that "our national leaders tell us where they are leading us . . . and what their intentions are about this war."

2. Termed the philosophy of the interventionists "a philosophy of failure."

3. Charged that if the President's suggestion of Western Hemisphere defense is followed "we will start a war between the hemispheres that may last for generations."

4. Declared that the security of this country lies in the strength and character of our own people and not in fighting foreign wars.

5. Asserted that the America First Committee, with the support of the people, "will keep this country out of war and create a leadership for our Nation that places America first."

The course of the leadership he advocated, Lindbergh said, is toward success and not failure.

Impregnable Defense Sought

"The America First Committee stands for an impregnable defense, a fully informed, free and self-reliant nation and a destiny for America that is independent of these everlasting wars in Europe," he declared.

"We believe in the right of free speech. Every citizen has the right to state his honest opinion. Speech and thought are not yet suppressed in this country.

"We believe in the right of the vote, that every citizen should have the right and the opportunity to vote

on the policy of his government; especially on a policy which involves his laying down his life in war.

"We do not feel that our citizens were given this opportunity at the last election. The issue of peace and war was not honestly presented to us at that time. And now, in the hour of decision, we stand for the right of a free people to make its choice of war or peace.

Records of Interventionists

"It would be interesting to trace the personal records of the interventionists through the years preceding this war.

"I would like to know, for instance, what they were doing while Germany was invading and while the flighted Lion was being built. I would like to know where they were when I was addressing a group of air men for America and England. In those days, when there was still time to have prevented this war, the people who stood so loudly now were hard to find.

Signs That Are the Same

"But, as I have said, reality has never seriously affected the interventionists of any country. The usual effect signs of declaring war on Hitler, they said, would be enough to bring victory. Tanks and airplanes and fortifications were incidental matters. They used the same arguments, the same tactics, the same propaganda in Europe in 1939 that they are using in America today. The interventionists had their way. Unfortunately, moral effect is not enough against steel and guns. Thousands of brave men died, and Poland fell—half to Germany and half to Russia.

"After that, there was still the possibility of a negotiated peace in Europe, but not so far as the interventionists were concerned. And by that time, our interventionists in America were shouting as loudly for the war to continue as were their brethren in Europe.

"France would never be secure with a negotiated peace, they said, and the very mention of peace showed that Germany was weakening. They were certain she could be blockaded into submission by the British and French fleets. Victory would be assured and war could be

always the demand for more assistance from America.

"I tell you it is time for our people to ask where we are going, to consider where our course will end. We are not children to be coddled into unpleasant situations. We are not the blind followers of a totalitarian regime. We are the citizens of a free country, a country governed by the people and for the people. We demand the truth from our leaders. We demand that they tell us where they are leading us. We demand that they stop all this vagueness and confusion, and tell us as free men should be told, what their intentions are about this war. We demand a philosophy and a policy that will lead to strength and success; not to submission and defeat.

Never mind realities, the moral effect will make up for our lack of preparation. Their prophecies have been false, their policies have failed, and their promises have been worthless.

"If you stand with us, we ask you to join our committee. With your help, we will keep this country out of war. With your help, we will create a leadership for our Nation that places America first.

"I am glad to be able to tell you that our strength is rising. Our membership is increasing by many thousands each day. Men and women in every section of this Nation are holding meetings such as we have held in Philadelphia tonight. In every State of the Union, we are organizing against war. But the

FBI Agents in Crowd

While the police detail of 270 uniformed men was the same as assigned to the Convention Hall gathering.

a squad of 25 Federal Bureau of Investigation agents circulated through the Arena crowd during the four-hour meeting.

A detail of detectives accompanied Lindbergh and his party to the meeting from their hotel and back and

stood close by while he was on the platform.
Also on the platform were more than 125 other men and women, including Mrs. Lindbergh, who smiled with a smile when invited to address the rally. Others were Mrs. Drew Thompson Murphy, assistant chairman of the Philadelphia chapter; Charles Wiling, treasurer; former Congressman Michael Pedersen; former Director of United Industries; Mrs. Lora Dwyer, the Rev. Thomas J. Blough, S. J., assistant pastor of the Church of the Good Shepherd; the Rev. J. H. Hutton, pastor of St. Thomas's Church, and the Rev. John J. Hagan, pastor of St. Peter's Church.

If we in America would only revise our Neutrality Act, and sell arms for cash to Europe. So the blockade was tightened, and the winter slowly passed. Meanwhile, Russia invaded Finland and the sinking of British shipping began."

In sarcastic vein, he reviewed at considerable length the course of the war since then, carrying out the idea that "interventionists" in Europe had insisted upon carrying it on. He dwelt upon the British defeat in Norway and the retreat from that country, the defeat in France and the British retreat from that country, and the

Negotiated Peace

"At that time, many of us who did not want to see England defeated advocated a negotiated peace in Europe. We realized how futile it was to carry on a war for which no nation but Germany had prepared. We knew that it would only send the best men of Europe to die by the hundreds of thousands, and that with each month that passed England would be in a worse position to negotiate than she was before.

"But the interventionists were still in control. Their personal reputations were at stake. Germany had over-extended herself, they shouted; famine and disease would spread through Europe and the conquered peoples would revolt. Russia would turn against Germany; the British navy would win in the end. But of course it would now be necessary for America to take a more active part in the war—we must send destroyers from our Navy; guns and planes from our Army and our air force.

"They attempted to stampede our people through hysteria and fear. If England fell our turn would be next, they cried. Our Nation of 130,000,000 people would be invaded like Luxembourg, Holland and Belgium. Our cities would be destroyed by non-existent fleets of trans-Atlantic bombers. German parachute troops would descend on the streets of New York. Our own President spoke of an air invasion from the Arctic wastes of Greenland, and of bombing planes over our cities of the middle west—bombing planes with speeds far exceeding any yet attained, even on the drawing boards of our greatest engineers.

Churchill Is Quoted

"During the winter of 1940 and 1941, the interventionists again told us that England was winning. It was Churchill himself who said that the British navy had the submarine menace well in hand, and that the Royal Air Force had already won the battle of the air. The interventionists points to the Italian reverses in Albania, Libya, and Abyssinia as proof that Germany was losing the war. But it was necessary for us in America to give still more assistance, they said. We must supply all the arms they needed. We must make our country into 'an arsenal for democracy' so that we could save the British Empire from defeat. We might even have to transfer part of our Navy to England, they told us, and possibly convey ships across the sea. But with our assistance, in sufficient quantity, they assured us, there could be no doubt that England would win the war. To think otherwise, they said, was fatalism.

"Then came the Yugoslavian episode. The interventionists hailed it with enthusiasm. It was the turning point of the war, they claimed. They told the people of Yugoslavia to fight, and they promised that the resources of America and England would carry them to victory. The Yugoslavians believed, and fought and died. Then came the Suez of Greece, and now it is Crete. Through the same story—our assist after another since the war began. And

into war... We are not the followers of a totalitarian regime. We are the followers of a free country, governed by the people and for the people. We demand the truth from our leaders. We demand that they tell us where they are leading us. We demand that they stop all this vagueness and confusion, and that all of free men should be told what their intentions are about this war. We demand a philosophy and a policy that will lead to strength and success; not to confusion and failure as in the past.

Philosophy of Failure

"The philosophy of the interventionists is a philosophy of failure. Nothing shows that more clearly than a study of their record in this war. They cannot point to the achievement of a single important success, either in America or Europe.

"And what are they doing today? Our own President says that the safety of America lies in controlling the Cape Verde Islands off the coast of Africa. From 1900

"If we take the attitude that we must control the islands of the Eastern Hemisphere, Europe has just as much reason to demand control of the islands of the Western Hemisphere. If we say that our frontiers lie on the Rhine, they can say that theirs lie on the Mississippi.

"Mr. Roosevelt claims that Hitler desires to dominate the world. But it is Mr. Roosevelt himself who advocates world domination when he says that it is our business to control the wars of Europe and Asia, and that we in America must dominate islands lying off the African coast.

"I have always been in favor of controlling the islands of our own hemisphere. It is less than two years ago that Administration supporters called me an imperialist for advocating such a policy. But islands lying off the coast of Africa do not belong to this hemisphere, and if we try to control them, we will throw the world into complete chaos by our attempt.

"The interventionists have forgotten their promises that all the steps they asked us to take were to be short of war. They now say that the only way for us to defend America is to cross the Atlantic Ocean and fight Europe; to cross the Pacific Ocean and fight Japan; to fight possibly Russia, Italy, France and Spain as well. They say that the only way we can defend democracy is by adopting the policies of a totalitarian state ourselves.

"They tell us it is undemocratic for us to question the type of leadership that has taken to defend every nation in the world that followed it. They shout to us, as they shouted at England and France; they say:

"I am glad to be able to tell you that our strength is rising. Our membership is increasing by many thousands each day. Men and women in every portion of this Nation are holding meetings such as we have held in Philadelphia tonight in every State of the Union, we are organizing against war. But the crisis is here. We need your assistance and we need it now. We ask you to help us organize. We ask you to write to your representatives in Washington, to tell them you are opposed to entering the war. This is a time for action, and it is only by action that we can succeed.

Although he spoke almost three minutes over the half hour time allotted him on Station WPTZ, 12.1, of that Station and Lindbergh, who kept on the air until he had finished his speech, who presided at the meeting, said the American First meeting had passed more than 2,000 resolutions and had elected a steering committee and a board of directors.

"The only thing that we have in Europe is the aid, 'are the rows on our lips'—the aid, making the graves of our boys that did not come back from another war."

Senator Walsh, chairman of the Senate Naval Affairs Committee, the last speaker, accused interventionists of urging upon America an implied or expressed alliance with Britain and the surrender of this Nation's peace.

"England and France," he said, "declared war on Germany without Germany being guilty of one provocative act against them. There has been no overt act of hostility manifested by either Germany, Italy or Japan against the United States."

"Eighty per cent of Americans want peace, not war. If you are of native stock and against war you are a democrat. If you are pro-British, foreign-born and for war, you are a patriot."

"Most of those who want war are too old to fight or have no children that will do the fighting."

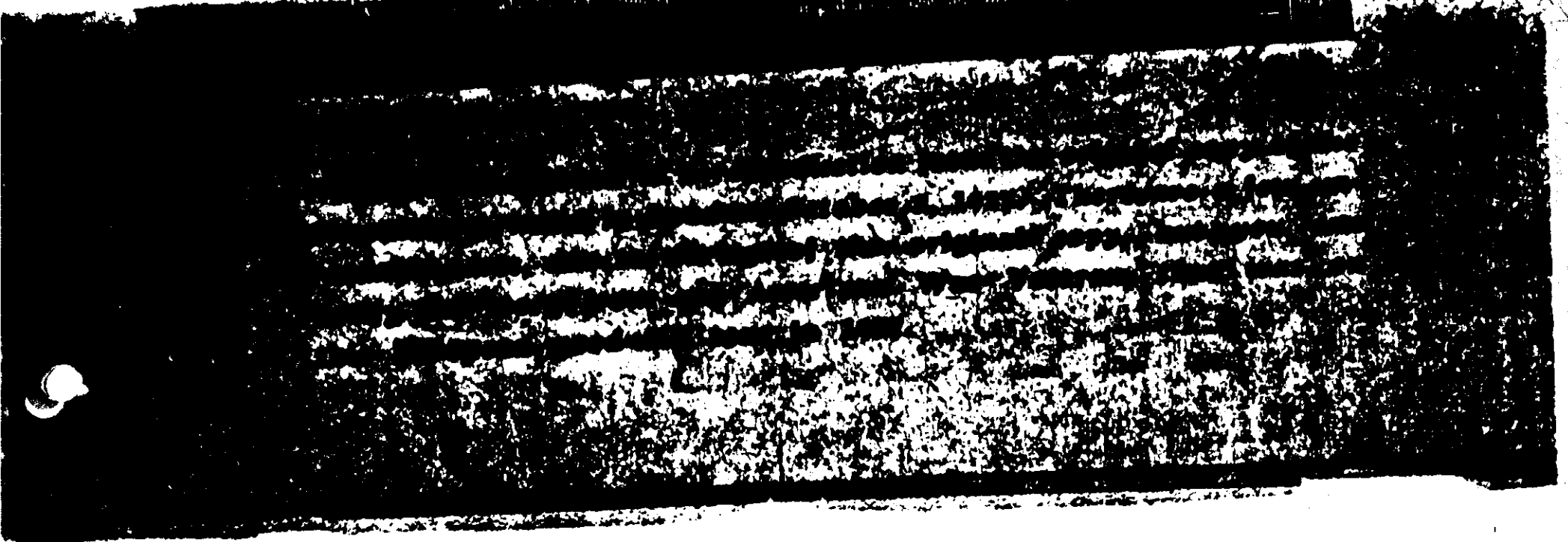

Outside the hall thousands of persons milled about. Inside, the speakers were frequently interrupted by Jew-baiting cries from the audience."

"Young boys and bespectacled elderly women sold copies of Father Coughlin's Social Justice (outside the hall) and did a good business. . . . (All the stops of sympathy were pulled when John F. (Jafsie) Condon, the go-between in the Lindbergh kidnaping case, got up from a second-row seat, mounted the stage and shook hands with Col. Lindbergh. . . . In a moment Col. Lindbergh was engulfed. He was rescued by detectives of the Alien Squad, a group of policemen assigned exclusively to the task of ferreting out un-American activities."

Demonstrations for which Lindbergh has been in no way responsible have also complicated the situation for those of us who wish to think straight. For example, this sort of headline is hard to take:

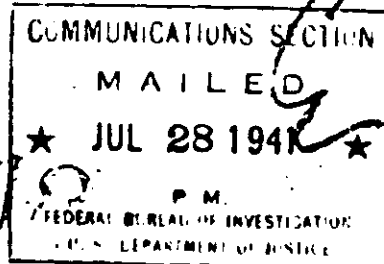

As I understand it, LINDBERGH was given some lessons in flying by one JOE LYNCH of Butte, Montana. They went on a barnstorming tour of the country and were stranded in Billings, Montana. While in Billings, LINDBERGH lived in the home of a prostitute for a considerable time and associated with the prostitute's pimp. There is a photograph in existence showing LINDBERGH with this woman and her pimp.

During his stay in Billings he tried to marry two different girls who were employed in a laundry. For part of the time he lived in a boarding house, and the register containing his name is still in existence. This boarding house was operated by an old lady, and LINDBERGH left Billings owing her a little over \$38.00 for room and board, which debt he still owes.

I was reliably informed that LINDBERGH should have been prosecuted on two different charges of bootlegging whiskey from Canada to Billings, Montana, by airplane. These charges, of course, are now outlawed by the Statute of Limitations, but I believe that it is still possible to obtain proof of the fact that he did bootleg this whiskey.

It is, to say the least, coincidental that LINDBERGH on his tour of the United States after his return from his flight to Europe, did not stop at Billings. JOE LYNCH, who is supposed to be a friend of LINDBERGH'S, called to see him somewhere while on his tour and was refused admission.

Dear Sir:

On May 26, 1941, MARVIN E. RUTHERFORD of Abilene, Texas, furnished this Office with information hereinafter set forth.

RUTHERFORD is a chemical engineer, an ex-service man of Company 348 of San Antonio, Texas. It should be stated, in a preliminary way, that RUTHERFORD claims patents on various technical developments. He has patented in 1941 a muffler for an airplane under the name of aero-silencer through KIMMEL-CROWELL, patent lawyers, Legal Building, Washington, D. C. Other patents include a front springs support for an automobile (1923), a non-corrosive battery terminal (1925), a radiator shield and fender brace (1924), a (disco-hydraulic) brake (1936), a commercial plow (1934). RUTHERFORD also claims the invention of, although not the patent for, the front end drive utilized by the now defunct Cord Automobile Company of England, the gear driven airplane propeller, and the bullet-proof or non-inflammable airplane gasoline tank. Some of the patented items have gone into actual production.

RUTHERFORD alleges that on April 22, 1939, he deposited in registered mail, a copy of the registration receipt being in his possession, the original plans for an aviation gasoline tank similar to the ones in use in the present conflict since the latter part of 1940. The sealing and mailing of the envelope were witnessed by PEARCE ROGERS and JACK BLAKE of Abilene, Texas. No return receipt was requested. The envelope was addressed "Colonel CHARLES A. LINDBERGH, c/o HENRY ARNOLD, Commander-in-Chief of the Air Corps, Washington, D. C.". At that time LINDBERGH was chairman of the New Device Committee. RUTHERFORD has in his possession photostats of the plans sent at that time. There were just two photostatic copies of the plans made, and RUTHERFORD has both of them. They were photostated by the Blueprint Company, Pine Street, Abilene, Texas.

RUTHERFORD thereupon left for California to experiment on the above mentioned airplane muffler in the Lockheed Laboratory at Burbank. While in California RUTHERFORD found in a copy of the May, 1941, Los Angeles Examiner, a daily newspaper, an article written by HENRY ARNOLD, Commander-in-Chief of the United States Air Corps. The article described an airplane gasoline tank found on a German plane shot down in England. It was said to be a bullet-proof self-sealing gas tank. These tanks, RUTHERFORD states, have been in American production during the last 90 days only. ARNOLD stated in the article that at that time, May 3, 1940, the United States did not have a self-sealing gas tank. According to RUTHERFORD, subsequent to that time, all United States military planes have been fitted with tanks of this type.

RUTHERFORD has not received an acknowledgment of the plans he forwarded to Colonel LINDBERGH. He believes that because the design of the tank mentioned in the article of HENRY ARNOLD'S corresponds with that of the plans forwarded to LINDBERGH that the latter may have given the plans to a foreign government. He does not believe that this is a mere coincidence of the development of these tanks simultaneously in Germany and the United States. Up to the time of Major ARNOLD'S article the United States, he says, did not have such a tank. He said that he had not patented his self-sealing gasoline tank because this would expose the principle of its design to anyone who would consult the records of the patent office and as a patriotic citizen he wanted the benefit to inure to the United States Government.

RUTHERFORD declares that various attempts have been made by unknown individuals to "shake down" his premises to obtain information relating to his military inventions. However, these would have been unsuccessful as to the tank because the plans were kept at another place. He said that his mailing of the letter to LINDBERGH had been occasioned by just such a "shake down" and the fear that some foreign agent would obtain the plans. No one in collaboration with RUTHERFORD knew of the principle of this development.

RUTHERFORD states that he communicated with the Honorable FRANK KNOX, Secretary of the Navy, eight months ago in regard to this matter. He received a reply that after investigation there was no evidence that plans for such a tank had been forwarded to his Department by CHARLES A. LINDBERGH. RUTHERFORD has a copy of both of these letters. RUTHERFORD further advised that the situation was communicated to ED WISHCAMPER of the Abilene Reporter. WISHCAMPER contacted a representative of the DIES' COMMITTEE, name unknown, but nothing of this Committee's investigation is known.

RUTHERFORD declined to give his home address but advised that he could be contacted through Mr. ROGERS of the ROGERS Grocery Company, Abilene, Texas.

MEMORANDUM FOR THE ASSISTANT TO THE ATTORNEY GENERAL
MR. MATTHEW F. McGUIRE

On May 26, 1941, Mr. Marvin E. Rutherford of Abilene, Texas, who described himself as an ex-service man of Company 348, San Antonio, Texas, a chemical engineer and inventor, called at the Dallas, Texas, Field Division of this Bureau and advised that among his other inventions he had perfected the bullet-proof or non-inflammable airplane gasoline tank.

In this connection, Rutherford claimed that on April 22, 1939, he sent the original plans for a bullet-proof, non-inflammable airplane gasoline tank similar to the ones in use in the present European conflict since the latter part of 1940, to Colonel Charles A. Lindbergh, c/o Henry Arnold, Commander-in-Chief of the Air Corps, Washington, D. C. These plans were reportedly sent to Lindbergh because he was Chairman of the New Device Committee. Rutherford states that he presently has in his possession photostats of the plans mailed to Mr. Lindbergh on April 22, 1939, and further alleges that these documents were sent by registered mail, the copy of the registration receipt being now in his possession. Rutherford also contends that the sealing and mailing of the envelope containing these documents were witnessed by Messrs. Pearce Rogers and Jack Blake of Abilene, Texas.

Subsequently while residing at Burbank, California, Rutherford read an article in the May 3, 1940, issue of the Los Angeles Examiner, written by Henry Arnold, Commander-in-Chief of the United States Air Corps, describing a bullet-proof self-sealing gas tank found on a German airplane shot down in England. According to Rutherford, the article written by Mr. Arnold stated that at that time the United States did not have a self-sealing gas tank. However, Rutherford reported that tanks of this nature had been in American production approximately ninety days prior to his visit to the Dallas Office of this Bureau and at the present time all United States military planes are being fitted with tanks of this type.

Continuing, Mr. Rutherford stated that he has never received an acknowledgment of the plans he forwarded to Mr. Lindbergh. Rutherford expressed the opinion that Lindbergh may have transmitted his plans to a foreign government. He stated that the development of these tanks simultaneously in Germany and the United States is something more than

a mere coincidence. It is noted that Mr. Rutherford advised he had not patented his invention because this would expose the principles of its design to those who cared to consult the records of the Patent Office and further, being a patriotic citizen, he wanted the benefit of his work to inure to the United States Government.

Rutherford also asserted that various attempts have been made by unknown individuals to "shake down" his premises to obtain information relating to his military inventions. It was because of this and the resultant fear that some foreign agent would obtain his plans that he forwarded them to Mr. Lindbergh.

Mr. Rutherford recounted that he communicated with the Honorable Frank Knox, Secretary of the Navy, about nine months ago in regard to this matter and received a reply that after investigation there was no evidence of the receipt of the plans for such a gasoline tank by the Navy Department from Mr. Lindbergh.

For your information, Rutherford claims to be the owner of several patents in the technical field.

In view of the allegations made by Mr. Rutherford, it would be appreciated if you could advise this Bureau what action, if any, should be taken in this matter.
