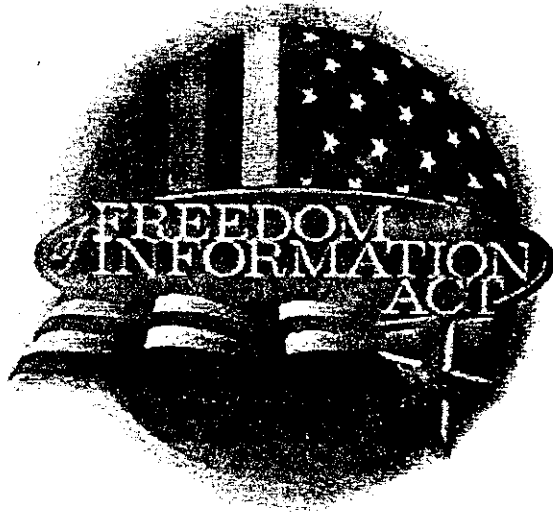

Enclosed for Chicago is one photocopy of a two page letter and envelope addressed to GRAHAM, and one copy of an FD-302 reflecting interview with GEORGE WILSON.

On 1/6/81, GEORGE WILSON, Executive Vice President, Billy Graham Evangelistic Association, 1300 Harmon Place, Minneapolis, Minnesota, telephonically contacted the Minneapolis Office of the FBI with information that a threatening letter had been addressed to WILLIAM FRANKLIN GRAHAM at the Association's headquarters address. The contents of the letter were threatening toward GRAHAM, as well as other individuals.

George Wilson, Executive Vice President, Billy Graham Evangelistic Association, 1300 Harmon Place, Minneapolis, Minnesota, telephone 338-0500, was contacted at his place of employment, furnished with the official identity of the interviewing Agent and with the nature of the interview. Wilson subsequently furnished the following information:

The Billy Graham Evangelistic Association on January 5, 1981, received a letter addressed to Mr. William Franklin Graham. Graham is identical to the Evangelist Billy Graham, and the Minneapolis based Billy Graham Evangelistic Association is the national headquarters for Graham's organization. Occasionally Wilson's office does receive threatening type letters but they are somewhat of a rarity. This particular letter was of some concern to Wilson, in that it implied threats to Graham and other individuals. Because Graham and one of the other individuals mentioned in the letter, Frank Sinatra, are both involved in the January 20, 1981, inauguration ceremonies of President Elect Reagan in Washington, Wilson advised that he reported the receipt of this letter to the U.S. Secret Service in Minneapolis, as well as the FBI.

b7C The name [REDACTED] is unknown to Wilson and the Billy Graham Evangelistic Association.

Wilson pointed out that because the letter was addressed to William Franklin Graham, the writer may possibly be from the southern part of the U.S., in that it is a common term of address in that part of the country. Graham was born in Charlotte, North Carolina, and currently resides in Asheville, North Carolina.

The envelope containing the threatening letter was handwritten and addressed to Mr. William Franklin Graham, 1300 Harmon Place, Minneapolis, Minnesota 55403. The envelope which contained no return address contained a postmark of Chicago, Illinois, which was dated January 2, 1981.

The two page letter was handwritten on the reverse side of a photocopy of two different articles which appeared in Life magazine with handwritten notations on April 26, 1943, and May 24, 1943.

The following is a verbatim of the two page letter:

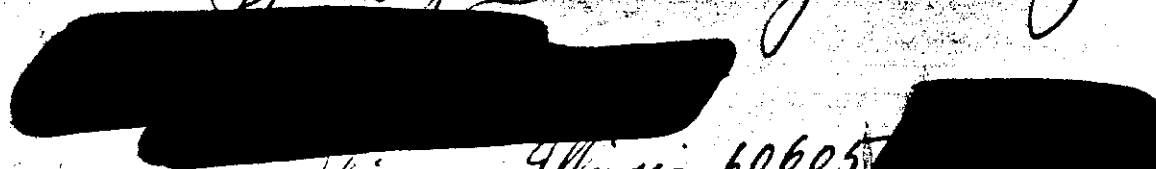

ASPARAGUS AND THE DUKE

Windsor visits his Bahamian subjects at New Jersey

While his Duchess went shopping in New York last week, the Duke of Windsor in his capacity as Governor General of the Bahama Islands, dropped in on his subjects at Swedesboro, N. J. The 214 Bahamian Negroes, recently to help with U. S. crops, sang *God Save the King* twice as the Duke to Farm Security Administration camp. They told the former King that they care for the strange food or the stranger climate, but did hire the high wages. Then the Duke doffed his bowler hat and smart topcoat, walked the muddy fields where he learned how to cut asparagus and how to pack (left). He even brought some stalks home to the Duchess and the Wallis

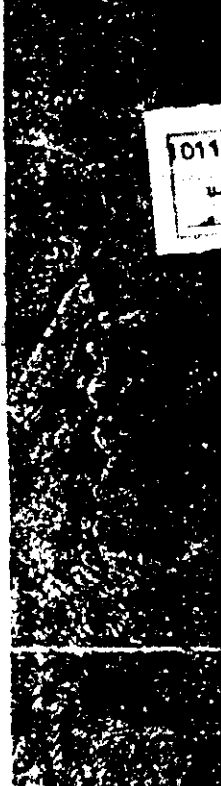

BAHAMIANS ARRIVE FOR FARM WORK

In Washington last week the Senate passed a bill appropriating \$20,000,000 to establish a "land army" to help in the production and harvesting of this year's crop. In Miami new recruits for this wartime farm army were arriving by plane and ship from the Bahama Islands. The Bahamian Negroes, enlisted in Nassau by the U. S. Agricultural Labor Administration, were immediately settled in huge migratory workers' camps among the Everglades and put to work picking Florida's ripe bean and sugar-cane crops. While the Bahamians, most-entitled in the latest Har-

lem Bahamians, were pouring into Miami at the rate of 375 a day, labor officials charged that 500 U. S. families secretly brought from the mid-South to Florida were being returned to their homes. Nevertheless, the Department of Agriculture is going ahead with plans to import as many as 4,000 Bahamians and later 11 two Jamaicans on a for-the-duration basis. During the last war, too, several thousand Bahamian Negroes were temporarily moved in to supplement the nation's depleted labor supply. Many of them decided to remain, and immigration officials are still chasing them.

And the next worse is the one who would ignore it.

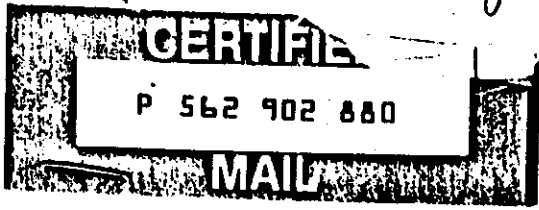

On 5/13/85, AUSA ROBERT FETTWEIS, District of New Jersey, was advised of the threat made by mail by [redacted] and the results of her interview. He declined prosecution for lack of evidence. Based on AUSA FETTWEIS's opinion, Newark considers the captioned matter closed.

On 5/22/80, [redacted] Intelligence Unit, Atlantic City Police Department, transferred this material to SA [redacted] ARA, and advised that prior to his receipt of same it had been handled by an unknown number of people at the hotel and police department. WI was the addressee, probably as a result of that hotel's promotional advertising of a forthcoming SINATRA appearance at Atlantic City's Resorts International Casino/Hotel. This ad was also included in the Reading, Pa., newspapers, during the early part of May. It is noted the enclosed envelope is postmarked May 12 at Reading, Pa. Reservations Office on their out-of-state 800 number. On those occasions, the caller did not speak but only played SINATRA music in the background. SINATRA performed at Resorts last weekend without incident, and will again appear this weekend, May 30-June 1, 1980.

On 5/27/80, Mr. MURRAY MYRON, Bureau Consultant in Psycho-linguistics, was contacted. His observations support the possibility that the originator of the threat may also have sent similar letters to the President.
