Sinatra Ties Can To 'Clan'

Frank Sinatra wants out from under that "clan" tag used as a description, mostly by columnists, in referring to professional and private associations of such cronies as Peter Lawford, Sammy Davis Jr., Dean Martin, etc., etc. Singer-actor made move to bury the tag yesterday in a statement which said:

"As far as I know, the various guilds that are part of my professional life are the only organized groups to which I belong. 'The clan' is a figment of someone's imagination. Naturally, people in Hollywood socialize with friends as they do in any community, but we do not gather together in childish fraternities as some people would like to think. Life magazine coined the phrase, 'The Clan,' in an article, and it stuck with everyone except the people who are supposed to belong to it. There is no such entity as 'the clan' and there never has been. I am fortunate to have many friends and many circles of friends, but there are no membership cards."

Term "clan," by Webster's definitions, is:

Pertains to: "1. A race; a family; a tribe; an association of persons under a chieftain. Among the Highlanders of Scotland, a clan consisted of the common descendants of the same progenitor.

"2. (Still with Webster): A clique, sect, society, or body of persons closely united by some common interest or pursuit; in this sense used contemptuously."

Frank Sinatra's long, earnest deliberations into entering the recording business with an eye on buying an established label is continuing. Some time back he reportedly was thinking of bidding for Norman Granz' Verve Records. As yet nothing concrete; nor is it too probable.

Sinatra's manager Hank Sanicola and attorney Milton (Mickey) Rubin have been holding weeklong pow-wows on various directions the singer could take. Rubin acknowledges Sinatra is mulling several possibilities in regards to buying a diskery. In fact, a number of labels have tipped Sinatra they are on the sales block.

As of now there are 16 different paths Sinatra can plod in making his administrative move into recording. One, quite likely, would be to expand his Essex company. By setting up his own distribution, etc. Sinatra already has several names under exclusive pact, such as Sammy Davis Jr. And it's understood that he's contacted other big artists about leaving their labels and swinging over to his—if he buys or develops one.

The big loss, of course, will be to Capitol which has garnered much green Sinatra disks. An added blow to Cap would be the exiting of other top names who are cronies of Sinatra. >

SINATRA NAMES KOCH PROD'N CHIEF OF ESSEX

Frank Sinatra has signed Howard W. Koch as executive producer of his Essex Productions indie film company which has just signed a \$15,000,000 multiple-picture deal

with United Artists. Koch goes to work immediately to develop projects for Essex's slate.

Koch continues as a partner in Schenck-Koch Productions which is now filming "Miami Undercover" teleseries for Ziv-UA, but will devote his time to the Essex Company.

Koch, 44, started his career as a messenger with Universal Pictures in New York. He came to Hollywood at 19 and worked as a film cutter and assistant director. Since 1952 he has produced more than 25 features and has had deals with Warner Bros. and UA.

Most recently he worked with Norman Panama and Mel Frank on "The Facts of Life." Koch's headquarters with Essex is on the Desilu Gower lot.

Aspects Of Deal

Sinatra's new deal reportedly represents a complete departure from financing pacts usually entered into by the distribution company.

Sinatra is not obliged, as first reported, to personally star in all of the pix, number of which could range up to six, depending on individual budgets.

The actor-singer-producer's company will be participating in a risk venture to the extent that UA agrees to budget on specific pic and puts up the money. Sinatra company's profit participation will depend, to begin with, on its ability to bring in film at agreed price. All things being equal at the box office, this, of course, will have direct bearing on earnings potential.

Sinatra reportedly will control negative ownership rights to UA for a period of 10 years, after which UA will have right to buy or sell, with Sinatra continuing to have a participation in distrib company's earnings from his pic.

Profit split is on a complicated sliding scale basis, so that reportedly, it is not possible at this time to peg it at any specific percentage terms. However, arrangement is said to be particularly beneficial to Sinatra if the pix click as expected.

It's understood that the time limit on the deal on Sinatra also is free to make arrangements for himself to be made by others than UA.

Sinatra To Produce Show For Kennedy Inaugural Ball

Washington, Dec. 1. — Although the President-elect's brother-in-law, Peter Lawford, will not be in the show, Hollywood will be well represented at the John F. Kennedy inaugural here.

Democratic National Chairman Henry M. Jackson said that among entertainers at the \$100-per-ticket inaugural gala Jan. 19 will be the Las Vegas summiteers (except Lawford): Frank Sinatra, Dean Martin, Sammy Davis Jr. and Joey Bishop. Sinatra also will produce the gala.

All Greek To Them

Running up against a blank wall in researching architecture and costuming for their independent production for MGM release, "Damon And Pythias," to be filmed in Italy, co-producers Sam Jaffe and Samuel Marx appealed to ancient history department at USC to clarify conflicts.

Although story takes place in 400 B.C., when Syracuse was under the domination of Greece, architecture in the locale was subsequently influenced by Carthaginians, Romans, Saracens, Normans, Spanish and Italians.

20th Reopts Colton

Contract of Trax Colton has been renewed by 20th-Fox executive producer Robert Goldstein.

Others who will perform include Shirley MacLaine, Harry Belafonte, Milton Berle, Nat Cole, Ella Fitzgerald, Henry Fonda, Gene Kelly, Juliet Prowse, Mahalia Jackson and Nelson Riddle orchestra.

Special material for the show will be prepared by Sammy Cahn and James Van Heusen.

The gala, to be staged in the National Guard Armory before a VIP audience headed by President-elect and Mrs. Kennedy and Vice President-elect and Mrs. Lyndon B. Johnson, requires an invitation before \$100 can be contributed to the Democratic National Committee, with the receipt serving as an admission ticket. It is a fund-raising stunt to doctor the big party deficit left over from the campaign.

Barron Hilton, prexy of Carte Blanche, is chairman of the gala committee, with Mrs. William H. Vanderbilt of Chestnut Hill, Mass., serving as co-chairman.

Miss Jackson will go down in current Washington history as a bipartisan entertainer. She is a favorite of outgoing President Eisenhower and sang on several programs for him at his request.

Sinatra himself will star in all the projects. To date no other players nor other creative personnel have been set, it is understood. Recently, Sinatra's Essex company leased space on Desilu Gower lot, where the films will be shot.

Currently, Sinatra is working in the Columbia pic, "Devil At 4 O'Clock," which Mervyn LeRoy and Fred Kohlmar are producing. It is believed Sinatra will be free to start prepping his new UA program immediately after windup of "Devil," or at least early in the new year.

SINATRA SETS GALA SHOWFOLK

Washington, Jan. 8.—Democratic National Committee has unveiled the first, comprehensive list of entertainers slated for the inaugural gala to be staged Jan. 19 by Frank Sinatra.

Names were given out after Sinatra and Peter Lawford, brother-in-law of the President-elect, arrived in town to begin on-the-spot arrangements for the huge affair counted on to wipe out the Democratic Party's \$2,000,000 deficit.

Mrs. Franklin D. Roosevelt will be onstage to introduce Fredric March for a dramatic reading from Lincoln. Program will open with "Stars And Stripes Forever" conducted by Leonard Bernstein, who'll also appear later in show.

Sinatra will welcome the notables, pay tribute to Kenney on behalf of show business and intro program's m.c., Joey Bishop.

The program's roster includes: Ethel Merman, who sang at President Eisenhower's last Inauguration; Milton Berle, Allan King, Jimmy Durante, Sidney Poitier, Sir Laurence Olivier, Peter Lawford, Anthony Quinn, Pat Suzuki, Janet Leigh, Tony Curtis, Gene Kelly and Juliet Prowse.

Singers scheduled are Helen Traubel, Ella Fitzgerald, Mahalia Jackson, Harry Belafonte, Nat Cole, Keely Smith, Louis Prima, and Kay Thompson, in addition to Miss Merman.

Writers of show are listed as Sammy Cahn, Norman Corwin, James Van Heusen, Leonard Gersche, Jack Rose, Mel Shavelson, Goodman Ace.

Sinatra has invited nation's 200 Medal of Honor winners and their families as guests of the gala entertainers. Others will pay \$100 for general admission.

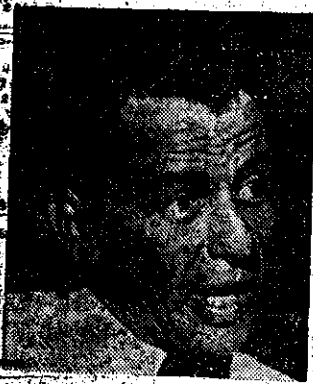

Mexico City.—Frank Sinatra, in his first professional appearance here, will raise more than \$45,000 for the Mexican Rehabilitation Institute in four benefit performances including an exclusive "April in Mexico" ball at the Hilton Hotel which was sold out a month ago at \$125 per person.

Coming here at his own expense (over \$10,000) with an orchestra of 20 including accompanist Bill Miller and conductor Nelson Riddle, Sinatra was met at Central Airport by more than 150 reporters, photographers and radio-TV men, while 200 attended his press conference at the hotel. His three-day schedule includes a private meeting with President Mateo.

the first amendment we don't have anything to be patriotic
about... the pending litigation by the much maligned Hollywood
Ten is just about the most important action ever attempted
as far as we are concerned... the anti-trust laws have been
carefully studied and with BEN MARGOLIS and DAVID SHAPIRO on

"the job, we can all be hopeful that they come out Victorious on this one...we will really have won a victory...

"How many people will remember what that it was back in 1947 that ten top, Oscar winning writers were dragged into court? It was T. NORMAN THOMAS who badgered them from one question after another.. investigating committees are forever investigating something or somebody and we've more than had our share...There was the Lusk Committee, the Dies Committee, Tenney and more recently Buras here in California... But T. NORMAN THOMAS was the WALTER of those days..always looking for a communist...late came Mc Carthyism to throw fear into the air... Mc Carthy must have been quite gratified to see THOMAS accomplish the imprisonment of ten top Hollywood writers...it probably gave him some new ideas for his witch-hunting.

"It was back in 1947 that the producers and directors got their heads together, with some outside help, I might add, and decided that no one with any communist ties or fronts could affiliate with the movie industry and this pertained especially to the writers..the final blow came when in April, 1950, TRUMAN announced that all security risks should be checked out and then the House Un-Americans took over...

"Since 1947 the air has been filled with fear and terror...filled with uncertainty as to how brilliant men could make a living to feed and clothe their families..they are not able to get work in their own professional field..writing award-winning scripts, but have had to resort to jobs in gas stations, restaurants, digging ditches and some have even had to resort to the lowest form..becoming salesmen.

"There is so much to be gained for all of the good Americans who have been deprived of their livelihood, if the suit against the studios is successful.

"GALE SONDERGAARD:

"I'm glad I belong to the present..I'm also very glad to be a part of the Past, in spite of having worked in 'Salt of the Earth' which has never been shown in the U.S. However, it is gratifying to know that the film has received praise in many foreign countries..Tonight, I have a surprise for you...a film made by the National Council of Arts, Sciences and Professions (film was ~~made~~ ~~in~~ 1950 ~~prior~~ ~~to~~ the Hollywood 10 leaving for jail, showing each man first as a mug shot and then embracing his wife and children..there were several shots of the House Committee hearings with THOMAS asking questions of the witnesses.)

"BEN MAROLIS:

"Well, I've never been in jail so I don't have that in common with the Hollywood 10, but I have lost more cases defending them..This litigation that is now under way is not going to be easy..first of all, we are up against a vast amount of money that will be used against us...we were fortunate in getting the services of DAVID SHAPIRO, who unfortunately wasn't able to be here tonight. But on the other side is an added advantage of political prestige.. because ex-Attorney General ROGERS is representing the studios..this will be his first civilian case since leaving the Government. However, working with me and SHAPIRO will be A.L. WIRIN and we are going ahead with optimism because there is so much to gain by a victory...we have carefully studied other anti-trust cases...providing we are successful, it will mean that all of our writers not just the Hollywood Ten, but approximately 300, will be able to get back to their jobs and shed the fear that has hung over them for so long...the House Un-American Committee should then be well silenced and no longer able to harass and continue the witch-hunts across our country...we simply must have room for dissents and that we will get...

"HERBERT BIBERMAN:

"Blacklisting has created fear in the hearts of many a family and because of the investigating committees, who are always investigating somebody, many of our most brilliant writers have had to serve prison terms...it is mighty hard to try to tell a youngster 8,10 or 12 years old, that his Dad is going to be away for a year..that he's going to prison because here in America he does not have freedom of speech.

"What is the answer? Certainly not KENNEDY...if he lives to be President for 100 years, he would have to prove anything he said 50 times and I'd only believe half of it. The CIA? Now there's an outfit that should be investigated (applause) and even the Supreme Court that used to be able to make decisions that were beneficial, have deserted us recently..the most recent example is WILKINSON and BRADEN...again we have two more victims of the Un-American Committee..with their incessant questions..Are you or have you ever been a member of the Communist Party? and if the witness says 'yes' then off to jail he goes...and if he says 'no' then they get him on a perjury charge and off to prison he goes...so you see, you just can't win, the way the rules are set up...unless you are in with the capitalist crowd...no one went to prison in the recent G-E case... the HUCA is setting up a regular thought-control operation... we don't object to having an indelible stamp inked on our beef to show that it is prime or top grade, but we do object to having a stamp put on our minds, always having someone else approve of what you say...this is not freedom of speech...and if there is anything worse than the black-market that has been created for those on the blacklist, I haven't seen it yet...

"Do you know, that some of our top writers get calls from producers offering \$50 a week...and they say, 'this will help to feed your family...you should remember that you are beholden to me'...these writers should demand that they be given the right to work...not blackmarket... the writers are the only ones who can work under assumed names, as many have done, but what can the actor or director do? He can't wear a mask...he is just trapped without a job.

"So in addition to fear, we have hysteria...the distributors who hold the whip-hand with every film that's made, are now going to control each film from the moment of its conception...

"A cold war, filled with fear, hysteria and hypocrisy... where the main weapon is not the sword but the big lie...for instance, MEISENBACH was released from charges made during the Un-American hearings in San Francisco...what did it prove? It proved that J. EDGAR HOOVER lied, that the committee lied and the film is a distorted mass of lies. We've had the greatest magnitude of lies from the CIA and from top officials.

"And I'll give you an example of a big name in Hollywood who had a writer do all of his writing and I'll even tell you who ghosted for this big-shot..it was JOHN HOWARD LAWSON...and by the time that a reputation was built up, did anyone every know who was responsible? Another big lie...and LAWSON can't even get a job to display his talent and get credits.

"My friends, you and I are the victims of this cold war and if there's any small flame of indignation within us, we had better start right now to put the pieces together, if we hope to have peace, otherwise, we will just have a pile of little pieces...What with the constant threat of nuclear war blasting us to bits, our most imperitive job right now is to take all the teeth our of the Un-American Committee by hoping that this legal action against the stuidos is successful...this would put J. EDGAR HOOVER, the F.B.I. and the HUAC in the dog-house for keeps.

"We don't want un-American activities, we want American activities and we'll get them... (standing ovation)

"Questions and answers--

"Q...How can we help on the law suit against the Studios?

"A. (MARGOLIS) See ROSEMARY LUSHER after the program, on the stage.

"Q. Will the blacklist writers have a better chance to work now that DALTON TRUMBO is working?

"A...(MARGOLIS) If we can win and we will do our very best, then, the harrassing witch hunts of the Un-Americans will virtually be brought to a grinding halt..."

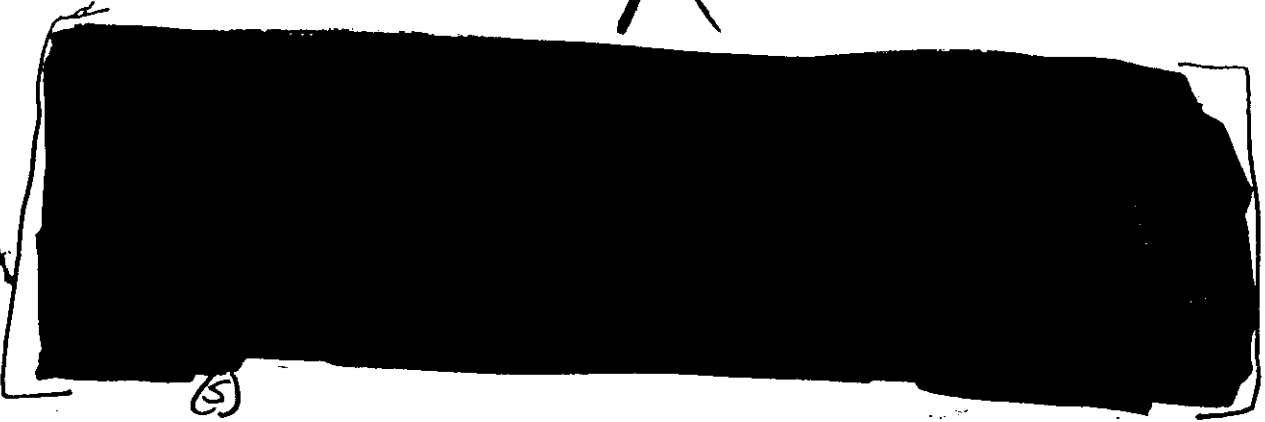

Sinatra Plans Reassemble Tommy Dorsey Band To Back Him In 'Swing Along' Pic

Frank Sinatra is planning to reorganize the old Tommy Dorsey band, with which he got his start as a name vocalist early in his career, for a new top-budgeted Essex Productions feature.

In an unusual switch, the singer is tagging film "Swing Along With Me," title of his new Reprise Records album. More frequently album titles stem from pix.

Sinatra will star in the film, a band story.

Meanwhile, Capitol Records, apparently caught with their pressings down, is rushing release of its Sinatra album, "Come Swing With Me" to dealers and distributed 2,000 copies in Los Angeles area yesterday. Lp was originally set for distribution July 31.

Reason for the rush is fact that Sinatra's own label, Reprise, will release on Monday album, "Swing Along With Me." Both albums are similar in cover design, with headshots of artist predominant. Both albums were arranged and conducted by Billy May, also a Cap contractee, and, songs are similar in period and vein. Capitol album was recorded March 20-22 under producer Dave Cavanaugh. Sinatra's Cap contract calls for but one more album. Reprise is singer's own company and has its separate distribution setup nationally.

Court Forbids Sinatra-Reprise Records From 'Sing'-ing Along With Cap Disk

Capitol Records won a Superior Court injunction Friday against Frank Sinatra, Essex Productions and Reprise Record Co. in a judgment handed down by Superior Court Judge Gordon L. Files which prohibits the defendants from selling, exploiting or merchandising the Reprise record, "Swing Along With Me."

Action was filed by Capitol July 14, when both that diskery and Reprise announced the release of extremely similar albums, both featuring Sinatra, with arrangements and orchestrations by Billy May. The Cap disk is titled "Come Swing With Me," while Sinatra's Reprise waxing is titled "Swing Along With Me." Judge Files commented, "This is a classic example of unfair competition."

Although thousands of the Re-

prise disks are in the hands of dealers, the order forbids the manufacture or sale by distributors to dealers in its present form.

Sinatra is still under contract to Capitol and, according to Alan Livingston, Cap veepee, "must record additional albums for our label until his contract expires." Sinatra, however, can record for other labels under the terms of his contract. Dispute in this instance rested on the fact that Sinatra and his subsidiary companies, Essex and Reprise, made use of knowledge of his Capitol recordings to record a similar album.

Suit charged Reprise and the other named defendants, with breach of trust and confidence, unfair competition and wrongly interfering with Capitol's business relations.

Order to desist from manufacture and sale of "Swing Along With Me" is effective immediately. The Capitol lp, "Come Swing With Me," stated Livingston, is selling "as expected; very well."

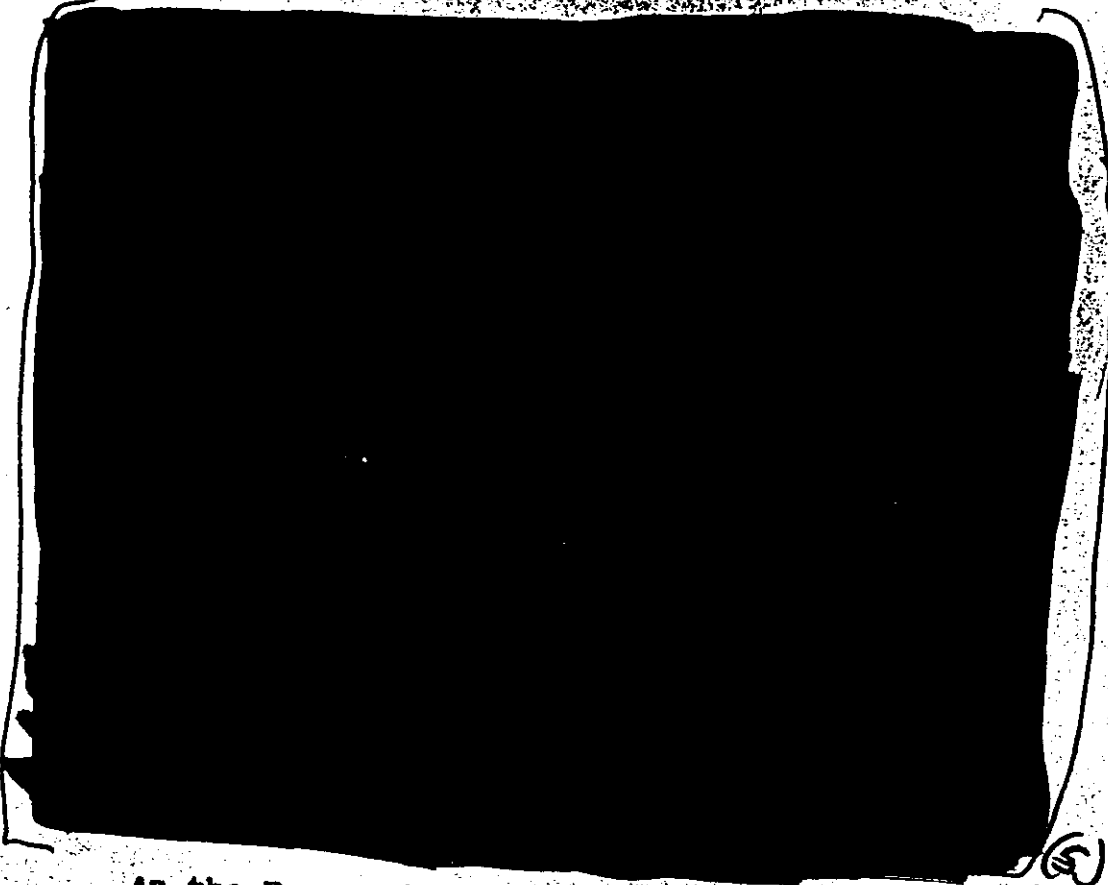

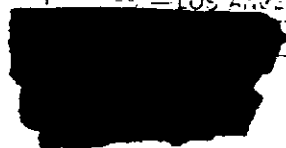

This conversation concerned several topics; however, the main subject appears to be FRANK SINATRA, the well-known singing star and actor. SINATRA has long been alleged to be a close associate of SAM GIANCANA to the point where he supposedly has business interests with GIANCANA and has invested GIANCANA's money in Nevada enterprises. From the tenor of the conversation it would appear that SINATRA and GIANCANA have had a serious rift since the advent of the KENNEDY administration and the main cause for this rift would appear to be because of the fact that SINATRA has been unable to influence the KENNEDYS, particularly ROBERT KENNEDY, Attorney General, to lessen the intensity of the investigation on GIANCANA and his associates. Apparently JOHN has just recently returned from a several-day visit with SINATRA in the latter's home in California. "SKINNY" mentioned by JOHN is probably PAUL "SKINNY" D'AMATO. D'AMATO is the operator of the 500 Club in Atlantic City, New Jersey, and recently applied for a license to purchase an interest in the Cal-Neva Lodge, Lake Tahoe, Nevada, with FRANK SINATRA and DEAN MARTIN. He withdrew this application when it was determined that he had been previously convicted of a violation of the White Slave Traffic Act. He was in contact with GIANCANA in Las Vegas in July, 1961.

"LITTLE JOE" mentioned is unknown. PHYLLIS would be PHYLLIS MC GUIRE, well known singer and sweetheart of GIANCANA. JOE KENNEDY is JOSEPH B. KENNEDY, father of Attorney General ROBERT KENNEDY. JOHN D'AMATO is Alderman of the First Ward of Chicago. JACK ENTRATTER is a man of record of 12 per cent of the Sands Hotel in Las Vegas and as of 1958 was general manager at this hotel. ENTRATTER was the Vice President, Manager, and large stockholder of the Copa Cabana Night Club in New York City. As of 1958 it was reported that ENTRATTER was a front man for FRANK COSTELLO and for MEYER LANSKY. ENTRATTER has been involved in Las Vegas concerning hoodlum matters and was unable to furnish any illuminating information. SAM WATERMAN (phonetic) is a Miami hoodlum and associate of FRANK SINATRA. It would appear from the context of this conversation that FRANK SINATRA was requested by GIANCANA to make a personal contact with ROBERT KENNEDY to intercede on the behalf of GIANCANA. According to JOHN, FRANK went so far as to write GIANCANA's name and took it to KENNEDY and stated "This is my buddy." SINATRA, according to JOHN, is also concerned about GIANCANA's relationship with PHYLLIS MC GUIRE and is fearful that this relationship only serves to allow the Government to more closely watch GIANCANA's activities.

JOHN states concerning SINATRA's relationship with the KENNEDYS, JOSEPH P. KENNEDY, the father of the KENNEDY clan, is of all the KENNEDYS the closest to SINATRA and, therefore, contacts made with ROBERT KENNEDY should perhaps be made through the father. SINATRA apparently feels that the KENNEDY sons would not be faithful to JOE KENNEDY and perhaps would not listen to any request made by SINATRA. JOHN feels differently about this; however, mention is then made by GIANCANA of a donation, the amount undetermined, which was made. GIANCANA then states that he will not contribute one penny toward any future campaign by the KENNEDYS and states that the "(obs) better not think of taking this (obs) state" referring to the State of Illinois.

Reference is then made to the Cal-Neva Lodge which is located in the Lake Tahoe, Nevada, area. This lodge is a modern, plush resort which sits astride the Nevada-California line and among the large stockholders of this lodge is FRANK SINATRA, who owns 36.6 per cent. Apparently GIANCANA, according to this conversation, has money in there which he intends to get out and then "wind up with half of the joint with no money." Apparently JOHN feels that D'AMATO is going to get his gaming license regardless of his past activities, such license being for the purpose of being employed in the Cal-Neva Lodge.

Apparently GIANCANA was in conversation with SINATRA during the time that GIANCANA was in Florida which would have placed this period as some time in January or February of 1961. GIANCANA then makes reference to the fact that recently a bookmaker was called to the FBI Office in Chicago and was shown a picture of GIANCANA. The person referred to by GIANCANA is a Cicero, Illinois, bookmaker who was interviewed at the Chicago FBI Office on an IWA matter. He was exhibited a photograph of GIANCANA and was asked if he was acquainted with GIANCANA and replied that he was, however, only slightly and had no business dealings with him. GIANCANA then relates the interview conducted with him, GIANCANA, at O'Hare Airport by Bureau Agents in July 1961 during which interview he was abusive, arrogant, and generally unhappy about the whole matter.

Apparently GIANCANA is unhappy over the fact that he is not being invited to SINATRA's New Year's Eve party this year which as far as GIANCANA is concerned is one more reason for his apparent intense dislike of SINATRA. When JOHN mentions that FRANK advised him that GIANCANA was not being bothered, GIANCANA makes the interesting observation that he has "more (obs) on my (obs) than any other (obs) in the country" referring to the FBI investigation being conducted on him.

The question of the property owned by GIANCANA in Lake Worth, Florida, which according to this conversation, GIANCANA has apparently given up.

JOHN then tells me of a commission from GIANCANA to work for SINATRA in the G.I. program. Apparently GIANCANA is not in favor of this and gives more or less of a lecture as to how GIANCANA should then makes the interesting statement that he will give JACK ENTRATTER and makes that if GIANCANA will "put that guy in the head" and drop that (obs)".

JOHN then states that he borrowed \$3,000 from FRANK SINATRA during his visit but if he had known of the seriousness of the case between GIANCANA and SINATRA, he would have borrowed \$20,000 indicating that this would probably not be repaid.

The latter part of this conversation is not as clear as the first part; however, it would seem that GIANCANA is attempting to test the loyalty of DEAN MARTIN and FRANK SINATRA and has instructed JOHN to make contact with DEAN MARTIN with instructions to GIANCANA to be available for any ten days which GIANCANA cared for MARTIN's presence. The observations are made that apparently GIANCANA and MARTIN do not believe that GIANCANA will carry out threats of repercussion against SINATRA and MARTIN so that in order to "convince" MARTIN and SINATRA one of the things that DEAN MARTIN is shortly going to have his name put down is that he cannot sing.

It is requested that you carefully peruse the information contained herein and furnish the Bureau and Chicago with any information you are furnishing to this conversation and if it would be of any use to the Government with GIANCANA is JOHN BIRD.

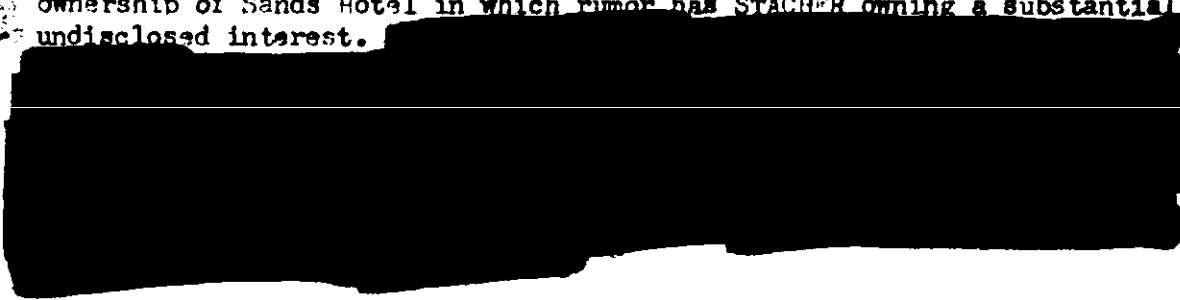

He took the material from our Government records, from the files of the Treasury Department. It is doubtful if you'll be able to obtain a copy of this lat so I shall outline the bare facts. I am mindful of the teen-agers when writing this letter.

"SINATRA: In his late teens met Willie Moretti, the notorious king of the New Jersey rackets (not under your State's jurisdiction) who became his "patron saint". Moretti endeavored to keep him out of trouble, but didn't succeed very well.

"SEX CHARGE ARREST: In Bergen County, N.J. Arrested on sex charge, through influence of Moretti reduced to seduction and finally dismissed through Moretti, though case went to grand jury. Moretti obtained his first job for him, \$35.00 weekly, but he, Moretti, thought it was insufficient so handsomely supplied Sinatra with pocket money.

"ILLEGAL POSSESSION OF WEAPON: Sinatra then went to Los Angeles and he openly carried a gun. The Los Angeles Sheriff took it away from him but Sinatra continued to carry a gun long after the Sheriff told the press he had taken it away.

"FRIENDS: Sinatra's friends are: Willie Moretti (cousin of Joe Adonis Joe Adonis, the Fischetti brothers of Chicago (who are cousins of Al Capone), Al Capone, Meyer Lansky, Frank Costello, and Lucky Luciano.

"CAREER AGAIN: The gansters obtained his job with Tommy Dorsey's band. Sinatra wanted a release from the contract and when Dorsey refused he wa:

"threatened so the release was given. While Sinatra was out of work he was "kept" by the gangsters since he could not be seen going around poorly dressed.

"COMPLICITY WITH CRIMINALS AND IN CRIME: There is an entry on the manifest of the Pan-American Airways of a trip made with the Fischetti brothers from Miami to Havana for the express purpose of turning over two million dollars, covering past and future narcotic transactions. This was after Luciano had been deported to Italy and had managed to sneak back to Cuba. There is a photograph to prove this. The T-men had the entire matter covered from Miami to Havana and the photo shows Sinatra getting off the plane with the Fischettis and carrying the suitcase. The money was later turned over to Luciano by Rocco Fischetti. Other of his friends are dope addicts. In a raid on Luciano's home by the Italian police they collected, among other things, a solid gold cigarette case bearing the inscription: "To my dear plan, Lucky, from his friend, Frank Sinatra". According to newspaper accounts, less than two years ago Sinatra made a trip to Italy where it was reported he openly attended Luciano's parties

"You have here three wanton breaches of the law: Sex charge arrest in New Jersey. Illegal possession of a gun, even after having it taken away from him by the sheriff, a person of authority, after which he continued to carry one. An complicity with criminals and in crime. Today he still boasts on his radio program that: "Most of my friends are in prison".

"Why is this entertainer permitted to have full rein in the profession? The Government, the press, and the radio are hard at work trying to prosecute all these criminals, gangsters, and racketeers. The radio has over the summer months given an outstanding public service in this connection, even having an interview with Moretti on one program (the network that will hire Sinatra again for five years!) and all the leading publications are running lead articles on drug addiction among the young and on Luciano and his crimes. Yet nobody bothers to see that Sinatra comes in for his share in this nefarious matter. Frankly, we feel he is anything but the sort of entertainer to have before the teen-agers as a pattern to follow to become successful. Of course, it's all right to have sex orgies (the papers are full of them today), it's perfectly all right to break the law and carry guns even after you have been apprehended and warned against it, it's perfectly all right to be close friends with the top criminals of the country and to help them and have them put you on the top where you receive a fantastic income. It's a nice example for youth, isn't it? He breaks the law on three counts, goes free; has all the wrong associations and people applaud him; carries a gun, so that's all right; aids criminals and that's all right, too. He comes out on top. Hollywood has erroneously described him as "the symbol of underprivileged

"American Youth". Nothing could be farther from the truth! He's synonymous with criminals, crimes, hoodlumism, gangsters, and his almost daily immorality is enough in itself without all the other heinous activities. What has Sinatra gone free? We read from time to time of one of the entertainers in Hollywood committing an offense for the first time, not as bad as Sinatra's offenses, and an uproar is made and he is arrested, fined and jailed, but Sinatra goes free. There must be something radically wrong. People here in the east are writing to the network protesting his further employment. The same network denouncing crime and criminals will give him a five-year contract next month. They are writing to the various churches and to the press and various other publications who are civic-minded. Perhaps you will see fit to do something about this odious individual who should be removed from the entertainment picture at least. He does not constitute a good citizen and he is not a good example particularly at this time when the emphasis is on the protection of the young in this very field - criminals, crime, hoodlums, gangsters, rackets, drug addiction, narcotics in all its ugly phases.

"Thank you for reading this letter and I hope you will forgive me for taking up your valuable time with this letter. I believe you understand my viewpoint.

Source indicated that, in his opinion, such entertainers would not be permitted to obtain more than one or two points since the management of the Las Vegas establishments does not desire to share any more than possible such lucrative investments.

FRANK SINATRA is an owner of record of 9 per cent of the Sands Hotel. The following information with regard to SINATRA was summarized on September 7, 1960, by the Nevada Gaming Control Board:

FRANCIS ALBERT SINATRA is applying for a 25 per cent interest in the Cal-Neve Lodge at Lake Tahoe at a cost of \$100,000.00. The investment is to be financed by a loan from The City National Bank of Beverly Hills, California, in the amount of \$100,000.00. Said loan will bear interest at 6 per cent per annum and will be secured by a pledge of shares (the exact number to be negotiated) of Hobart Productions, Inc., stock owned by the applicant. Hobart Productions, Inc., is expected to be dissolved in 1960, and upon such dissolution, Mr. SINATRA will receive over \$2,000,000.00 in cash after income taxes. He intends to use a portion of these funds to repay the \$100,000.00 loan received to finance this investment.

Mr. SINATRA does not anticipate active participation in the management and operation of the Cal-Neve Lodge.

The application was filed July 7, 1960.

SINATRA certifies that he is a citizen of the United States, having been born at Hoboken, New Jersey, December 12, 1915, where he resided until 1939; that until 1944 he lived in Jersey City and Hasbrouch Heights, New Jersey, moving to California in the latter year; and that since 1944, he has resided in the Los Angeles area.

Applicant avers that his first "steady" engagement in the entertainment field was in Englewood, New Jersey, 1936-1939; that until 1942, he was under contract as a singer with TOMMY DORSEY and HARRY JAMES; that thereafter he was

employed as a singer-actor by RKO Pictures, simultaneously making records for Columbia; that subsequently he worked for practically every motion picture company, continuing with Columbia records until 1952, when this phase of his activity was transferred to Capitol records; that since 1955, all of his recordings have been handled through Essex Productions, Inc., and since 1957 his motion picture work has been done through Hobart Productions, Inc., companies in which he is the majority stockholder and with whom his contracts permit free lance work in other fields such as night club and television appearances.

SINATRA affirms that he has never been arrested; that he does not have any interest, direct or indirect, in gambling outside the State of Nevada.
