Bergen County Grand Jury file No. 18450 reveals that the adultery charge was presented to the Grand Jury of Bergen County on January 4, 1939, and that body returned a "No Bill."

SINATRA's counsel has submitted the following explanation concerning the omission of the Hackensack arrest from his Personal History Record:

"You have informed me that from your investigation of Mr. SINATRA's background, there has come to your attention an arrest report, being report No. 42799 of the Sheriff's Office of Hackensack, New Jersey, which indicates that on November 26, 1938, Mr. SINATRA was arrested and charged with "seduction." You have asked for information concerning that arrest, and an explanation as to why that arrest was not listed on Mr. SINATRA's Personal History Questionnaire.

"Based on lengthy discussions I had with Mr. SINATRA concerning the questions set forth in the Personal History Questionnaire and my own personal knowledge of his affairs, I personally prepared Mr. SINATRA's Personal History Questionnaire and Invested Capital Questionnaire. By way of background, I would like to state that our firm has represented Mr. SINATRA for more than five years, and during that period I have been the partner primarily concerned with our representation of Mr. SINATRA.

"When I questioned Mr. SINATRA as to whether he had ever been arrested, he told me about the incident in Hackensack, New Jersey, and based on the facts which he furnished to me and whatever investigation I was able to make of such facts, I concluded there had not been an arrest and advised him I was not going to list it on his Personal History Questionnaire.

"Mr. SINATRA's recollection of the facts is that a woman approximately 15 years older than he made a claim that she was pregnant and that Mr. SINATRA caused her pregnancy. He said there was an investigation of the matter by the Court, including a medical examination of the woman, which revealed that she was not pregnant. It is also Mr. SINATRA's recollection that an investigation into the background and character of the woman, and her family, disclosed facts which attacked the credibility of the woman. Mr. SINATRA at that time was of the opinion, and is still of the opinion, the matter was really a complaint of a "crank" and based on investigation made by the authorities the entire matter was immediately dismissed.

"It was upon Mr. SINATRA's recollection that I told him I did not think a paternity proceeding in New Jersey was a criminal proceeding, since I regarded a paternity action as a civil action. Moreover, since it had been dismissed at the outset and he had no recollection of an actual paternity claim having gone any further than the woman's initial complaint, it was my belief that the incident would not be listed as either a civil proceeding or a criminal proceeding.

"Based on Mr. SINATRA's recollection of the facts, I did not even think there was any possibility that a criminal complaint had been filed against him for seduction, since seduction is defined in the California Penal Code as the very crime of having sexual intercourse with an unmarried woman of previous chaste character under promise of marriage."

Evidence shows that applicant's professional life is a matter of common knowledge with the American public; that within the entertainment industry, applicant is highly regarded as a fair and just man whose ideas, theories and abilities, are greatly respected; and, that his standing as a performer is a credit to the entertainment field.

Persons who have known applicant for fifteen years tender him an unqualified endorsement as to character, honesty and integrity. They admit that he is censored at

times, by the press and even his friends and associates, for being too quick-tempered and forceful--this largely because he is a pronounced non-conformist and a free-thinker who goes out of his way to champion the cause of the underdog.

Individuals interviewed expressed the opinion that the applicant had a bad press primarily because of his tendency to come to the rescue of the oppressed. They cited a recent controversial incident involving applicant's engagement of a writer, ALFRED MALTZ, one of the "Hollywood Ten," to do a screen story.

The "Hollywood Ten" were a group of motion picture scenario writers who, when subpoenaed before the House Un-American Activities Committee investigating Communist infiltration in the last decade, declined to cooperate and took refuge behind the Fifth Amendment. The American public then became so incensed that the motion picture industry in order to protect its interests took action which was tantamount to a blacklist.

After all arrangements (financing, productions, etc.) had been completed, newspapers took up a cudgel of criticism which resulted in cancellation of the production contract; that SINATRA entered into an agreement with this writer in the belief that he was the best qualified person available to do the story; that others in the group identified as the "Hollywood 10" had recently completed screen plays without a wave of protest engulfing the individuals who had retained them; that SINATRA then terminated his agreement with MALTZ; and, that at the moment he is being sued by MALTZ not only for a claim based on personal services but for defamation of character as a result of news releases recounting the charges brought by the House Un-American Activities Committee some years ago.

Upon interview, SINATRA denied being aligned with Communists, hoodlums or the so-called underworld element; stating that in the course of his career he has been introduced to any number of people, good and bad, and that he is not in

a position to run away from or refuse a gesture of meeting; and, that this does not mean that he is "a friend of" or an endorser of the thinking or motives that actuate those whom he perchance may be introduced to.

FRANK SINATRA was interviewed by Bureau Agents, Los Angeles, California, on April 25, 1961, regarding his knowledge of the activities of SAMUEL GIANCANA. SINATRA advised that he met GIANCANA a few years ago socially but has had no business dealings with him and knows nothing about GIANCANA's affairs. He was questioned relating to his knowledge of JOE PIGNATELLO, described in the Associates Section of this report as an individual close to GIANCANA, and advised that PIGNATELLO was known to him, SINATRA, as "JOE the Cook", and that he originally knew PIGNATELLO through GIANCANA. SINATRA denied any intervention on his part on behalf of PIGNATELLO in an effort to further PIGNATELLO's business interests in Las Vegas and said he had done PIGNATELLO no favors in this regard.

FRANK SINATRA, the well known singer and entertainer has been described previously as an individual who enjoys a close association with certain notorious individuals, among them being JOSEPH FISCHETTI of Miami, Florida, and SAE GIANCANA. This previous informant indicates that SINATRA was more than a social acquaintance with these persons and in fact informant intimated that SINATRA through his Nevada gambling interests was in some degree in partnership with GIANCANA in certain operations. Further elaboration upon this particular association will be described elsewhere in this report under the Legitimate Enterprises Section.

The informant related that DREW told him that in the discussion with GIANCANA, he had attempted in some degree to convince GIANCANA that FRANK SINATRA had made some attempts to dissuade the Justice Department through Attorney General ROBERT F. KENNEDY, from conducting the intensified investigation being conducted on GIANCANA and his activities. DREW said that GIANCANA was not at all satisfied with the effects made by GIANCANA and in fact questioned him whether SINATRA had made any attempts at all to intervene in his behalf. DREW stated that GIANCANA is highly indignant over the fact that SINATRA has apparently "forgotten" passed favors done for him by GIANCANA and intimated to DREW that he intended to get the message across to SINATRA and SINATRA's partner DEAN MARTIN, that he, GIANCANA, means business. DREW stated that he was instructed by GIANCANA to make contact in the near future with DEAN MARTIN and passed on GIANCANA's orders to the effect that MARTIN is to be available to perform at a spot not yet designated by GIANCANA for a ten day period. DREW advised the informant that he, DREW, had borrowed \$3,000.00 from SINATRA recently but if he had known the seriousness and the rift between SINATRA and GIANCANA, he would have borrowed \$20,000.00 indicating the possibility that this loan would not be repaid.

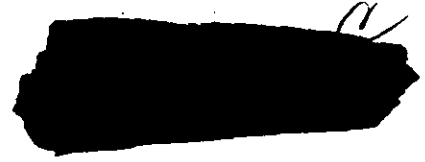

Sinatra 1st U. S. Civilian To Get Key To Toyko

Tokyo, April 28 (Via Air Mail). —Frank Sinatra turned over a check worth about \$28,000 to Tokyo Governor Ryotaro Azuma for 60 orphanages housing Eurasian children and thereby became the first non-military figure to receive a key to the city. Check was proceeds of Sinatra's three benefit shows on first stop of global swing.

Shows were Sinatra's first in Japan, after bookers tried for years to get him, but couldn't meet the price. This time he came for free, and as one Las Vegas veteran ringsider said after watching Sinatra complete a songalog lasting over an hour, "He doesn't work this hard for \$100,000 a week."

Sinatra did two performances to above-capacity audiences at the 1,200-seater Mikado Theatre Restaurant, where the usual \$7 dinner-show deal was upped to \$14, and another before a bursting outdoor theatre crowd of 7,000 who paid 56 cents or 83 cents each. Latter show was specifically geared so youngsters could afford to attend.

Tokyo embraced Sinatra during week-long visit and he responded with charm, patience and sincerity. He radiated warmth and goodwill — and just for the record Sinatra told a press confab he planned to remain controversial. "That's the only way to make progress," he said.

Nazareth, May 2. — Frank Sinatra will become second living American to have a building in this ancient Biblical city named after him, with Friday (4) groundbreaking ceremonies for the Frank Sinatra International Friendship Youth House. The entertainer, in Israel for two-week tour and benefit performances, will attend.

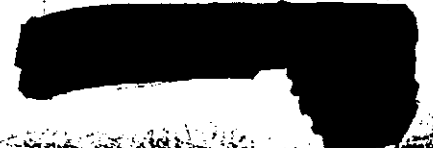

Columbia and RCA distributed singer's earlier recordings.

Capitol, according to suit, has been advertising older Sinatra recordings for sale on the basis of 50% and lower reductions. Preliminary injunction would halt such sales.

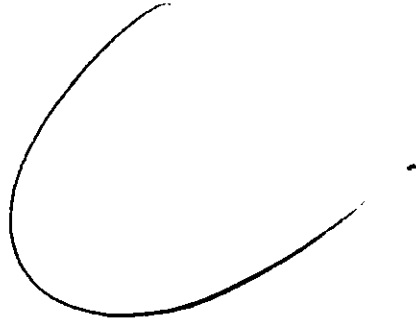

A suspense melodrama with political background, exploring and exploiting some dramatic projections of communist brain-washing. "The Manchurian Candidate" is tautly made, with strong boxoffice potential. The premise is somewhat far-fetched, and its development strains belief in the final sequences, but accepting it on its own terms it sustains interest. George Axelrod and John Frankenheimer produced, with Frankenheimer directing Axelrod's screenplay. The M.C. production is being released by United Artists.

Based on a book by Richard Condon, "The Manchurian Candidate" is taken from reports of brain-washing by Chinese communists of U.S. troops captured in the Korean war. Frank Sinatra and Laurence Harvey are two such servicemen, members of a squad forced to undergo the involuntary psychological indoctrination. When Harvey is returned to the U.S. with other squad members, he has become, under certain conditions, an automaton responding slavishly to orders from Soviet agents. His final rebellion provides the climax to the story.

So far, so good. The story gets into murky areas in its development. The Soviet spy apparatus, no doubt, as any espionage machinery, would be amazing to most simple citizens, so a broad scope of speculation is legitimate. Axelrod's screenplay, however, uses more than is really necessary. In the final stretch, when Harvey's mother—wife of a U.S. Senator—is disclosed as a top Soviet agent, when killing is piled on killing—four murders and one suicide—it will be for many stretching credibility to the breaking point. It is too bad, too, because not all this detail is essential to the story. But in the tradition of E. Phillips Oppenheim and Somerset Maugham (the Ashenden stories), it is perhaps defensible.

The direction and acting are good, so interest is maintained. Frankenheimer's handling of the early sequences, in which he attempts and succeeds in creating on film the cor-

ruption of the mind, is imaginative film-making. In the more realistic portions, there is terse character exposition and propulsion.

Sinatra gives a reasoned and in many ways more mature performance than he has ever done before. Harvey is competent but never seems completely convincing as an American GI. Janet Leigh gives evidence of considerable enlargement of her screen personality, with more depth and legitimate sex than she has hitherto shown. Angela Lansbury gives another strong performance as Harvey's mother. Henry Silva has a good character portrayal. James Gregory and John McGiver are consistently interesting, both playing against their usual typing. Others of special interest include Knigh Dhiagh, James Edwards, Douglas Henderson, Albert Paulsen, Madame Spivy, Barry Kelly, Joe Adams, Lloyd Corrigan, Whit Bissell, Robert Riordan.

Lionel Lindon's black-and-white photography uses lighting adroitly, mixing styles without diffusing cohesion. Richard Sylbert's production design gives backing and some insight to the narrative. George R. Nelson's set decoration is meticulous. David Amram's music is creative in supplementary vein to the visual. Joe Edmondson's sound is good. Ferris Webster's editing helps the story's many moods and its unusual tempo. —James Brown

The unlikely situation of an American Legion Post and a Communist publication finding a common film target — but throwing their darts with different aims — has occurred re Frank Sinatra's "The Manchurian Candidate." Film has found a champion, however, against the Commie onslaught at least in Hearst's L.A. Herald-Examiner.

Pic is currently being condemned by the People's World, a Communist newspaper, as "the most vicious attempt yet made by the industry to cash in on Soviet-American tensions. The film is poison ★ ★ ★"

'Too Close For Comfort'

To this the H-E's Jack Lotto on Saturday, observing that the film's exposition of Red brainwashing of American soldiers in Korea to do subversive work back in the U.S. was too close for comfort in Red eyes," he declared. "It does serve to awaken Americans to Communist treachery."

Last month the 23d District American Legion sent a resolution to state and national Legion headquarters attacking the pic as "a vivid example of an attempt to undermine Congressional committees ★ ★ ★"

Stephen S. Byko, Commander, and Dr. John R. Lechner, Americanism committee chairman, of 23d District, yesterday were asked by DAILY VARIETY if they had seen the People's World attack. Byko had not, but he said the matter would be discussed tonight at a meeting at Teddy's Roughriders Post No. 516, 9047 South Vermont.

'Typical Commie Trick'

Dr. Lechner said he had seen the item but it did not change the original criticism of the People's World article. He commented, "That can possibly be a ruse. I am not accusing them of it. But it's a typical Communist propaganda trick. There was no point, absolutely no reason for inserting four or five scenes ridiculing a U.S. Senator. And the brainwashing! That was so damned far-fetched that it, in itself, was ridiculous."

Debate Invitation

Dr. Lechner issued a public invitation to Sinatra and/or the producer of the film (Howard W. Koch is the executive producer) to attend tonight's meet. "I'll debate them on the floor," Dr. Lechner said. "We have no axes to grind, but they really want beyond reason. The motion picture industry is too big, too important to do things like this."

Increased Production Seen In Independent Setups Like Sinatra-Koch's Essex Unit

A significant Hollywood development which can fill the gap created by reduced major studio activity, in the opinion of informed industry observers, is the growing trend among top stars to team up with experienced production executives in establishing indie units designed for filming of properties both with and without the star who heads the company. Bankers and Wallstreeters interested in movie business are taking special note of this development, with chief interest being shown in the operations of Essex Productions, the Frank Sinatra company with Howard W. Koch as v-p and executive producer.

made in association with George Axelrod and John Frankenheimer, just recently released and doing very well, and "Come Blow Your Horn," produced in conjunction with Bud Yorkin and Norman Lear, with sneak previews over the weekend in Oakland and Palo Alto being accorded a sensational reception. "Horn" is a Paramount release; the other three are United Artists.

Particular interest in these Essex projects is centered on the fact that the four pictures combined—all made here and brought in on schedule—cost only a combined total of about \$10,000,000; a little over \$800,000 for "X-15" and about \$3,000,000 apiece average for the other three, thus providing ample profit assurance.

Also regarded as holding great promise are Essex's next two ventures, both musicals, with no distribution deals set yet: "The New Yorkers," in which Sinatra will appear with Gene Kelly, Dean Martin, Sammy Davis Jr. and Joey Bishop, and "Robin and the 7 Hoods," with Sinatra, Martin, Davis and Bishop.

Sinatra's activities are becoming increasingly diversified within the entertainment field. His Reprise Records already is a formidable disc firm, and he has interests in radio stations, plus his occasional nitery and TV stints. Essex also extends production consultation services to other creative groups, especially writers, directors and producers who are new to motion pictures. This includes services of other Essex personnel as well as Koch, who has had extensive experience in all phases of film-making, including pre-production planning, budgeting, casting and as a producer and director, both major studio and independent. Essex already has provided various services to "Road to Hong Kong" and "The Caretakers," UA releases, and the "Ben Casey" TV series pilot for Bing Crosby Productions, and possibly will assist on "Lady in the Cage," upcoming Luther Davis production for Continental. In some cases, these outside projects may even interest Essex as a participant.

As comparable operations in the Essex line—combination of showman-star and knowledgeable producer to handle executive and administrative details—there is the highly successful Jerry Lewis Productions, with Ernest D. Glucksman as producer, with a solid string of boxoffice hits. Doris Day and Martin Melcher also are among the most active and successful combinations of this type, while Tony Curtis has teamed up with Stan Margulies and Kirk Douglas has Edward Lewis.

Burt Lancaster has done very well with Harold Hecht, and Marlon Brando's company, with Brando Sr. at the head, also makes pictures with or without the star. A number of other top boxoffice names likewise are exploring the idea, with the main hurdle in most cases being to find the right qualified producer with whom the star can work harmoniously. Talent agency executives state the producer shortage is as acute as any shortage in the production field and that quite a few more of their star clients, some of whom already have their own companies, would team up with the right production executive if one could be found.

There is quite general agreement, however, especially among the agencies, that this is one of the healthiest trends the industry has witnessed in years. They view it not only as a stimulant to production but also as a better chance for stars to get good properties—an important factor in the growing realization that few stars or combinations of stars today can carry a picture if the story is weak.

Essex, in its two-year existence, has made four pictures—"X-15," a timely topic subject with only fair boxoffice results; "Sergeants 3," a comedy that proved a worldwide boxoffice blockbuster; "The Manchurian Candidate";

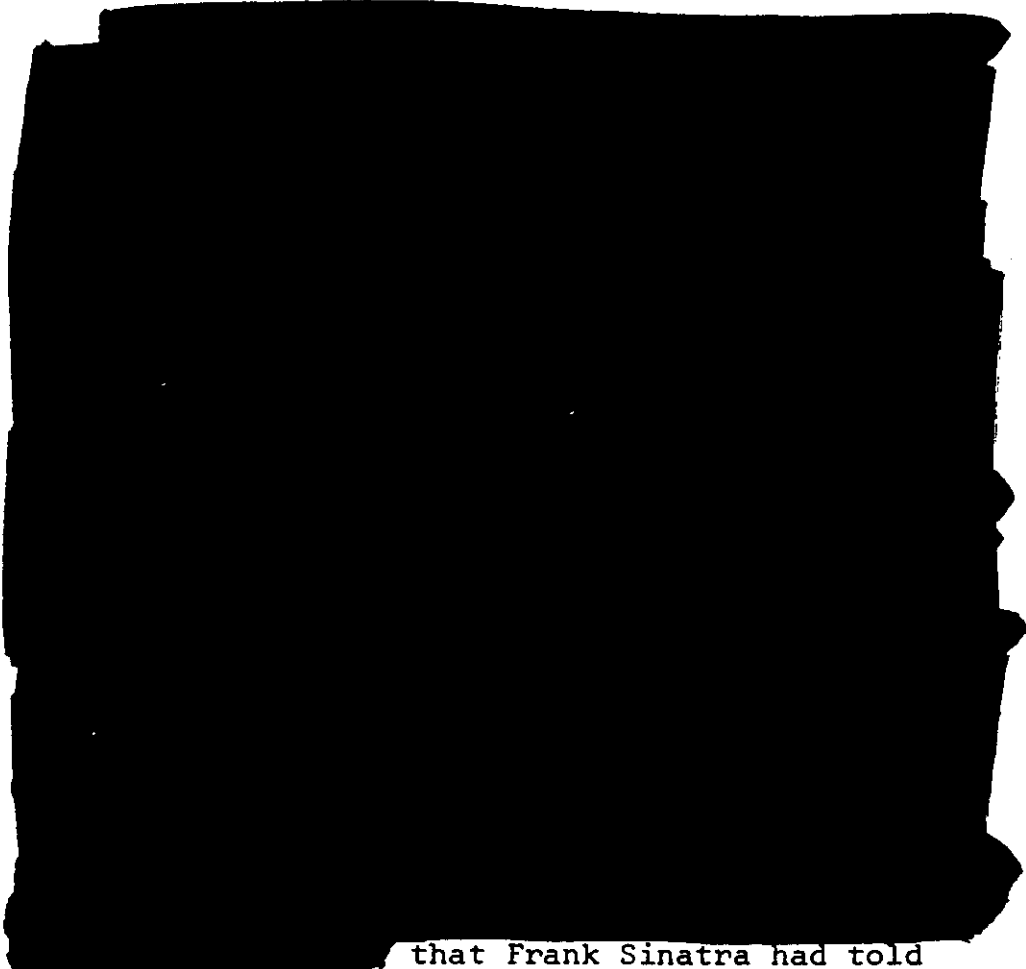


