Dear Frank Sinatra

I have written the FBI that since Richard Rodgers died I will position Frank Sinatra with my throat to him in self-defense. My statement in July of 1980 will be that I want to kill Frank Sinatra, singer, in self-defense because he is co-conspiracy to steal FBI tapes of my music pastureships, and wealth, with other who stole.

I have a proposal for Frank Sinatra to avoid the sensationalism of murder in self-defense.

1. Frank Sinatra must name the FBI agents who were involved with the pastureships and state and particularly the FBI agent who organized the theft and stole most of the wealth. Included, I want a statement about the theft. Therefore I will position the ego-maniac thief who organized the theft as law courts and attorney will allow and Frank Sinatra will not be the one I state I must kill in self-defense.
2. I want \$200,000 from Frank Sinatra for my pages

attorney's fees to eliminate murder in self defense and sensationalism. All that 200,000th be deductible from your financial settlement with me when it comes because of the partners and money stolen.

3. Or, I want \$400,000 for attorney's fees and other expenses. Also \$400,000 will be deducted from a financial settlement with you. And because of the increased amount of money, I will give you a better financial settlement on the stolen partnerships and wealth.

4. If more than one partner wants me to go to court other than murder in self-defense, I want from you and others a total of \$500,000 expenses which is deductible from financial settlements in the theft of partnerships and wealth.

57C) You should not contact me by mail because my mail is not secure. Your attorney should call me on the phone - [REDACTED], or come to my home to arrange a meeting in New York City to work out matters. I include here.

If Frank Sinatra agrees to nothing, I will put up my life at the FBI in July of 1980 regarding him.

Frank Sinatra and other partners should know that I was never a communist. It was and is a set-up and cover up of the FBI agent who organized the theft and stole most of the wealth. Also, I was never guilty in the security of the theft. It was also the set-up and cover-up of the FBI agent who stole most of the wealth. (b7C)

In addition, [REDACTED], never received any money at all from anyone, or the partners, or the partnership, and I never signed anything ever regarding the partnership or money, and I never met anyone involved with the partnership.

Furthermore, I want a financial settlement with Frank Sinatra (and others) before I put up my life in self-defense. A better financial settlement will be given by me that way.

I note that I have a good grasp of what happened regarding the theft.

I believe that the ego-maniac thief who organized the theft and stole most of the wealth will not go through with a court case, and will try to settle since I have an attorney and a grasp of law.

I don't need \$500,000 for a court case, but I have

If my terms are accepted, my trust

the ego-maniac thief without the sensation
of murder in self-defense and will be
directed to a fraudulent partnership.

Dear William Webster,

I am [redacted] Brooklyn, N.Y. My social security number is [redacted]

Since Richard Rodgers, composer, died in Dec. 1979, I am changing my position in self-defense.

This letter is not a confession to Bill Frank Sinatra, singer, in self-defense.

I state that I have a confession to Bill Frank Sinatra, singer, in self-defense and a 50 page statement about the theft of FBI taps and records which include my music partnerships and wealth, since Frank Sinatra is a co-conspirator to steal my music, partnerships, and wealth, which was stolen with others, also.

This confession and 50 page statement is in safe deposit box in The American Savings Bank at Kings Highway, Brooklyn, N.Y.

This confession and statement will be given to the FBI in Washington, D.C. in July of 1980, if their case is not closed. I am a whole lawyer.

39 MAY 27 1980

The ego-maniac thief who was an FBI agent organized the theft yet threatens me via police and mental institution to prevent me from taking action to recover the wealth stolen and placing him in prison. If a policeman with a set-up puts me in a hospital, I will tell every doctor that I was to confess to a crime, which is my confession stated here, but will tell only a legal FBI agent.

If the FBI has failed to obtain the reasons for the partnerships being offered by me on tape, I give explanation. Since, in 1954, I thought communists were following the FBI & me and since was concerned for the FBI investigation, which I do not understand I thought that my music should be checked. If my composed music was good then the FBI would have a clearer idea if communists were around. Consequently I wrote music and offered a partnership because of my ambition.

Also, I was never a communist and I joined the communist party ever. The thief stole most of the wealth from the partners for his cover-ups has set me up as a member of the communist party, and also because he has followed thru with this set-up of me as a gu

man in the security of the M.S.D., with which I failed but still accuse.

The reason I delayed in my position, which I wrote would be July 1979, is that the FBI knew I was in self-defense and since I told of it then everyone who could has a better intelligence and position to understand the theft.

I am enclosing with this letter another letter to Frank Sinatra, which is my proposal and position. I want the FBI to give my letter to Frank Sinatra. I do not know his address and can not contact Frank Sinatra by mail.
